### **DISAPPROVAL BY THE GOVERNOR**

The Honorable President, presents a disapproval by the Governor on the following measure:

House Bill No. 6052 SUB A as amended BY Slater, Watson, Diaz, Faria, Costantino ENTITLED, AN ACT RELATING TO FOOD AND DRUGS -- THE EDWARD O. HAWKINS MEDICAL MARIJUANA ACT (protect patients with debilitating medical conditions/medical use of marijuana)

Upon suggestion of Senator Perry, and without objection, the reading of the veto message is dispensed with as copies have been provided to each Senator.

Without objection, so ordered.

Senator Perry, moves passage notwithstanding the disapproval of the Governor, seconded by Senators Paiva Weed, Goodwin, Levesque, Roberts, Polisena, Damiani, McCaffrey, Tassoni, Sheehan, Sosnowski, Pichardo, Ciccone and Badeau.

The bill marked Substitute "A" is read and passed, in concurrence, notwithstanding the disapproval of the Governor, as amended, and the original bill indefinitely postponed, upon roll call vote with 30 Senators voting in the affirmative and 5 Senators voting in the negative as follows:
