NY Subway Riders "Wipe Out" Nazis

Subway riders on NY's No. 1 train sprang into action recently, and it went viral on Facebook, after passengers had enough with the swastikas and anti-Semitic messages scrawled inside two subway cars. They banded together and eliminated the hate words and symbols.

Richard Hatch from Battlestar Galactica Dies

He starred on this space show with Lorne Green, who was mostly known as Ben Cartwright on *Bonanza*. Hatch also took the place of Michael Douglas on the *Streets of San Francisco*, co-starring with Karl "Don't Leave Home Without It" Malden.

Berkeley Still at it

The so-called black bloc agitators, who disrupted a conservative speech at UC Berkeley's Sproul Plaza, arrived like a paramilitary force armed with bats, steel rods, fireworks, and Molotov cocktails.

The speaker was still two hours away from his podium, but it was just the right time for the agitators because the 6:00 pm news was about to start. About 100 to 150 protesters started smashing windows, launching fireworks at the cops, and started a fire. As university spokesman Dan Mogulof said, "They didn't come to lock arms and sing Kumbaya," and we "have never seen this on the Berkeley campus. This was an unprecedented invasion."

I'm thinking back in the '60s and early '70s during the anti-Vietnam War marches and demonstrations, Berkeley was even then a hotbed of radicalism. The Free Speech Movement, much like today's version, was anything but free speech. They, like today's radicals, attacked fascism while acting like the very thing they march against.

Free speech, especially on a college campus, should mean that everyone has a right to express their opinion, but that is the last thing radicals want. Their idea of free speech yesterday and today is to shutdown free speech they disagree with. The more things change, the more they stay the same.



The Wisdom from Washington

Wednesday is the 285th anniversary of the birth of George Washington. Since 1971, Washington's Birthday has been observed, as a public holiday on the third Monday in February. The day is commonly called "Presidents' Day," but the legal name remains, "Washington's Birthday."

"First in war, first in peace, and first in the hearts of his countrymen, he was second to none in the humble and enduring scenes of private life; pious, just, humane, temperate, and sincere; uniform, dignified, and commanding, his example was as edifying to all around him as were the effects of that example lasting. To his equals he was condescending, to his inferiors kind, and to the dear object of his affections exemplarily tender; correct throughout, vice shuddered in his presence, and virtue always felt his fostering hand; the purity of his private character gave effulgence to his public virtues. His last scene comported with the whole tenor of his life although in extreme pain, not a sigh, not a groan escaped him; and with undisturbed serenity, he closed his well-spent life. Such was the



man America has lost such was the man for whom our nation mourns."

We could do no better, in reflecting on the life and influence of President Washington, than to consult his 1796 **Farewell Address** to the nation written as he prepared to retire from public life. It was almost immediately reprinted in newspapers across the country and later in pamphlet form.

In the address, Washington argues that the Union of the States "ought to be considered

as a main prop of your liberty," and that "there will always be reason to distrust the patriotism of those who in any quarter may endeavor to weaken its bands." He warns against sectionalism: North versus South, or Atlantic versus West. He praises the Constitution, which he declares, "improved upon [the Articles of Confederation]" and "better calculated than [the Articles| for an intimate union." The Constitution, he says, "till changed by an explicit and authentic act of the whole people, is sacredly obligatory upon all." As every schoolboy knows, he then goes on to warn against factions and "the baneful effects of the spirit of party generally."

Washington stresses the need for religion and morality if the republic is to be preserved. And he exhorts to maintain good public credit and to be careful with regard to public debt "not ungenerously throwing upon posterity the burden which we ourselves ought to bear." Finally, Washington warns against foreign alliances.

The full text of the Address is available at libraries and online. The original hand-written address is 32 pages in length, far from a 140-character "tweet."

Stirpe Nostra

AUGUSTUS THE COLONIZER

Augustus added to the population of the empire by personally establishing about twenty-five colonies throughout the more remote sections of Italy. He furnished these colonies with public buildings and opportunities for revenues. He even gave the inhabitants a degree of equal rights and dignity with the citizens of Rome. Colonists were permitted to cast votes for officials on a par with Roman citizens, and to influence decisions made by their representatives in the Senate. Their votes were sent back to Rome under seal. He even permitted colonies to recommend youths to be admitted to the equestrian military career.

Most provinces were assigned to pro-consular governors, but unruly or difficult ones he governed himself, and those provinces which were notorious for their lawlessness were deprived of their independence. Those that were overwhelmed by debt were provided with financial relief, and some which were severely damaged by earthquakes were rebuilt. Latin rights or full Roman citizenship was extended to the inhabitants of any province that was able to show that they had provided some kind of service to the Roman people.

Augustus restored the kingdoms of most nations which were conquered by the Roman



legions or in a few instances joined them with other conquered areas. He united the kings, encouraged inter-marriages and friendship among the conquered nations, always treated them with consideration as a part of the empire, and even brought up some of their children and educated them as his own

He assigned his army legions and reserves to the various provinces, stationed his fleets in strategic locations to defend the upper and lower seas around Italy and some were used to defend the city itself. He never permitted more than three cohorts to remain in the city and even these were not provided with a permanent camp (a cohort was a section of 300 to 600 soldiers). All of the other available soldiers he placed on winter and summer duty to protect the towns near Rome.

He set a fixed pay scale for all ranks of soldiers everywhere, setting forth allowances, designating the duration of their service, and a retirement pay according to rank. This was done to avoid the temptation to engage in any kind of revolution after their discharge.

In order to keep in touch with his provinces and to know what was going on at all times he established his own version of our pony express,

but without the ponies. Young men were stationed at short intervals along the military roads and carried messages in relay style. Later he revised the system slightly to provide for a single messenger to be carried in a litter or chair from one station to the next. He preferred this second system because he not only received his written message but was also able to question the messenger as well.

Finally, as proof positive that his ingenuity was equal to that of our great government leaders, he provided for the payment of all of the aforementioned services by levying new taxes.

Saint John Kemble

John Kemble was born at St. Weonards, Herefordshire in 1599, the son of John and Anne Kemble. They were a prominent local Catholic family who continued to practice their Faith in opposition to the newly established Church of England. His family included four other priests. John Kemble was ordained at Douai College, which was an English College in France, on February 23, 1625. He returned to England on June 4, 1625, as a missionary in Monmouthshire and Herefordshire.

Upon Father Kemble's returned to Monmouthshire, he served more than 50 years as an itinerant priest, winning admirers even among Protestants. Around Hereford and Monmouth, the Catholic Earl of Worcester held sway at Raglan Castle, and Catholicism was for long periods practiced despite the difficult environment.

The condition of Catholics had eased but priests still needed to perform their ministry discreetly. Father Kemble established his ministry from his base of operation at Pembridge Castle, the home of his nephew, Captain Richard Kemble; he had seemed immune from prosecution.

Father Kemble got caught up in a frenzy of anti-Catholicism brought on by a false conspiracy plot known in history as the Titus Oates Plot. When Oates' story was examined in detail the fraud was exposed, but it gave disgruntled Protestants an opportunity. Anti-Catholic politicians made cynical use of this "plot" to implicate English Catholics, particularly priests. Father Kemble was arrested on December 7, 1678.

In April 1679, Father Kemble, now 80, was ordered to be taken to London to be interviewed about the plot. He was found to have had no connection with the alleged plot but found guilty of the treasonous crime of



being a Catholic priest. He was sentenced to be hanged, drawn and quartered. He was returned to Hereford for the sentence to be carried out. Before he was led out to his execution on August 22, 1679, Father Kemble insisted on saying his prayers and finishing his drink, and the assembled party joined the elderly priest in a final smoke and a cup of wine.

Before his death, Father Kemble addressed the assembled crowd, pointing out that no association with the "plot" had been charged to him. The old priest went on to say: "The failure of the authorities in London to connect me to the plot makes it evident that I die only for professing the Catholic religion, which was the religion that first made this Kingdom Christian."

Consoling his distraught hangman, the priest is said to have whispered, "Honest Anthony, my friend Anthony, be not afraid; do thy office. I forgive thee with all my heart. Thou wilt do me a greater kindness than discourtesy." Kemble was allowed to die on the gallows before being drawn and quartered, thus he was spared the agony suffered by many of other Catholic martyrs of Britain.

John Kemble was beatified in 1929 by Pope Pius XI and canonized on October 25, 1970, by Pope Paul VI as one of the Forty Martyrs of England and Wales. His Feast day is celebrated on August 22nd.

This past Saturday (February 11th), I talked with his widow Dina at the corner of Salutation and Hanover Street. She was just standing leaning up against the building. What was she thinking I thought as I approached her? Her life with him? Her life without him? All the joy he brought her in his Joe Cool way. I told her I was so sorry to hear the news and hugged her because this was indeed a time to comfort. You live your life day in and day out, and never know when God comes knocking on your door.

Joe Cool will be missed. He had a way about him that will never be forgotten. I see him and I see him laughing or complaining about politics, but he loved being around people and people loved being around him, too.

He may be gone, but he will never be forgotten! Goodbye old friend.

His funeral was from the Boston Harborside Home, North End, Boston on Monday, February 13th, followed by a Funeral Mass in Sacred Heart Church, North Square.


to Receive Pirandello Lyceum's President's Award for Her Contributions to the Italian Community



L'Anno Bello: A Year in Italian Folklore

And the Oscar Goes To...

It is that wonderful time of the year again. The time of watching movie stars glide down the red carpet, as graceful as paper swans, wrapped in jewel-hued gowns. It is the time when television channels replay Oscarwinning movies of the past, with iconic images of sultry femme fatales and tight-jawed heroes and conniving villains flashing across the screen. During the past few weeks, people have devoted many moments to recognizing the artistic achievement a medium which often goes unappreciated, being synonymous with lightweight popcorn fare. Now, however, people are in full recognition of the powerful force that movies play in our lives. Which film of the past year, they ask, best crafted a story that transported us to another time or place? Which director imbued his or her project with the most love and passion? Which actress or actor best delved into the complexities of their role? Yes, it is the time of the year when the Academy Awards are announced. As a long-time lover of film, I will spend the evening of Sunday, February 26th, glued to my television, shivering with anticipation as the little gold statuettes are distributed. While I am watching, I will also pay tribute to the significance of movies to my life and heritage.

Movies have always comprised an integral part of my soul. Indeed, film has contributed to the collective subconscious of people around the world. Much of our notions of good and evil, achievement, love and longing derive from the celluloid world. When I think of selfless romance, for example, I think of cynical café owner Rick Blaine from Casablanca letting his true love Ilsa depart on a plane on a foggy Moroccan night, all for the higher cause of stopping Nazism. Han Solo from Star Wars, on the other hand, forever stays in my mind as the epitome of the rascal with a heart of gold, the guy everybody



knows who tries to be tough but cannot conceal his soft side for long. When he reappeared at the end of the film to save Luke Skywalker from the clutches of the evil Empire, I felt a cheer swelling up inside me. That is why I appreciate film so much, because they are little stories that encompass the spectrum of emotions that give meaning to our existence as humans. I try to catch as many of the Best Picture nominees as I can, though busy work and school schedules make it hard. I used to attempt to catch the nominees prior to the Oscar ceremony, but find it more stress-free to view them afterwards when I have time, perhaps on a cozy movie night, snuggling with my husband and a big bowl of buttered popcorn. Over the past year, for example, I caught up on Best Picture nominees Spotlight, The Revenant, and Brooklyn in my leisure, and found all three films well-made and thought-provoking. I cannot wait to do the same with this year's nominees. From dramatic biographies to quirky indie flicks, the year's Oscarnominated films encapsulated a rich tapestry of the human story, and I want to soon add them to my repertoire.

The Oscar season also reminds me of the tremendous achievement that Italians and Italian-Americans have made in the field of cinema. State-

side, directors like Francis Ford Coppola and Martin Scorsese have become icons of American filmmaking. My father is always quick to remind me that Italian-born moviemakers have supplied the world with many indelible masterpieces. World cinema stands all the richer because of directors like Federico Fellini, who brought whimsy and absurd satire back to silver screen or Vittorio De Sica, who gave a voice to Italy's working-class citizens or Sergio Leone, whose revisionist Westerns reshaped the myth of the American frontier. Italian film even forms the backbone of an interesting story repeated among my family. When my grandmother was a young and sophisticated student in Rome, she was courted by the studio bigwigs of Cinecittá, the Italian version of Hollywood, to become an actress. Though one of her old-fashioned relatives put an end to this, the story speaks to the splendor of Italian cinema and its ability to inspire dreams in young people just like the fictionalized Hollywood of legend. In honor of Italian contributions to movies, I often serve star-worthy Italian dishes for my Oscar-watching events. Last year, I made a mascarpone cheesecake drizzled with chocolate sauce. It was such a decadent and creamy hit that I plan to make it again, an appropriately stylish plate for the most glamorous season of the year.

Films are a roadmap of our hopes, dreams and values. I encourage everyone to watch at least a few of the Best Picture nominees before the Oscar ceremony on Sunday the 26th of February in order to find one that resonates on an emotional level. Good movies enrich our lives, as they provide us with visions of another world or new perspectives or characters so strongly written that they remain inside our mind long after the projector has stopped running. This month, I will revel in the Oscars in order to pay tribute to the films that have enhanced my life journey, and I will also pause to honor the Italian movies that have become milestones in my culture and heritage. After all, the ability to view films as more than just entertainment but as significant social art and artifacts is an achievement worthy of an Academy Award

Some Tips for Keeping Your Pet Safe in the Snow

There's nothing quite like watching a dog experience snow for the first time. What the heck is all this white stuff? Must dig in and try to gobble it up! However, before letting your pet go wild in the snow, make sure you're taking these safety precautions.

- 1. Get your dog used to the snow gradually: The key is acclimation. If they seem fine and aren't shivering or trying to get in, it's perfectly fine for them to stay outside for longer periods as long as they're building up to it. Start them out with small stints outside so their coats and paws will have time to adjust.
- 2. Remember that coldness depends on the dog: Puppies will have a harder time regulating their body temperatures outside, and senior dogs can have issues like diabetes, or an altered metabolism that can make it harder for them to adjust. Smaller dogs with thinner coats will shiver more than dogs bred to be outside in the cold.
- 3. **Prep your dog:** If you notice your dog tends to be cold, stock up on sweaters, coats, or dog booties. Some dogs will even get cold indoors! Avoid shaving your pet in the winter. Wipe off your dog's paws when he comes inside after being outside, especially if he has long hair that will keep the pads of his paws wet.
- 4. **Use your intuition:** If it's literally colder than Mars outside (which actually happened in the Midwest last year), limit your dog's time outside. If a cold wind is penetrating your ski jacket, it's probably too cold for a dog to play outside for an extended period of time, too. In addition, watch the dog for signs of discomfort. Holding up a paw because it's frozen, means it's time to go in. If it's Minnesota cold, 17 and 20 degrees below, you wouldn't want to stay outside more than 15 or 20 minutes with these guys.
- 5. Watch out for rock salt and antifreeze: Rock salt is going to be everywhere, so try, and keep your pet from eating it. It isn't toxic, but it can upset their stomachs. It may also rub on the pads of their paws to cause irritation. Pet-safe rock salt might be a great option for your home, or for your neighbor to use. Be extra vigilant about keeping your pet away from antifreeze. It tastes sweet, but is extremely toxic. Look out for blue or green-colored substances on driveways, sidewalks, and car surfaces.
- 6. **Make potty time quicker** and easier: Try shoveling a patch of grass for your dog to run to during potty time. If they opt to go on the carpet instead, try taking them outside for two

or three-minutes jaunts, and give them a treat every time they come in, just like when you were potty training. This will help incentivize them to learn a new routine. If your regular area is too cold, try a new area with less snow or overhead protection from falling rain or snow.

7. Learn how to warm up your dog: If your pet seems too cold, try covering them in a towel, or blanket. You can also use a blow dryer at the low setting (too high could burn the dog) to warm them up. Avoid heating pads, which could also cause burns, although warming some rice in a sock in the microwave is an excellent and pet-safe alternative. Put it against your wrist first to make sure it's not too hot.

A dog's normal body temperature should range from 99.5 to 102.5 degrees. (To get your dog's temperature, you'll need to use a rectal thermometer).

8. **Treat cracked pads:** Try a moisturizer originally made for cow udders to soothe your dog's paws. When applying anything

to his feet, keep him busy with a puzzle feeder or treat, so that he won't lick it right off. You can try preventing this type of damage by putting your dog in booties, or by cleaning off the pads of his feet every time he comes inside.

9. Give your dog plenty of exercise: It can be hard to get moving with your dog on a cold day, but letting your dog stay idle could lead to destructive or nervous behaviors due to all that pent-up energy. Once your dog is acclimated and prepared for the cold, it's ok to continue walks and backyard play. You can even build a little agility course in your backyard with piles of snow.

If your area is just too cold, try finding an indoor gym for dogs. Puzzle feeders are also a great option for keeping your dog busy on a long, cold winter day.

Best of luck enjoying the winter snow with the dog you love! That's all for now!




The maintenance included painting the ceiling and walls, installing updated interior and exterior lighting, repainting the inside plumbing, and repairing the exterior sidewalk masonry.

Lewis Black and his Rant, White and Blue Tour, hit Boston's Shubert Theatre on Friday with a political shock wave. Simple TIMES . . .

A peculiar pitch is gaining traction in the Digital Age. And it is loaded with questionable quotes, fake facts, lack of credibility, and unverifiable

The most recent presidential election cycle served up a daily dose of ugliness, charges, and countercharges, slander that brought idle threats of lawsuits, and three of the most agonizing Presidential debates ever seen. The whole process left me reeling. So, I wonder where we're heading as a "civil" nation while the world turns on, tunes in, and is fixated not so much on the content of a U.S. presidential candidate's character, but on the context of their retorts that are unbecoming of the most powerful office on the planet.

Since the election concluded, we've heard the words "alternative facts" uttered by Kellyanne Conway, senior advisor to President Donald J. Trump, during her appearance on Meet the Press on Sunday, January 22nd. Is such action intentional distortion of the truth or an unwitting way of misstating the whole truth and nothing but the truth? While I discerned lies in her answers, I am at a loss for an honest explanation as to what exactly is going on with Trump's administration. So I set out to get truthful answers.

I stumbled upon a cousin's share of an article on Facebook featuring a report by Jill Abramson, political columnist for The Guardian about the very issue I sought clarity from. She is alarmed by recent tweets by President Trump and his messy distortions of the Affordable Care Act, which became a signature policy of President Obama's eight years in the White House.

In search of more thorough explanations, I visited Google and found succinct, honest, thought-provoking answers. Abramson, former executive editor at The New York Times, said: "Most believe there is truth and there are lies. Alternative facts are lies," Abramson wrote in her column on January 24th.

My initial jump into the scrum of Social Media arrived in May 2015. Not a long time to be on Facebook after I learned that some folks have found it a friendly outlet since 2004! I now harbor a better grasp as to why I resisted regular invites by family and friends to join them on the new technological fascination of the 21st century.

For example, we're hearing a lot about "fake news" by fake journalists to President Trump's inaccurate tweets and speeches. But all that activity was not necessary for me to know that several readings over the past 21 months that Facebook is fraught with news that cannot be verified, lacks credibility, and carries phony news sources.

My natural instincts and superb training in Journalism School to discern fact from lies proved enormously beneficial. What's a Facebook member to do? I never open an unknown news source no matter how appealing its headline. And upon viewing news posts from Facebook friends, I ask: "is it credible," "is it verifiable."

As a guest on CNN's Reliable Sources in December, Abramson shared several instructive answers to host Brian Seltzer's queries. One is how can "news rooms" adapt "in this new environment". Abramson recommends: "Be less reactive" in carrying "patently false stories.'

Even in a peculiar era whereby gathering news and media outlets reporting are loaded with skeptics, Abramson adds: "Trust in the news media is at a historic low and probably sinking. Do thorough fact-checking. Blow the whistle on manufactured news stories. But journalists still have to do their jobs."

No doubt daily inundation of information from the Internet is taxing to the psyche. And it has become jaded to the extreme that any so-called story or rumor can spiral out of control. When I attended Journalism School in the 1980s the Internet was not in existence. No e-mails. No cell phones. No texting, nor Instagram. Snapchat? Not even a thought. While the Internet has merit, it also has its inherent troubles.

Ah, yes, placing my gaze on another person's gaze to interview for a column or report on a story is what I yearn for. The vast majority of interviews for my published material are by phone. Such a tool is vital as time and scheduling and travel to interview people are rarely realistic. And deadlines are ever looming.

With its inherent goodness, it is a cruel reality that Facebook has its myriad imperfections, quirks, questionable news sources, fake news, and lack of credibility in stories, along with a necessary working knowledge and reliance on Social Media for longtime journalists to continue their careers in the newspaper business.

I love my craft too much to allow the challenges of the Digital Age to toss me down another career track. And attaining that goal to author a book remains within reach.

Recipes from the Homeland

VINEGAR (PICKLED) PEPPERS

1 quart white vinegar 1 quart water 5 green bell peppers 3 teaspoons salt

3 medium pickling jars with screw caps 3 teaspoons sugar

Place white vinegar and water in a saucepan over medium heat and cover. Bring to a rolling boil for about three minutes.

Meanwhile remove stems and seeds from peppers. Wash peppers thoroughly. Cut peppers into quarter portions lengthwise and place in clean jars. Pour enough boiled water and vinegar combination over peppers, up to rim of jar. Add one teaspoon of salt and one teaspoon of sugar to each jar. Place cover tightly on each jar.

On a clean cookie sheet or cutting board, turn closed jar upside down, resting jar on its cover. Check to be sure that water is not leaking from jar. Allow standing for thirty minutes before turning jars right side up. Store for three or four weeks in your cupboard before use. Refrigerate only after opening jars.

NOTE: I began to pickle bell peppers in the 1950s when my cousin Josie (LaGrassa) DeSisto shared her recipe with me. Each time I pickled peppers, my mind wandered back to my childhood when each fall, Papa bought a case of the small Santo Nicolo peppers for pickling. They were small but firm. They were green, and some were spotted with a little red, or yellow skin. While Mama washed the peppers without removing stem or inner seeds, Papa prepared the very large ceramic container. It was the same kind that everyone else in the neighborhood used for pickling

After the peppers were clean, my parents placed them in the container and added the necessary vinegar and spices. I remember Papa placing a large ceramic cover on the container. He warned us not to go near the peppers.

All this took place in the little cubical of space in the cellar of 39 Charter Street, below our bakery. Each family had a cubical reserved for storing extra canned goods, wine, and preserved vegetables. Before long, the aroma of the pickled peppers found its way up to the street floor of the building. Papa wasn't the only one who had pickled peppers.

Each time I look at the ceramic container, still in my possession, it reminds me of the above yearly ritual.

A Nostalgic Remembrance



During most of my younger life, I played music on Valentine's Day. Many organizations would hold some type of a get together to celebrate the annual event. I played with many bands, and always looked forward to those middle of the winter jobs. One reason was that Lent was soon coming, and the work would be reduced dramatically. If I was playing at a nightclub, (a steady job) there would be no worries about the reduction in work due to the season of Lent. Babbononno had gone the same route two generations earlier and, Dad and my uncles, Paul and Nick, a generation before me.

Back in the heyday of supper clubs, I was leading the house band at a place in Waltham, called Piety Corner Gardens. It was owned by a man named Steve Santamaria, and he was a great man to work for. When holidays would roll around, he would come up with a theme that brought the people in, old and new customers. During Christmas season, he would have special dinner prices and gifts for the ladies. On the evening of Valentine's Day, he made sure that every female that entered his establishment received a long stem rose. I and my guys would play a lot of romantic music to set the tone for couples celebrating February 14th.

After Piety Corner Gardens closed, I played mostly "club dates," also called "onenighters." They paid well, and you never knew who you were going to be working with, due to the stable of musicians the contractors or bandleaders had. You could be playing a formal affair at the Copley Plaza, or a night out for members of a Knights of Columbus lodge. You never knew, but it was fun and I satisfied all of the prerequisites: I was always dressed in a tux (not a black suit and a bow tie like some of the guys); I was always early and ready to play at the designated time; I knew the correct notes to play for all of the tunes in the American Song Book (at least 1,000 or more songs).

I continued with this type of a routine until I was in my 30s. Interspersed were stints with bands in New York, knocking on doors in Hollywood, and putting my own rock group together. I grew up during the infancy of rock ... the doo-wop era, if you will. I learned to dance listening to the tunes of Chuck Berry, Little Richard, Bill Haley and the Comets, and dozens of other pioneers of the idiom in the 1950s. The ironic part of all of this was that, as time rolled on, I disliked rock and roll. When I decided to

look further into my prejudice, I made the decision to put a rock or top 40s group together and investigate the roots of my prejudices. I gathered a group of musicians and singers together, put a band together, and got us booked into nightclubs around Boston. As I said, "The ironic part of this," was that that first year leading a rock group, I made more money than I had in all the years of playing music that preceded that point in time.

When I was in my 30s, I decided to go back to school. After graduating Boston State (now UMass), I concentrated on show business. Babbononno, my uncles, and especially my father, all advised me to make things easier. Interspersed with teaching days and playing music nights, were two stints of returning to school for advanced degrees.

By the time I was in my midthirties, I was still a bachelor, doing well financially, and had no intentions of settling down. During the summer of 1973, I was on the road with a Motown group called the Uniques. I left them to return to teaching in Boston and playing nights around Labor Day that year. Opting for a three-day vacation before resuming my planned schedule, I headed for the Cape, and met Dean Saluti in Hyannis. We became fast friends, and he talked me into applying for entrance to a doctoral program at Boston University. At that point in time he was tending bar at night at the Kenmore Club in Kenmore Square, and working on his doctorate at BU. during the day. I took the entrance exam and was accepted to BU's Graduate School of Education.

On a given day, I entered one of my programmed classes for the first time and sat next to a very beautiful young lady. As time went on, I discovered that she was Italian American, lived in the North End, and was teaching school and working on her doctorate. After getting to know her, and with Valentine's Day coming up, I asked her out to dinner. I was a bit nervous as I had, for the most part, gone out with girls in show business, singers, dancers, or actresses, and none of them Italian. Going out with a home-based Italian girl was something I hadn't experienced since I was in my early 20s.

I decided to take her to a rather fashionable restaurant in Boston's financial district. I believe it was called Lechners. I wanted to make a good impression, so I made reservations for a middle-of-the-week evening, picked my date up in my new Lincoln, and headed to Boston's

financial district. A valet parking attendant helped us exit the car and we entered the restaurant stopping at the maître d's station

After we were seated, we ordered dinner giving our choices to a waiter wearing white gloves and a tuxedo. We decided to start with a Caesar salad that would be crafted from a cart that was wheeled right to our table. I knew that this event would let my date know how much class I thought I had, and the salad chef began the show, chopping, mixing, tossing, and everything else involved with the construction of a true Caesar salad.

Just as the tuxedoed salad chef finished and was ready to serve us, a very large fly flew over our salad and had a heart attack in midair. It took a nosedive and landed on its back in the middle of the lettuce, dead as a doornail with all legs pointing toward the ceiling. People at several tables had been watching the chef at work and witnessed the demise of the fly. Some laughed. Others, especially the women, gasped in shock. The salad chef, yelling "Oh dear, oh dear," headed off to find the manager and bring him back to our table. When the man in charge arrived, he looked at the results of a crash landing and immediately told us that dinner was on the house. I accepted, knowing that my intention of impressing a new date was as dead as the fly in the salad that was whisked away from our table.

Well, today Dean Saluti is one of my best friends. We both received our doctorates from BU. The restaurant ... it's long gone. My date? About a year later, we were married. This coming summer Loretta and I will celebrate our 40th anniversary together.







HOOPS and HOCKEY in the HUB

They came out of the tunnel and into the light, the bright glimmering surface reflecting back their images as they began to glide across the surface — something they had done since childhood.

But it was different now.

No longer was their longtime mentor behind the bench, urging them on, pushing them to be productive, and certain to be somewhat critical if aspects of their game fell below his standards.

The Bruins were on the ice, but he was on their minds. After all, hadn't the new leader — Bruce Cassidy — stated openly in his first press conference, that he, the new head coach, had let him down?

And didn't he go on to say that, the players felt the same way?

Yes, that's what was said. But, who knew that what they would accomplish within a week's time would in some weird way partially atone for their less than spectacular play of the past few weeks.

Even they couldn't have foreseen that these revived, rejuvenated Bruins would play a significant role in accomplishing the unforeseen — the surprise ending to it all, the final act that would lead to Claude Julien being hired for one of the prize coaching positions in the NHL — the Montreal Canadiens.

Yes, the Habs, the archrivals of the B's, the antithesis of the Black and Gold. But in a way, the best position in the NHL for which Julien was qualified.

In the days following Julien's release — (Bruins coaches are never fired. They are "relieved of their duties.") — one wondered in which direction the team would head.

It appeared the B's were at a crucial juncture — similar to facing an old-time road sign with a plethora of directional arrows attached. A wrong turn could lead to negative results, while others could lead to mixed experiences. The Bruins chose the one true way — the winning way.

The triumvirate of victories — over San Jose, Vancouver, and finally the Canadiens left one to wonder why we hadn't seen these exploits throughout the season. The B's appeared refreshed and resolved. They seemed like a team on a mission, one that was accomplished by winning those three games in a convincing manner, none more so than their 4-0 victory over the Canadiens at the Garden on February 12th.

It was almost enough to enable fans to forget Claude Julien, the man who had coached the B's for the past nine and two-third seasons, had engineered the end of the Stanley Cup drought and had reinstilled Black and Gold pride throughout the region once again.

Indeed, seeing Coach Cassidy ascend the podium for his first postgame press conference after the win over San Jose seemed like an interview with a visiting coach — so much had Julien's presence been sewn into the fabric of the Bruins.

But, in a way, the Bruins were not completely done with their former coach for the reanimated B's had one last role to play for him

The victory over the Canadiens, coming in such an emphatic manner—a 4-0 shutout against the Atlantic Division leaders, who had amassed 70 points to that juncture in the season—set the wheels in motion for this drama's final act.

On Valentine's Day, the Canadiens, like so many teams before them, proved that there is no love in pro sports by firing Coach Michel Theirren, the man behind the bench of their first-place team.

For the second year in a row, Montreal had started the season at a torrid pace, going 13-1-1 to grab a commanding lead. Last year the Habs did much the same, but cooled off as the season went on, and failed to make the playoffs.

Now, up in the Province of Quebec, this year's proceedings appeared headed for a rerun. Montreal had gone 9-10-2 in the 2017 portion of the schedule and several teams appeared to be closing in on the frontrunners.

But, suddenly a possible solution appeared in the picture. Someone who was not available a few short days before became a possibility. A Quebec native, one who spoke French (always a positive in Montreal) and had coached the team in a prior era.

The Canadiens appeared to be sinking. They had not only lost to the Bruins, they had lost badly. Now was the time to attempt to right the ship. Now was the time because the best person for the job was available. And who knew how long he would be available.

Now was the time for Claude Julien to rejoin the Canadiens and lead them into the playoffs. And thus, it was that Julien once again took command of the helm of the Habs, a parting gift of sorts made possible by the actions of his former team.

If Claude Julien had still been with Boston, he would not have been available. Perhaps Therrien would still be the coach of Montreal. And even if he had been dismissed, it would have been someone other than Julien that would have been named to the position.

But in this final act, those scenarios would not be allowed. Once Julien was fired by Boston, his former players and coaches did the only thing they could do to put a positive spin on it all. They regrouped and went out and won.

In a convoluted way, their winning enabled their former coach to secure a position that really was made for him. It created an opportunity at just the right time for just the right person.

Timing is everything. This was the time where a unique constellation of events played out over the course of a week, bringing to fruition a conclusion that no one could have foreseen a week earlier.

Claude Julien — the coach of the Montreal Canadiens. On the day he was dismissed by the Bruins who would have thought it was possible? As the Bard would say: "All's well that ends well."
