

## CACTOLOGY III ADDENDA ET CORRIGENDA

Heath (1999: 1) elevated *Stenocereus* subgen. *Griseocereus* P.V.Heath (1996) to the rank of a genus, as *Griseocereus* (P. V. Heath) P. V. Heath. The 1996 basionym itself was a new name (based on *Cereus* [infragen.unranked] *Pruinosi* K.Schumann, *Gesamtbeschr. Kakt.* 1: 52 1897). Heath (1999) did not provide a description or cite a type for his genus name. Since *Griseocereus* (P. V. Heath) P. V. Heath lacked a description and a type citation, I (Guiggi, 2012) assumed that Heath's genus name was not validly published, and with such a belief, I proposed the same genus name (*Griseocereus*) for a new taxon at the rank of genus and typified it with *G. fimbriatus* (Lamarck) Guiggi (cfr. ICBN Art. 37.1, Mcneill *et al.*, 2006). Within my new genus, I proposed four new combinations. After a personal discussion with Kanchi Gandhi (GH), I realized that my new genus name *Griseocereus* Guiggi (2012) is a later homonym of *Griseocereus* (Heath) Heath (1999) (cfr. ICBN Art. 53.1, Mcneill *et al.*, 2006). The latter generic name, although yet to be typified, is valid and legitimate. Therefore, *Griseocactus* is proposed here as a substitute name for *Griseocereus* Guiggi. This necessitates the transfer of taxa previously treated under *Griseocereus* Guiggi to *Griseocactus*. Accordingly, four new combinations are made here.

***Griseocactus*** Guiggi, **nom. nov.** Replacement name: *Griseocereus* Guiggi, Cactology 3: 7 (2012), **nom. illeg.** (non *Griseocereus* (Heath) Heath 1999).

***Griseocactus fimbriatus*** (Lamarck) Guiggi, **comb. nov.** *Basionymus*: *Cactus fimbriatus* Lamarck, Encycl. 1(2): 539 (1785). *Synonymus*: *Griseocereus fimbriatus* (Lamarck) Guiggi, Cactology 3: 7 (2012).

***Griseocactus fricii*** (Sánchez-Mejorada) Guiggi, **comb. nov.** *Basionymus*: *Stenocereus fricii* Sánchez-Mejorada, in Cact. Suc. Mex. 18(4): 89 (1973). *Synonymus*: *Griseocereus fricii* (Sánchez-Mejorada) Guiggi, Cactology 3: 7 (2012).

***Griseocactus griseus*** (Haworth) Guiggi, **comb. nov.** *Basionymus*: *Cereus griseus* Haworth, Syn. Pl. Succ. 182 (1812). *Synonymus*: *Griseocereus griseus* (Haworth) Guiggi, Cactology 3: 7 (2012).

***Griseocactus pruinosus*** (Otto ex Pfeiffer) Guiggi, **comb. nov.** *Basionymus*: *Echinocactus pruinosus* Otto ex Pfeiffer, Enum. Diagn. Cact. 54 (1837). *Synonymus*: *Griseocereus pruinosus* (Otto ex Pfeiffer) Guiggi, Cactology 3: 8 (2012).
