HIGHLIGHTS

Chapter 71: Grounds for Deportation

- Section 71.05 has been substantially updated to include the latest case law concerning the criminal grounds of deportability

Chapter 33: Refugees, Asylum, and Restriction on Removal. The information in this chapter on “Temporary Protected Status (Safe Haven)” has been revised to include information on the designation of countries whose nationals may be eligible for TPS. See § 33.08.

Chapter 71: Grounds for Deportation. Section 71.05 (“Deportability Based on the Commission of Criminal Offenses”) has been completely updated, with the latest information on crimes involving moral turpitude (§ 71.05[1]), noncitizens convicted of aggravated felonies (§ 71.05[2]), high speed flight (§ 71.05[3]), deportability for conviction other crimes (§ 71.05[4]), and controlled substance violations (§ 71.05[5]).

Chapter 104: Judicial Review. This chapter has been revised to account for 2003’s Administrative Procedure Act (APA) and other changes affecting the exhaustion of administrative remedies. See § 104.02.
