INTRODUCTION OF BILLS

**\*House Bill No. 30** -- Tort Liability and Reform - As introduced, limits liability of apiarists under certain circumstances. - Amends TCA Title 44, Chapter 15. by \*Casada.

**\*House Bill No. 31** -- Physicians and Surgeons - As introduced, exempts primary care physicians from restriction on right of an employed or contracted healthcare provider to practice upon termination or conclusion of the employment or contractual relationship. - Amends TCA Section 63-1-148. by \*Casada.

**\*House Bill No. 32** -- Naming and Designating - As introduced, designates "John Charles Tidwell Visitor Center" at Johnsonville State Historic Park. by \*Gilmore.

**\*House Bill No. 33** -- Traffic Safety - As introduced, requires that 95 percent of revenue from traffic violations resulting from traffic surveillance cameras be earmarked solely for educational needs of local governing entity. - Amends TCA Section 55-8-198. by \*Ragan.

**\*House Bill No. 34** -- Public Health - As introduced, requires hospitals to provide parents of newborns with certain information concerning pertussis disease and immunizations. - Amends TCA Title 68, Chapter 11, Part 2. by \*Maggart.

**\*House Bill No. 35** -- Criminal Offenses - As introduced, enhances penalties for patronizing prostitution and promoting prostitution in certain instances; provides immunity for minors arrested for prostitution; establishes tow and impound procedures for vehicles used in prostitution offenses. - Amends TCA Title 37; Title 39 and Title 40. by \*Maggart.

**\*House Bill No. 36** -- Election Laws - As introduced, clarifies and adds to the duties of county administrators of elections. - Amends TCA Title 2, Chapter 12. by \*Dunn.

**\*House Bill No. 37** -- Education - As introduced, removes annual reporting requirement of the state board of education on the weight of textbooks. - Amends TCA Title 49. by \*Dunn.

**\*House Bill No. 38** -- Motor Vehicles - As introduced, requires notice be given to the registered owner of an abandoned or unattended motor vehicle within three business days after receiving verification of ownership or within 30 days of taking the vehicle into custody, whichever is earlier. - Amends TCA Title 55, Chapter 16. by \*Dunn.

**\*House Bill No. 39** -- Safety - As introduced, adds go karts, climbing walls, and inflatable devices to amusement devices subject to inspection and review by the elevator and amusement device safety board. - Amends TCA Title 68, Chapter 121, Part 1. by \*Montgomery.

**\*House Bill No. 40** -- Special License Plates - As introduced, authorizes issuance of new specialty earmarked plate for adoption; allocates revenue from such plates to the Adoption Foundation of Tennessee, Inc. and to Harmony Adoptions of Tennessee, Inc. - Amends TCA Title 55, Chapter 4. by \*Montgomery.
