## APPENDIX II

# STRUCTURE OF THE UNITED NATIONS

## THE GENERAL ASSEMBLY

The General Assembly is composed of all the Members of the United Nation. (For delegations to the third emergency special session and the thirteenth regular session during 1958, see APPENDIX IV.)

President, third emergency special session: Sir Leslie Munro (New Zealand).

Vice-Presidents, third emergency special session: Ceylon, China, France, Paraguay, Spain, Tunisia, USSR, United Kingdom, United States.

President, thirteenth regular session: Charles Malik (Lebanon).

Vice-Presidents, thirteenth regular session: Australia, China, Czechoslovakia, Ecuador, France, Indonesia, Nepal, Netherlands, Pakistan, USSR, United Kingdom, United States, Uruguay.

The Assembly has four types of committees: (1) Main Committees; (2) procedural committees; (3) standing committees; and (4) subsidiary and ad hoc bodies.

### MAIN COMMITTEES

### PROCEDURAL COMMITTEES

SPECIAL REPRESENTATIVE OF THE SECRETARY-GENERAL, JORDAN  
 On 21 August 1958, the General Assembly adopted a resolution (1237 (ES-III)) which, among other things, asked the Secretary-General to make such practical arrangements as would adequately help uphold the purposes and principles of the United Nations Charter in relation to the situation then prevailing in Lebanon and Jordan and thereby "facilitate the early withdrawal of the foreign troops from the two countries".

Following consultations called for by the resolution, the Secretary-General appointed Pier P. Spinelli, United Nations Under-Secretary in charge of the European Office of the United Nations, as his special representative in Jordan, stationed in Amman, to assist in the implementation of the Assembly's resolution, specifically with a view to help in upholding the purposes and principles of the Charter in relation to Jordan in the circumstances prevailing at the time and to keep within his purview "the implementation of the principles of the Assembly's resolution by all nations in relation to Jordan".

PANEL FOR INQUIRY AND CONCILIATION  
 The Panel, established by the General Assembly in 1949, by resolution 268 D (III), consists of qualified persons, designated by their States to serve a term of five years, who are readily available to assist the United Nations organs or States parties to a controversy in the settlement of disputes and situations by serving on commissions of inquiry or of conciliation.

It was to study the comments of Member States on the question of defining aggression in order to determine when it would be appropriate for the Assembly to consider the question again, but not earlier than at its fourteenth session.

The Committee is composed of those Member States which served on the General Committee at the most recent regular session of the Assembly. The Committee did not meet in 1958.

COMMISSION ON PERMANENT SOVEREIGNTY  
OVER NATURAL RESOURCES

This Commission was established by the General Assembly on 12 December 1958 under resolution 1314 (XIII) to conduct a "survey of the status of the permanent sovereignty of peoples and nations over their natural wealth and resources", due regard being paid "to the rights and duties of States under international law and to the importance of encouraging international co-operation in the economic development of under-developed countries". The Commission was to report to the twenty-ninth session of the Economic and Social Council.

## THE SECURITY COUNCIL

The Security Council consists of 11 Members of the United Nations. Five are permanent members of the Council. The Group was to keep the Security Council currently informed through the Secretary-General.
