

Dear Program Applicant:

Thank you for your interest in the Hopkinsville Fire/ EMS EMT Program. Please read this application package **entirely** and follow all instructions carefully. Incomplete application packages or failure to comply with these procedures may preclude your acceptance into the Program.

PROFESSIONAL CERTIFICATION:

The EMT Program has a rigorous curriculum that requires FULL dedication throughout the entire course.

Completion of the Program qualifies the candidate to take the National Registry EMT exam, which is required for Kentucky EMT certification.

Upon successful completion of the program, students will obtain a Certificate of Completion in EMT Training allowing them to sit for the NREMT exam and Skills testing.

FINANCIAL OBLIGATIONS

Full Tuition is due at Orientation on August 23rd. (We are unable to accept GI Bill at this time) Students are responsible for all supplies, books, testing, certification, and licensing fees that are NOT included in this price. A price list is provided below. Please note that not all of these fees are due at the same time.

Tuition: \$1,000.00 (Due at Orientation)

Books: \$156.71 (Will purchase individually before class starts)

AHA CPR: Included in Tuition

Background Check \$41.20

Skills testing: Free

FISDAP Testing: \$25.00 (Due at Final Exam)

Testing Fee: \$98.00 (You will pay this to National Registry of EMTs when you decide to go take the test, after the course is completed)

KY License Fee \$40.00 (Once you pass your NREMT exam, you will pay this to KY to become certified in the state of Kentucky if you wish)

Uniform for ride time will be a blue Polo with khaki or blue pants.

Total cost: Approx. \$1400.00 from start to being certified in Kentucky.

COURSE ADMISSION PREREQUISITES

1. Be at least 18 years old
2. Hold a high school diploma or a GED
3. Understand, read, speak, and write the English language with a comprehension and performance level equal to at least the ninth grade of education
4. Must NOT have been found guilty of, entered a guilty plea, or Alford plea to a felony offense or have completed a diversion program for a felony offense
5. Hold a valid motor vehicle operator's license

SELECTION PROCEDURE:

Students with a completed application packet and that meet minimum requirements will be considered for admission into the program. The staff of the Training and Education Institution will evaluate each application and will also conduct an interview from each candidate. Interviews will be held at the Information Session.

SCHEDULE:

The classes will be held every Monday & Thursday (excluding Holidays). First day of class is August 30, 2021 with a tentative graduation date of February 7, 2022. The skills exam will be on Saturday February 12th, time TBA. There is a Thanksgiving and Christmas break.
