## Great Salt Lake Advisory Council

### BACKGROUND

The Great Salt Lake Advisory Council ("Council") was established by House Bill 343 in the 2010 session of the Utah State Legislature. Council members were appointed by Governor Herbert, with consent of the Utah Senate, in June 2010. Governor Herbert kicked off the initial Council meeting on June 30, 2010.

## Duties of the Great Salt Lake Advisory Council

Legislation creating the Great Salt Lake Advisory Council identifies five specific "duties" of the Council:

1) ADVISE the governor, the Department of Natural Resources ("DNR"), and the Department of Environmental Quality ("DEQ") "on the sustainable use, protection, and development of the Great Salt Lake" ("GSL") "in terms of balancing: (i) sustainable use; (ii) environmental health; and (iii) reasonable access for existing and future development."

2) ASSIST the Division of Forestry, Fire and State Lands ("FFSL") in its statutory responsibilities for the Great Salt Lake (i.e. to prepare and implement a comprehensive management plan, initiate and publish studies of the lake, coordinate activities of DNR divisions with respect to the lake).

**3) RECOMMEND** appointments to the GSL technical team and utilize technical support from that team.

**4**) **ASSIST** DNR and DEQ and their boards in their responsibilities for the Great Salt Lake.

5) **REPORT** *"annually"* to the Natural Resources Appropriations Subcommittee *"on the council's activities."* 

## 2016 Tasks and Activities of the Great Salt Lake Advisory Council

During 2016, the Council addressed all five of its primary work plan tasks and objectives, as follows:

1) ADVISE — The Council briefed and advised the Executive branch, including meetings with representatives of the Governor's Office, Agency Directors, and Department and Agency managers.

**2**) **ASSIST** — The Council met frequently with officials of the Utah Division of Forestry, Fire and State Lands to assist in and provide support for the Division's statutory responsibilities and priorities.

3) **RECOMMEND** — The Council shared its recommendations regarding funding of Phragmites control, specific aspects of the Integrated Water Resource Management model, impacts from declining elevation of Great Salt Lake, the Great Salt Lake Technical Team's research funding, and other priorities.

4) ASSIST — The Council worked with both the Utah Department of Natural Resources and the Utah Division of Water Quality on Great Salt Lake issues ranging from nonnative invasive plants to air quality, from water quality to water management, and on numerous other issues.

5) **REPORT** — The Council prepared and provided its 6th Annual Report to the Utah State Legislature Natural Resources, Agriculture, and Environmental Quality Appropriations Subcommittee.

The Council further fulfilled its statutory responsibilities to advise, assist, recommend and report by holding five (5) formal meetings in 2016, with briefings, updates, reports, discussions and counsel on topics including causeway modification, water resource modeling, water development impacts, invasive species, air quality, lake elevation, GSL research, and other GSL-related topics. The major 2016 Council activities are summarized, below.

## **Funding Support: Phragmites Eradication**

Continued expansion of non-native Phragmites has a significant negative impact on the GSL ecosystem. It reduces native wetlands, limits use by wildlife, excludes favorable forage and nesting plant species, traps sediments, poses fire danger, consumes excessive water, and limits lake access for recreation, research and rescue. In 2012 the Council recommended eradication of Phragmites from the GSL ecosystem as a priority. The Council supports continued funding (\$500,000 for FY 2017-2018) for Phragmites research and eradication.

### **Program Support: Council Staffing**

The Council is holding regular public meetings, initiating updates, preparing reports, facilitating priority research, responding to requests for input, providing comments, and undertaking substantive activities in support of GSL. The Council receives limited staff support from the state employees already fully dedicated to agency responsibilities. The Council requests a dedicated full-time employee to help administer our work and fulfill our statutory responsibilities.

## Program Launch: Integrated Water Resource Management Model

Four years ago, the Council recommended development of an Integrated Water Resource Management ("IWRM") model to define and understand how variable precipitation and water management in GSL's watershed influences the lake's water levels, salinity, and the resources the lake supports. Funding was approved by the Legislature and model development is now complete, with model launch in early 2017. The Council is providing input to state agencies on how to launch, utilize and maintain the model to maximize its use and benefits.

### **Comments: State Water Strategy Plan**

In 2013 Utah Governor Herbert announced the need for a 50year Water Strategy Plan for Utah and assembled a State Water Strategy Advisory Team to prepare a draft strategy. Recently, the Team released a draft for comment. The Council agreed to prepare comments focusing on GSL. The comments will highlight ecological and economic values of the lake and the desire to hold GSL harmless from negative impacts.

# Implementation: Great Salt Lake Adaptive Management Tool

In 2014 the Council adopted an objective of no further net migration of salt from the South arm to the North arm of GSL. In support of that objective, the Council recommended support for the Union Pacific Railroad bridge project, provided it is built to accommodate adaptive management (i.e. control bidirectional flows). Prior to bridge project completion in 2016, the Council began discussions with the Division of Forestry, Fire and State Lands on policies and procedures to utilize the adaptive management tool.

## Policy Priority: Great Salt Lake Surface Elevation

In 2016, the surface elevation of GSL declined beyond the historic low. "Sustainable use, protection and development" of GSL are impacted by fluctuations in its surface elevation. Elevation cycles are trending towards lower overall lake levels, seriously impacting lake-related commercial activities, human health and air quality, wildlife populations, and overall health of the lake's ecosystem. In 2016 the Council initiated development of a substantive menu of possible options, tools and responses to address low lake elevation.
