# Great Salt Lake Advisory Council

## **BACKGROUND**

The Great Salt Lake Advisory Council (Council) was established by House Bill 343 in the 2010 session of the Utah State Legislature. Council members were appointed by Governor Herbert, with consent of the Utah Senate, in June 2010. Governor Herbert kicked off the initial Council meeting on June 30, 2010.

# **Duties of the Great Salt Lake Advisory Council**

Legislation creating the Great Salt Lake Advisory Council identifies five specific "duties" of the Council:

- 1) ADVISE the governor, the Department of Natural Resources (DNR), and the Department of Environmental Quality (DEQ) "on the sustainable use, protection, and development of the Great Salt Lake" (GSL) "in terms of balancing: (i) sustainable use; (ii) environmental health; and (iii) reasonable access for existing and future development."
- 2) ASSIST the Division of Forestry, Fire and State Lands ("FFSL") in its statutory responsibilities for the Great Salt Lake (i.e. to prepare and implement a comprehensive management plan, initiate and publish studies of the lake, coordinate activities of DNR divisions with respect to the lake).
- **3) RECOMMEND** appointments to the GSL technical team and utilize technical support from that team.
- **4) ASSIST** DNR and DEQ and their boards in their responsibilities for the Great Salt Lake.
- 5) **REPORT** "annually" to the Natural Resources Appropriations Subcommittee "on the council's activities."

# 2020 Tasks and Activities of the Great Salt Lake Advisory Council

During 2020, the Great Salt Lake Advisory Council addressed all five of its primary statutory "duties" as follows:

- 1) ADVISE The Council advised the Executive branch, including the Governor's Office, Agency Directors and department and agency managers on issues that impact GSL sustainable use, protection and development, including: strategies for water supply, policies for water administration, priorities for research, benefits from conservation, and others.
- 2) ASSIST The Council met frequently with officials of the Utah Division of Forestry, Fire and State Lands to assist in and provide support for the Division's statutory responsibilities and priorities, and to assist in initiating and publishing studies of the lake such as the reports on water conservation impacts, feasibility of strategies to get water to the lake, and implementing legislative direction on water supply and policy.
- 3) **RECOMMEND** The Council received reports and presentations from the Division of Forestry, Fire and State Lands' Great Salt Lake Technical Team and utilized technical support from that team on topics, including: air quality, hot topics impacting the lake, dust sources and quantification, etc.
- 4) ASSIST The Council worked with both the Utah Department of Natural Resources and the Utah Department of Environmental Quality on Great Salt Lake issues ranging from water supply to water elevation, from invasive plants to research priorities, from water management to water quality, and on other issues.
- 5) REPORT The Council prepared and provided its 10th Annual Report to the Utah State Legislature Natural Resources, Agriculture, and Environmental Quality Appropriations Subcommittee.

The Council further fulfilled its statutory responsibilities to advise, assist, recommend, and report by holding five (5) formal meetings in 2020, with briefings, updates, reports, discussions, and counsel on many GSL-related topics. Some 2020 Council activities are summarized, below.

# **Feasibility of Water Strategies for Great Salt Lake**

In September 2020 the Great Salt Lake Advisory Council completed a compelling and collaborative report entitled Water Strategies for Great Salt Lake: Legal Analysis and Review of Select Water Strategies for Great Salt Lake. In 2017, the Council had identified 70 strategies to maintain or increase water deliveries to Great Salt Lake. This 2020 report analyzed the legal, policy and technical feasibility of implementing 12 of the most promising strategies to maintain or increase water to GSL. The feasibility report organizes the recommended strategies into four categories: foundational, operational, tactical and organizational. The report concluded that while each of the strategies will improve water management, a combination of key strategies is necessary to improve water delivery to Great Salt Lake. The Council is hopeful that the proposed 12 strategies will be implemented to assure positive impacts on Great Salt Lake water levels.

# **HCR-10 Report and Recommendations**

Great Salt Lake Advisory Council provided resources, in 2020, to facilitate implementation of HCR-10 - "Concurrent Resolution to Address Declining Water Levels of Great Salt Lake." Enacted in 2019 at the request of the Council, HCR-10 prompted the Utah Departments of Natural Resources and Environmental Quality to convene a stakeholder group (Steering Group) consisting of State officials, experts in water law and municipal and agricultural water supply, agricultural producers, conservation and recreation interests, and representatives of industries that rely upon the lake. The Steering Group met regularly throughout 2020 and developed an influential report entitled Recommendations to Ensure Adequate Water Flows to Great Salt Lake and Its Wetlands. The report, completed in December 2020, presents 16 viable "Strategic Opportunities" to get water to the lake. The Great Salt Lake Advisory Council and the HCR-10 Steering Group are hopeful that the document will ignite continuing conversations, studies and thoughtful decision-making.

# **Conservation Impacts Study**

In October 2020 the Great Salt Lake Advisory Council released a report, entitled *Conservation Impacts Study*. The report examined the impacts of conservation on Utah water resource planning and on large water development projects that have the potential to negatively impact the declining Great Salt Lake. The study evaluated four water providers in Northern Utah. It concluded that significant, yet achievable, conservation could postpone the need for certain water development projects for another 40 years. For example, if the per person consumption is reduced by 50 gallons per day, to 173 gallons per day person, that level of conservation would postpone the need for large water projects such as the Bear River Development Project beyond 2065. In 2021, this study will likely be expanded to consider the conservation impacts of other Wasatch Front water suppliers.

#### **Great Salt Lake Public Information**

The Great Salt Lake Advisory Council has commissioned or facilitated numerous impactful studies and reports on the importance of Great Salt Lake, its contributions to the State of Utah, and ways to preserve those benefits and protect Lake resources. To help disseminate this timely and important data and information, and to help inform the public about GSL, in early 2020, the Council sought the assistance of information experts. Together with that outside help and expertise, the Council developed a general public information strategy. We also prepared written materials, including executive summaries, holding statements, talking points and press releases. Council staff also received presentation training and public education advice. This effort resulted in significant opportunities to share our information about Great Salt Lake

#### **Great Salt Lake Coordinator**

For several years, the Great Salt Lake Advisory Council has recommended that the State of Utah establish a full-time coordinator specifically for Great Salt Lake. A dedicated staff person is required to coordinate decisions and actions across the watershed to minimize costs and maximize benefits to Great Salt Lake and its wetlands. The Utah Legislature approved this position during the 2020 legislative session. This person is expected to: provide GSL-related coordination between governments, agencies, watersheds and stakeholders; facilitate research and public education; and contribute much-needed staff support for the Advisory Council and other GSL-related state groups. With more than a decade of experience on Great Salt Lake, Laura Vernon was appointed as Great Salt Lake Coordinator in July 2020.
