

Steart Peninsula, Somerset - Severn Estuary (Photo - WWT)




- Responsible for leading on the National Habitat Creation Programme (NHCP)
- Facilitates delivery of compensation habitat creation for local authorities who share responsibilities for coastal squeeze
- Targets identified within the Shoreline Management Plans

Compensatory measures are a must-have!



- Coastal protection plans offset negative effects
- Maintain ecological coherence of the Natura 2000 network
- Mitigate for hydro-morphological pressures in HMWBs
- Offset adverse effects of sea level rise "squeezing" habitats against hard surfaces maintained in the Shoreline Management Plans (SMP2's)

Compensate for coastal squeeze and adverse effects of sea level rise



Habitat Regulation Appraisals (HRA) of SMPs:

- Sea Level Predictions UKCP09 (medium emission projection 95th %ile
- 80cm rise over 100yrs (2105) (BUT 93cm-1.9m within physical plausibility!)
- Habitat creation and monitor SLR / Natura 2000 network!






Challenge:

- Inflexible Capital/ EU Funding Timetables


Land Owner Constraints

Land purchase or agreement options


Need to incentivise farm land-owners!

Conflict with other conservation agendas

Challenge: conflicting needs for creating compensation habitat while maintaining protection of designated sites and providing essential mitigation for scheme impacts

- SSSIs
- NERC Act Section 42 species
- Protected species (e.g. water voles)
- Birds Directive (Art. 3)


Funding

FCRM Budget 2014/15: £21M.....but £21M has to do a lot!


FCRM Capital Funding

Habitat creation costs: £50-200K per Ha

- European funding (e.g. Life Plus)
- Other funding (third sector partnership)
- LA and other partnership working



Responsibility – Welsh Government

Article 6(4) of the Directive states:

"....the member state shall take all compensatory measures necessary to ensure that the overall coherence of Natura 2000 is protected......"

Regulation 66 of the Regulations states:

'....the appropriate authority must secure that any necessary compensatory measures are taken to ensure that the overall coherence of Natura 2000 is protected'

Successes

Steart Peninsula (contribution)?



Steart Peninusla, Somerset – Severn Estuary

- 100 Ha (£5M)*
- Linked to Severn Estuary Strategy
- Compensation for epoch 1 (2025)
- Decision by Minister pending
- If a "No!"?

* 100Ha= 79ha from Steart and 21ha from Plustwines and Congesbury Yeo




Morfa Friog (Fairbourne) – 5 Ha

Mitigation for Flood Alleviation Scheme



- Planning approved
- Marine consent approved
- Fairbourne FRMS completed
- c.5Ha by October 2014



Cwm Ivy – 40Ha (Carmarthen Bay & Estuaries SAC)



- £38K/Ha / £1.5M
- Partnership with National Trust
- Land owner negotiation underway
- Approved for development of business case and Project start-up

Planned – 2/3 more schemes to appraisal and design phase in 2014-16

Setting the scene for compensation habitat creation schemes in:

- Carmarthen Bay SAC
- Anglesey Saltmarsh SAC
- Menai Strait Conwy Bay SAC
- Lleyn Peninsula & Sarnau SAC





Conclusions

- Compensation requirements are large (c.3000Ha by 2105)
- Risks are infraction, capital and reputational
- Severn Estuary SAC is a risk area
- Habitat creation is tricky & costly!
- Land issues and funding restraints to success!
- NRW making good progress on all fronts
- NRW: an opportunity to work more effectively to create N2K habitat ahead of SLR
- NRW looks forward to closer WG involvement in the NHCP
