The Oban Company Petitioner to the Vice Admiral of Argyllshire

1736 Jan 2. Petition by Robert Arthur for the Oban Company alleging that the company's ship Diamond with a cargo of tobacco was damaged in a storm through the negligent actions of the officers of a second vessel, and praying the Vice Admiral to apprehend them until caution is found as a surety for their defending themselves against charges. 1 document. 2 pages & endorsement.

1735 Dec 31. Letter, Archibald Campbell, Horseshoe (in Kerira), to Angus Campbell of Asknish, explaining that the Diamond and her cargo of tobacco belonging to the Oban Co. has been forced by a gale to put in at Horseshoe in course of a voyage from Virginia to Fort William. The parting of the anchor from the cable caused the vessel to ground, with what damage they are uncertain. 1 doc. 2 sides.
