- 1. Acquaint you with some special topics important to business and accounting professionals: business organizations, commercial paper, secured transactions, bankruptcy, sales, securities law, and accountants' legal liability
- 2. Prepare you for the Regulation section of the CPA exam

Below is a the list of topics. The course consists of 37 modules, three midterms, and a final exam. Each module generally consists of (1) a brief lecture you'll view on Blackboard, (2) a reading assignment, and (3) homework problems to be turned in, some of which I will discuss in video on Blackboard. (There is no homework for the last module, on miscellaneous topics.)

**Grading** There are 1,000 points possible, scored as follows:

Homework: 100 points
Midterm 1: 200 points
Midterm 2: 200 points
Midterm 3: 200 points
Final: 300 points

Final grades will be cut at A = 900 or more, B = 800 or more, C = 700 or more, D = less than 700.

**Homework** For each module, you will turn in several written homework questions. I will post videos discussing **some** of these questions, but I encourage you to try and work through all of them on your own before you view the video. You will learn commercial law by working commercial law problems on your own, and by struggling with the material as you do so. **Turn in all the questions, even the ones worked together.** 

**Tests** Tests will be multiple choice. You are free to use your book, notes, and any resource you can find online except communicating with other people.
