Andrew Kinkead of Taughboyne Parish, County Donegal (bef 1701 - c1722).

  - Discussion: This is an inventory of his estate. The online searchable database at the National Library of Ireland for some unknown reason adds Galway in a column titled "county of residence." This must be an error as the entry says Donegal and Louth. **Even Louth is an error**. The surviving abstract shows that Co Louth was meant to be Cloth Merchant.

George Kinkead of the diocese of Raphoe, County Donegal (bef 1716 – aft 1733).

- **George Kinkead** and <u>Isabella Fausset</u> obtained a marriage licence bond in 1734 [*Index to Raphoe Marriage Licence Bonds*, *1710-1755 and 1817-1830*. Transcribed by Rosemary ffolliott. Dublin: The Irish Ancestor, 1969. Published as a free supplement to The Irish Ancestor. 8].
  - <u>Discussion</u>: The Church of Ireland diocese of Raphoe consisted of thirty four parishes and covered most of Co. Donegal. It included the parishes of All Saints, Convoy, Conwall, Killea, Kilteevoge, Leck, Raphoe, Raymoghy, Stranolar, and Taughboyne in the barony of Raphoe as well as Burt parish in the barony of Inishowen West. Excluded was the Inishowen peninsula (Derry Diocese) and the very south of the county (Clogher Diocese).

In 1733 a marriage licence bond was made for the marriage of **Andrew McIlwaine** and **Jane Fasset** and in 1733 another was made for the marriage of **Ann McIlwain** and **Andrew Ferrell**[*Index to Raphoe Marriage Licence Bonds*, 1710-1755 and 1817-1830. Transcribed by Rosemary ffolliott. Dublin: The Irish Ancestor, 1969. Published as a free supplement to The Irish Ancestor. 10].

John Kinkead of Raphoe diocese, County Donegal (bef 1716 – aft 1733).

- <u>It is not certain</u>, but he is probably the father of James Kinkead of Maghereagh, Donagheady Parish, County Tyrone as there were Hutchinson spinster sisters living there in 1773 when James Kinkead appears in that townland. James Kinkead was succeeded by his son Robert.

  - Note: I am thankful to Norman L. Kincaide of Rocky Ford, Colorado, USA for noting a number of the following records pertaining to James Kinkead, the watchmaker, and his family.
  - James Kinkead, watchmaker, is noted in the *Kinkeads of Delaware*, as having advertised in the

Pennsylvania Gazette on 14 March 1765. In this he was noted as:

**James Kinkead**, clock and watchmaker from Strabane in Ireland but late of Sadsbury Township, Chester County.

- **James Kinkead** married <u>Margaret Legit</u> on 3 September 1765 [Pennsylvania Archives. 2nd Series. Ed. John B. Linn and Wm. H. Egle. Harrisburg: B F Meyers, State Printer, 1876. volume, p. 167].
- **James Kinkead** and his wife, Margaret, received 96 pounds, 8 pence from George Ligget's estate on 13 May 1771 [Chester County Deed Book S, p. 440].
  - James Kinkead, watchmaker, of Christiana Bridge, New Castle County, Delaware had married Margaret Liggot, daughter of George Liggot of West Bradford Township, Chester County, Pennsylvania. The Will of George Liggot, dated 28 December 1767, notes his two daughters: Margaret, wife of James Kinkead, watchmaker, of the town of Christian, New Castle County, Pennsylvania and Rachel Davidson, relicke of John Davidson, deceased of West Bradford Township, Chester County, PA. George Liggot had left his daughters his 137 acre plantation in East Fallowfield Township, Chester County, Pennsylvania [Bryant, Carol. Abstracts of Chester County, Pennsylvania Land Records. vol. 5 (1758-1765). Westminster, MD: Family Line Publications, 1998. FHL book #974.813 R28b]. They sold this 137 acre parcel to William Peoples of East Fallowfield Township, Chester County, Pennsylvania for 170 pounds on 13 March 1792 [Chester County Deed Book W2, p. 559].
    - Rachel (Liggot) Davidson remarried and, as Rachel Gardner of Honeybrook, left "to **James, son of James Kinkead and wife Margaret**, 50 acres of land to be surveyed off the east side of my plantation" by her Will dated 29 December 1792 and proved on 1 April 1793 [Wills: Abstracts and Administrations 1713-1825: Chester Co, PA. 1 April 1793].
- I **James Kinkead**, watch and clockmaker at Christiana, nearly opposite Mr. Dunn's store continues to carry on his business in as extensive a manner as ever, and hopes to merit the favor of all those that please to employ him. He returns thanks to all those ladies and gentlemen that have favored him with their custom and gives them caution that there is another person who follows the said business at the sign of the Boot and Shoe, a little below his shop, where some watches have been carried through mistake of the messengers, which the owners intended for the said Kinkead [The Pennsylvania Packet, Philadelphia, PA, USA. 7 February 1774].
- The assessment lists for <u>Southwark</u> Township in the county of Philadelphia contain the following entries:
  - 1779, James Kinkade, tax 0.3;
  - 1780, James Kinkaid, clockm'r, valuation 1,200, tax 3.12.0.
- The 1790 census of <u>Honeybrook</u> Township, Chester County, Pennsylvania lists one **James Kinkead** with 2 free white males of 16 years and upward, 1 free white male under 16 years, and 1 free white female including heads of families [Heads of families at the first census of the United States taken in the year 1790: Pennsylvania. Baltimore: Genealogical Publishing Company, 1970].
  - James Kinkead died on 3 November 1797 as evidenced by the following inquisition. An inquisition indented taken at the house of **James Kinkead** in the township of Brandywine in the county aforesaid (Chester) before me Joseph Millard one of the Justices for said County upon the view of the body of James Kinkead than and their lying ded upon the Sollum oath and firmations, Mathew Hanley, Joseph Green, Theopelus Irwin, Samuel Cunningham, Jacob Kimbel, Robert Nesbit, Philip Williams, George Ogelsby, Leonard Punday, Joshea Buffington, Patrick Webb and James Stanley, lawfull men aforesaid in said County who being sworn & charge to inq. how & in what manor James Kincaid come by his death, do say upon their qualify cathons aforesaid do aform the night of the 3 of November 1797 that he came by his death near the House of Abraham Beaty by the visitation of God in the Township of West Nantmill in said County in Witness whereof taken of the Justis was well where of Justice as well as jury. #### i. **James Kinkead** (aft 1775 - ).

- In the Chester County tax records, under date of January 8, 1796, **James Kinkead**, a minor, of <u>Honeybrook</u> Township, is listed as the owner of two tracts of land, one of fifty acres and one of 36 acres, as well as a small log house. In the 1798 tax lists for <u>Honeybrook</u> township **James Kinkead** is again listed as the owner of 50 acres [Chester County Historical Society, West Chester, Pennsylvania. Kinkead file. Abstracted by Norman L. Kincaide and posted to Kincaid-L mailing list on 29 October 2002].
- On 8 April 1799, it is recorded that James & Joseph Kinkead, both of <u>Brandywine</u> Township, sold 50 acres to Benjamin Jones of Honeybrook Township it being the parcel of land left to James Kinkead by Rachel Gardner by her Will dated 29 December 1792 [Chester County Deed Book R2, p. 463].
  - "My father raised and equipped a company of volunteers for the War of 1812, they were not called into action, however, probably because of their remoteness from the scene of hostilities. His reputation as "bridge builder" led the city or county of Baltlimore to send for him in Ohio to supperintend the building of a large stone bridge across the Patapasco River near the city of Baltimore. My father first lived in a place called Heistertown named after some relative of my mother's. The family moved to Somerset County, Penn. where I was born. You may remember I went up to look at the place in 1891 when we were visiting you at Sewickley (near Pittsburgh). The town was originally named Smithfield but changed some years ago to Somerville, the change made, I believe, on account of a like named town close by in Fayette County. On this trip I was shown a book entitled, I believe, "The Annals of Favette County" or "the History of Fayette County." It was printed I think a good many years ago but there are doubtless some copies still extant. The copy I saw was pretty badly used up in 1891.... In the front of the book is a history of the inception and organization of the "national turnpike road" with wich my father was identified for many years very prominently. My father was engineer and contractor as long as the road was a government work, going west with it from Baltimore, Md. to Zanesville, OH, locating it first on the westward move at Smithfield, Somerset County, Penn. and lastly at Zanesville, Oh, where the youngest of the family, my brother, Charles, was born. You will understand that this "National Road" was a great work in its day and generation before railroads were and steel and iron were not--all bridges were of wood or stone; on this great highway all were built of stone. This was my father's chief business, all on the road was built by and under his supervision, from Cumberland Maryland to Zanesville, Ohio, at Smithfield, my birth place, one of the largest bridges on the road was built -about the middle of the arched structure, set in the wall is a large, square stone with the inscription, 'Jack Kinkead, R.C. Beck & Evans built in 1817' engraved upon it. His last work was a big bridge on the road which was 25 miles east of Zanesville. When I was at Smithfield (Somerville) in 1891 the bridge my father built there was perfect--not a stone displaced. If you ever get the book I spoke of you will see that the U.S. voted my father a bonus of \$15,000 for this bridge over and above the contract for it."   - Kinkead, John Henry, third state governor of Nevada (1879-83), was born at Smithfield (now known as Somerville), Somerset co., Pa., Dec. 10, 1826, son of James S. Kinkead. His father was an engineer and contractor on the old national turnpike road, following its construction from Baltimore county, Md., to Zanesville, Muskingum co., O., building all or nearly all the bridges on the line, the material used being stone. One constructed at Smithfield, on the Youghiogheny, was in as good condition a few years ago as when constructed in 1818. The family removed to Zanesville, in 1829, and thence to Lancaster, where John received his education at the high school, an institution of some repute at the time. From school he went into business, removing in

1844 to St. Louis, Mo., where he became a salesman in a large jobbing dry-goods store. In 1849 he formed a partnership with J. W. Livingston, and the young men established themselves in Salt Lake City, there building up a large trade in dry-goods. He removed to California in 1854, engaged in various pursuits and finally settled in Marysville, but two years later went back to the East and tried mercantile business in New York city. Returning to Marysville in the winter of 1856-57, he met with one reverse after another. The discovery of the great silver mines in the Washoe region, at that time a part of Utah territory, led to a large emigration from California and Mr. Kinkead was one of the many who hoped to retrieve their fortunes in a new centre of population. Making Carson City his place of residence, he was active in the movement to create the commonwealth of Nevada, and when, in 1861, the territory was formed from the western part of Utah, he was elected territorial treasurer. He was a member of the convention which framed the present constitution of the state. In 1867 he went to Alaska with the "occupancy" expedition, and witnessed the transfer of the territory to the United States. He remained there nearly three years, in business in Sitka; then returned to Nevada, engaging in mercantile, mining and milling business in Humboldt and Lander counties. In 1878 he was elected governor by the Republican party and at the end of his term was offered a re-election, but declined it. In 1884 Pres. Arthur appointed him governor of the newly created district of Alaska, but in 1885 he returned to Carson City. Gov. Kinkead was married at Marysville, Cal., Jan. 1, 1856, to Lizzie, daughter of John C. Fale [The National Cyclopaedia of American Biography: Being the History of the United States as illustrated in the lives of the founders, builders, and defenders of the Republic, and of the men and women who are doing the work and moulding the thought of the present time. Volume XI. Copyright, 1901, 1909 bt James T. White & Company. Ann Arbour, Michigan: University Microfilms A Xerox Company, 1967. Page 201].

- <u>Discussion</u>: John Henry Kinkead and Lizzie Fall had no children. They adopted a native boy from Alaska and named him Kahtz Kinkead. However, he died at a young age.
- Governor John Henry Kinkead and his wife died in Carson City, NV and are buried in Lone Mountain Cemetery, Carson City, NV. Their current gravestone contains the following vital information:

John H. Kinkead Dec. 10. 1826 - Aug. 15. 1904 Eliz. Fall Kinkead His Wife Apr. 21. 1837 - Aug. 26. 1907


This line is represented by sample 4164 of the Kincaid DNA project at Family Tree DNA (see

Sample 4164, the above noted Norman Kincaide of Colorado, is part of set 2a of the Kincaid DNA project with sample 122441 who also descends from George Kinkead (c1733- Sep 1790, m. Jean Mitchell) of Toboyne township, Cumberland County, PA and sample 377865 who descends from David Kincaid (m. Lucy Riggins McCormick). This set is upstream of the New Brunswick, Canada Kincaids in set 3a. The two sets likely share a common ancestry in Ireland.

- <u>Discussion</u>: George Kincade's known children were Andrew Kinkead (c1755 1821) of Derry township, Westmoreland County, Pennsylvania; John Kinkead (c1756 1822) of Union township, Westmoreland County, Pennsylvania; and Mary Kinkead (c1760 ) of Westmoreland County, Pennsylvania. He was also survived by nephews Archibald Kinkead (1750 1826) of Bath County, Kentucky; and Andrew Kinkead (c1756 1826) of Greene County, Illinois.
- 1754 **George Kinkead**, freeman, taxed in Martic Township, Lancaster County, PA. Lancaster County Historical Society, Lancaster, PA, proving that he was born about 1733 if he was 21 years old in 1754.
- 1756 **George Kinkead** is taxed as a married man proving that he married between 1755-1756.
- 1761 **George Kinkead** is taxed in Middleton Township, Cumberland County, Pennsylvania and is missing from Martic Township, Lancaster County, Pennsylvania, proving that he moved from Lancaster County to Cumberland County, PA between 1760-1761, listed as adjacent land owner to Robert McCurdy in Lancaster County in 1760. - George Kinkead, Middleton Township, Cumberland County, PA purchased 197 acres along Sherman's Creek, Toboyne Township, Cumberland County, PA from Thomas French, Hanover Township, Lancaster County, PA for 120 pounds, September 6, 1769. Cumberland County, PA, Court House, Pennsylvania State Archives, Kinkead, Armstrong, Hollenback Collection, M158, proving that George Kinkead purchased property in Sherman's Valley, Toboyne Township, Cumberland County, Pennsylvania.
- **George Kinkead** taxed in Toboyne Township, Cumberland County, Pennsylvania, not taxed in Middleton Township, proving that he moved to his property in Toboyne Township
- The last Will & Testament of George Kinkade, Deceased. In the name of God Amen August thirtieth in the Year of our Lord God one thousand seven hundred and ninety. I George Kincade of Cumberland County Township of Tyboin in the state of Pennsylvania Being weak in Body but sound in mind and memory do make and ordain this my last will and Testament Principly and first of all I Recommend my soul to God who give it and my body to the earth Buried in a Christian like manner at the Discretion of my Executors and as having such Worldly Estate as it has pleased God to bless me with in this life I give devise the Same in the manner and form following. Item I give and bequeath to my loving Wife Jean all my household furniture and one cow and one horse ????? She shall ???? also her Saddle and the benefits of the half of my land during her life and five pounds of money all which I give to my loving wife Item I give and bequeath to my loving Sons Andrew and John all my land to be Equally divided between them their Heirs and assigns forever also I give to each of their old Sons five pounds also I bequeath to loving Son Andrew my Saddle and Bridle. Item I give and bequeath to loving son Mathew McClaren all my stock of Horses, Cows, Hogs and Sheep with my wagon and gears and farming Utensils. Also I give to my loving **Daughter Mary** fifteen pounds N.B.S. Except the horse and cow my loving Wife shall ????? of. Item I give and bequeath to my loving Wife the remainder of my money if any there be after paying the above Legacies. #### **Ballybegley**



The parish of Taughboyne formerly included townlands in what is now the Parish of All Saints. All Saints Parish sits above present Taughboyne Parish. Ballybegly Begg & Ballybegley Little townlands currently lie in the parish of All Saints and are on the lower corner of the northwest border which fronts on Lough Swilly. A couple of townlands to the northeast on Lough Swilly is Drumboy, All Saints Parish. Immediately northeast of Ballybegly Begg is Moneygreggan. Immediately southwest of Ballybegly Little on Lough Swilly is Ballylawn (aka Ballylan and originally Ballyneagh and Boylelawny).

Ballybegley is quite likely a seed townland for a number of subsequent Kincaid lines in Taughboyne parish, County Donegal and Donaghedy parish, County Tryone. The earliest known Kincaids in Ballybegly were John, Robert and Samuel Kinkead who had a lease of lands there in 1730. The latter two held land with one William Parks. Online genealogies have William Park of Ballybegley (1675 – 1750) marrying Jane Hood and his brother **Arthur Parke** marrying **Mary Esther Jack**, daughter of **William Jack** and **Esther Todd**, before emigrating to West Fallowfield, Chester County, Pennsylvania (see https://www.familysearch.org/tree/person/details/GHG5-HBL).

Samuel Kinkead sold his interest in 1741 and could be the Samuel Kinkead who shows up in Windham, New Hampshire. There is no further trace of him in County Donegal. He was old enough to be an elder in the Windham church when the call was put out to Rev. John Kinkead of Chester County, Pennsylvania to go there. Perhaps the above noted John Kinkead of Ballybegly was this Rev. John Kinkead. As noted above the Parks family was certainly associated with Chester County, Pennsylvania.

The Jacks are a pivotal connecting family. Sometime before 21 November 1697, **John Jack of Lisnaragh**, Donaghedy parish had married **Mary Kincaid** - as on this date they had a son Samuel baptized. Also in Ballybegley was the family of Archibald Alexander who died there on 31 March 1689. His wife, Elizabeth Mackey died there on 30 January 1715 at the age of 78. Archibald's eldest son, **Joseph Alexander**, married **Margaret Jack of Brookhall, Templemore parish** on 17 November 1686. Their eldest son, James Alexander married **Jane Scott** and had Elizabeth who married John Alexander, son of James Alexander of Gortmessan, Donaghedy parish, County Tyrone. Other descendants of Archibald Alexander of Ballybegley, ended up in the townlands of Drumenan (south side of Castletown & west side of Whitehill) and Kinnakally (south side of Clashygowan & north side of Castletown) in Taughboyne parish, County Donegal as well as in Altrest and Donemana in Donaghedy parish, County Tyrone. The Scotts also tie into Brookhall and are connected to the Hamiltons and McIlwaines. William Scott of Hornhead Castle married Frances Stewart (daughter or sister of Capt. Charles Stewart and Anne Hamilton, d/o Gustavus Hamilton and Elizabeth Brooke). Gustavus Hamilton was the nephew of James, 1<sup>st</sup> earl of Abercorn, Charles

Hamilton of Shawfield who had a castle on his lands near Donemana, Donagheady parish, County Tyrone, and George Hamilton of Greenlaw who built Derrywoone castle on Island McHugh, Barons Courty, County Tyrone. William Scott's daughter, Margaret Scott, married firstly Thomas Anderson and had Frances Anderson who married Samuel Dysart (c1710-1750) of Brook Hall. Margaret Scott married secondly John McIlwaine and had Elizabeth McIlwaine (c1732-19 Dec 1793) who married Rev. Joseph Rhea.

Brookhall places a key role as well. The estate lies between Boom Hall (south) and Thorn Hill (north) on the River Foyle along the road to Muff (Culmore Rd). It was part of Ballynashallog which is on the east side of Shatallow and Ballyarnet. On 27 September 1746 Andrew Makilvaine of Londonderry executed an instrument binding his 14 acres farm about Brookhall as part of a marriage contract with his soon to be second wife **Lucey Noble** of Derrygree, County Fermanagh. The farm was part of a lease from George Gregory and **Rebecka Houston** dated 2 November 1739. The family names of Noble, McIlwaine, Houston and Alexander tie into an interesting pattern between Kincaids and the sheriffs of Londonderry. The said Andrew McIlwaine of Londonderry, who married Lucy Noble, was a sheriff of Londonderry in 1721, 1727, 1734 and 1740. One William Noble had been sheriff of Londonderry in 1670 and several Houstons held that position starting with Robert Houston who was sheriff of Londonderry in 1675. He was followed by descendants Robert Houston who was sheriff of Londonderry in 1710, and 1729; Edward Houston who was sheriff of Londonderry in 1730; and Robert Houston was sheriff of Londonderry in 1756. The above noted Rebecka Houston was the widow of said Edward Houston. Compare this with the sequence of Kincaid marriages:

- **John Kinkead** and his wife **Jane Noble**, conveyed their lease of part of the lands of Ballynahery, Drumachose Parish to one **Robert Scott** on 10 April 1732 [Northern Ireland. Registry of Deeds. Kinkead et ux to Scott, no. 62733, book 89, page 178].
- **John Kinkead** and **Elizabeth McIlwaine** obtained a a marriage licence bond for their marriage in 1734 [Index to Raphoe Marriage Licence Bonds, 1710-1755 and 1817-1830. Transcribed by Rosemary ffolliott. Dublin: The Irish Ancestor, 1969. Published as a free supplement to The Irish Ancestor. 8].
- **John Kincade** and **Jane Houston's** marriage was solemnized at St. Columb's Church of Ireland Cathedral in Londonderry on 3 June 1782 by Rev. Pitt Kennedy.
- On 27 April 1775, William Leckey Esq., **Rebecca Houston, widow, Robert Houston, merchant, and Sarah Houston, spinster**, conveyed to **James Alexander Esq.** their leasehold interest in land near the City of Londonderry for consideration of £669.14.1½. and rent of £6.3.2½ [Public Record Office of Northern Ireland (PRONI), Belfast, Northern Ireland. D2433/A/1/46/4].
- On 10 May 1775, William Leckey of the City of Londonderry, Esquire, **Rebecca Houston** of the City of Londonderry, widow, and **Robert Houston** of the City of Londonderry, merchant, and **Sarah Houston**, spinster, **the only children of the said Rebecca Houston**, conveyed to **James Alexander of the City of Londonderry, Esquire**, "All that and those two undivided third part of twenty seven acres of Land Marked in the map of the acres No. 4 bounded on the North East by the road leading to Muff on the North by the acres No. 10, on the South West by the acres No. 3, on the South East by the River Loughfoyle and on the North East by the acres No. 11 and lie about one Mile and a half distant from Derry." Deed and Memorial witnessed by Eneas Murray of the City of Londonderry, notary public, and Patrick Dwyer, of the City of Londonderry, writing clerk [Northern Ireland. Registry of Deeds. Volume 307, page 393, no. 204717; registered 7 June 1775. https://www.familysearch.org/ark:/61903/3:1:3Q9M-CSJW-J9X2-G? i=204&cat=1857201.
- **William Kinkad** was recorded in the 1783 cess lists for <u>Ballynashallog</u>, Templemore Parish, County Londonderry {Ballynashallog was previously held by the above noted Andrew McIlwaine and contained Brookhall} [PRONI, MIC1/19/1. Parish of Templemore, Diocese Derry, Co. Londonderry: List of Cesspayers, 1775-1784].

One last point is that one of the witnesses to the Kinkeads 1730 Ballybegley deed was Moses Haslett. He may have been the ancestor of the Hasletts of Whitehill, Taughboyne parish, County Donegal and Sandville/Drumgauty, Donaghedy parish, County Tyrone. The latter got into a losing feud with the Earl of Abercorn and ended up losing their lands and eventually ending up at Woodhill, County Donegal in the 1820s (Along the River Foyle, p. 87).

Discussion: Stewarts Court is the estate about Ballylawn Castle, Moville Upper parish, County Donegal. The castle was the seat of the Stewart's of Stewart's Court Manor. Thomas Stewart married Mary Ward, daugther of Bernard Ward, of which the line of Viscount Bangor sprung. Thomas Stewart died without surviving issue and was succeeded by Alexander Stewart, M.P. for the City of Londonderry who married Mary Cowan, daughter of John Cowan, Esq. of Londonderry.

- Stewart of Londonderry.// The branch of the noble house of Stewart, to which the Marquess of Londonderry belongs, claims descent from Sir Thomas Stewart, of Minto, second son of Sir William Stewart, of Garlies, ancestor to the Earl of Galloway. William Stewart, Esq., of Ballylawn Castle, in the county of Donegal (great-grandson of John Stewart, Esq., who had a grant from Charles I. of the manor of Stewart's Court, where he erected the Castle of Ballylawn), took an active part in the contest between James and William, in Ireland, and held the rank of Lieutenant-Colonel in the regiment commanded by his wife's kinsman, Sir William Stewart, Viscount Mountjoy. Colonel Stewart married the daughter of Sir William Stewart, of Fort Stewart, in the county of Donegal. His eldest son and heir, Thomas, who succeeded him at Ballylawn Castle, served as a Captain in Lord Mountjoy's regiment. He married Mary, second daughter of Bernard Ward, Esq., (ancestor of the Viscounts Bangor), by Mary, sister of Michael Ward Bishop of Derry, but dying without issue, in 1740, was succeeded by his only brother, **Alexander**, who represented the city of Londonderry in parliament, and purchased the estate of Mount Stuart, in the county of Down, from the Colville family. He married his cousin, Mary, only daughter of John Cowan, of Londonderry, Esq., (by Anne Stewart, second daughter of Alexander Stewart, of Ballylawn Castle), and sister and sole heiress of Robert Cowan, Governor of **Bombay**. By that lady, who survived him seven years, and died in 1788, he had issue :-- 1. Robert, first Marquess of Londonderry... Archibald Alexander is, in the Subsidy Roll for 1661, of the parish of Taghboyne, county Donegal, assessed for property to the value of £13, 15s. He is, in the Hearth Tax Roll of the same parish for 1662, styled "Archibald Alexander of Ballybiglemore." He was probably a son of John Alexander of Eredy, and brother of Robert Alexander of Meyboy, and afterwards of Drumquin. As a lay elder he represented the Presbyterian congregation of Taghboyne in the Presbytery of Laggan, from 1672 to 1681 (Presbytery Records). In the burial-ground at Balleighan, in Taghboyne parish, his tombstone is thus inscribed: "Here lyeth the body of Archibald Alexander, who deceased the 31st March, anno 1689." Having died intestate, his wife obtained "letters" for the administration of his affairs (Original in General Probate Office). She died in 1715, and is on her husband's tombstone thus commemorated: "Here lyeth the body of Elizabeth Mackey, wife of Archibald Alexander, who departed this life 30th January 1715, aged 78 years."// James Alexander, a younger son of Archibald Alexander, farmed a portion of the lands of Ballybigley, and died there on the 28th May 1743, aged seventy-five. His wife, Elizabeth Paterson, died 3d July 1740, aged sixty (Tombstone Inscription at Balleighan).// Joseph Alexander, eldest son of Archibald Alexander, married Margaret Jack. His marriage licence is, in the Diocesan Registry of Londonderry, entered thus: "November 17, 1686. — Licentia ad solem. matrimonii inter Josephum Alexander de Ballybiglemore

He had married Elizabeth Paterson, and in his will, dated 26th October 1763, he names four sons, James, Samuel, William, and Joseph, and a daughter, Sarah (Will in Probate Court). **James, the eldest son, married Jane,** 

daughter of Alexander Scott, by whom he had four sons, Joseph, Nathaniel, John, and Robert, and four daughters. Two of the daughters are unmarried, and, with their sister, a widow, reside at Ballybigley. Elizabeth, the remaining daughter, married John Alexander, son of James Alexander, farmer, Gortmesson, county Tyrone, and had issue, seven sons and one daughter. James, eldest son of the eldest daughter, is now farmer at Drumenon, Taghboyne parish; he is married and has issue, one daughter. Joseph, second son of John and Elizabeth Alexander, is farmer at Imlich, county Donegal.// Joseph, eldest son of James Alexander of Ballybigley, died unmarried. Nathaniel, the second son, emigrated to St John, New Brunswick. He married and had sons and daughters. His only surviving son is Charles Crawford Alexander.// John, third son of James Alexander of Ballybigley, died without issue. Robert, the fourth son, proceeded to the West Indies, and there died without issue.// Samuel, second son of Joseph Alexander of Ballybigley, died in 1767. He had a son, James, and a daughter, Elizabeth. James Alexander was bankagent at Omagh; his remains are deposited in the parish churchyard of Cappagh, county Tyrone. Elizabeth Alexander resides at Rathmullen, county Donegal.// John Alexander, printer, Strabane, county Tyrone, was descended from the families of Ballybigley and Crew. He died in 1801. In his will, executed 18th November 1798, he names his sons, John and Joseph.// Descendants of Archibald Alexander of Ballybigley settled at Londonderry. Robert Alexander of Bishop Street, Londonderry, who died in 1822, names in his will his sons, James and Samuel, and his daughters, Hannah and Elizabeth. James Alexander of Foyle Street, Londonderry, whose will was proved on the 3d November 1831, made bequests to his sons, John and James, and his daughters, Mary, Jane, Eleanor, and Elizabeth (Wills in Probate Court).// Also descended from Archibald Alexander of Ballybigley is the family of Alexander at Kinnekally, parish of Taghboyne. John Alexander, farmer at Kinnekally, died on the 7th October 1724. He married, first, Magdalene Kilgour, who died in July 1709 (Tombstone Inscription); and secondly, Mary. In his will, dated 26th March 1720, he names his sons, Robert, Joseph, and John. He also had a son Jacob. "Mr Thomas Alexander" is named as one of his executors (Will in Probate Court).// John Alexander, son of John Alexander, farmer at Kinnekally, died in 1785, aged seventy nine. In his will, dated 1st October 1771, he names a son, James, and a daughter, Mary, married to John Gregg.// James Alexander, son of John Alexander at Kinnekally, died in 1829, aged eighty five. His son James, who died in 1836 (Tombstone Inscription), left a son, John, who is now farmer at Drumbarnet, near Newton Cuninghame, county Donegal.// James Alexander, brother of John Alexander, farmer at Kinnekally, rented the farm of Altrest, in the parish of Donagheady. He had a son, William, and a grandson, James, whose son, Robert, is now farmer at Altrest.// Archibald Alexander, descended from Archibald Alexander of Ballybigley, settled at Ratteen, in the parish of Taghboyne. He married, and had a son, Andrew, who purchased the small estate of Crew, parish of Ardstraw, county Tyrone. He married Fanny Lockhart, by whom he had six sons, William, Samuel, Hugh, Joseph, Andrew, and Thomas. His tombstone in Ardstraw parish churchyard is thus inscribed: "Here lyeth the body of Andrew Alexander, who departed this life March the 5th, 1779, aged 73 years."// William, second son of Andrew Alexander of Crew, married, and had one daughter. Samuel, the third son, married, and had three sons and one daughter. David, one of the sons, now resides at Taghboyne. Hugh, fourth son of Andrew Alexander, proceeded to the parish of Donagheady, and there purchased land. One of his sons now resides at Donemana, in Donagheady parish.// **Andrew, fifth son of Andrew Alexander**, purchased land at Donemana where his son resides now. Thomas, sixth son, emigrated to America ... [Alexander, Recv. Charles. Memorials of the Earl of Stirling and of the House of Alexander. Edinburgh: William Paterson, 1877. Volume II, p. 88-921.

<u>Discussion</u>: Kinnekally is in the upper middle part of the parish and is on the south side of Clashygowan townland.



#### Ardagh & Clashygowan, Taughboyne parish






John Kinkead of Ardagh, Taughboyne parish, County Donegal is still a bit of a mystery. He was living in that townland some significant time before 3 October 1769. On the latter date he was trying to buy Robert Glendenning/Clendenning's farm in Clashygowan. Moses McCrea of Balilenan (Ballylennan) seems to have beat him to it. However, neighbours protested as they preferred John Kinkead. John Kinkead seems to have been a well liked man and, later, on 15 November 1772, even the Earl of Abercorn's agent thought well of him. He then wrote of him: "I think Kinkead a very quiet well behaved man, and I am told he is in good circumstances." Moses McCrea won out though.

Moses McCrea died in October 1772 and by the 15th of the next month his widow had bargained with one John Hemphill for McCrea's farm in Clashygowan. However, John Hemphill decided not to keep it and on 22 January 1773 John Kinkead of Ardagh was again bargaining for it. He agreed to sell his land in Ardagh to John Stinson (a.k.a. Stevenson) who was his neighbour there. He clearly was successful as the next notice of Kincaids in either place was the Earl of Abercorn's 1781 survey of the townlands. Recorded in No. II Clashygowan was John & James Kinkead. There is no reference to Kincaids in Ardagh in 1781. Clearly the 1781 John Kinkead of Clashygowan was the 1773 John Kinkead of Ardagh or his son. The 1781 James Kinkead of Clashygowan was most likey the son of the 1773 John Kinkead of Ardagh and perhaps brother of the 1781 John Kinkead of Clashygowan.

Later, Robert White of No. VI Clashygowan had a son David White who was to later marry Elizabeth Kincaid. They became the ancestors of Heather Sushames of Davistown, Australia (Gedmatch A858134). She has records linking her Elizabeth Kincaid to the Kincaids of Ballyholly.





John Kinkead of Ardagh and Clashygowan, Taughboyne Parish, County Donegal (bef 1748 - ).

- Discussion: Ardagh is on the west central side of Taughboyne Parish on the border with Raymoghy Parish. It is bounded on its northern side by Dooish townland, Raymoghy Parish and on its western side by Lismoghry townland, Raymoghy Parish.
- <u>Discussion</u>: Clashygowan is in the central northern part of the Parish. It is two townlands northwest of Saint Johnstown and three townlands east of Ardagh townland.
- "Robert Clendening first made an agreement with Moses McCrea of Balilenan for his farm in <u>Clashigowan</u>, but upon finding some of the neighbours objecting to McCrea's comeing, he afterwards agreed with **John Kinkead of Ardagh**, who the neighbours like better, not that I beleive he was to get more of it; neither will give up without your Lordships determination" [PRONI. D623/A/38/163 & T2541/IA/1/8/159. Letter from James Hamilton, Strabane, to the Earl of Abercorn dated 3 October 1769].
- 22 October 1769. James Hamilton, Strabane, to the Earl of Abercorn... Nothing is yet done in the seal of Robert Clendenings farm in Clashigowan; Moses McCrea did certainly first agree for it, and the reason Robert gives for his afterwards selling it to another is, that he had got no earnest (which they generaly consider as necessary, for the binding of a bargain) that some other person had before bought it, and ten days afterwards gave it up; beside that the neighbours objected to McCrea, and were desireous **of Kinkead**; I am induced to think these were the motives, as I find **Kinkead** was not to pay more for it, neither this nor Thomas Mackeys bargin for Tillywhisker, will be determined, till your Lordship's pleasure is known [PRONI. D623/A/38/167 & T2541/IA/1/8/163].
- Mosess McCrea of Clashigowan's widow has bargined with one John Hemphill for her farm. Hemphill is a man of good character and good substance as I am told. **John Kinkead of Ardagh** thinks he has a fair claim to it. He tells me it was sett up to be bid for at auction, and that it was to continue up but for ten minutes and that his offer was the last within that time. I realey think Kinkead a very quiet well behaved man, and I am told he is in good circumstances. The parties are anxious to know your Lordship's determination, as whoever gets, will want to dispose of the farm he now has [PRONI. D623/A/40/70 & T2541/IA/1/10/66. Letter from James Hamilton, Strabane, to the Earl of Abercorn, dated 15 November 1772].
- Hemphill who bought from Mosess McCrea's widow her farm in <u>Clashigowan</u>, will not keep it. **John Kinkead** who pays £3 9s. 5 1/2d. in <u>Ardagh</u> has bargined for it, and says that John Stinson who holds as much joining his in Ardagh will buy his part there. They are both good tenants [PRONI. D623/A/40/76 & T2541/IA/1/10/72. Letter from James Hamilton, Strabane, to the Earl of Abercorn dated 22 January 1773].

James Kinkead of Clashygowan, Taughboyne Parish, County Donegal (bef 1760 - ).

Discussion: See John Kinkead of Ardagh above. It appears that James Kinkead was either the son of John Kinkead of Ardagh (later of Clashygowan) or his brother.

Robert Kinkead in Ardagh, Taughboyne Parish, County Donegal (bef 1799 - ).

- The Tithe Composition Applotment Books for County Donegal record that on 3 July 1820 **Robt Kincaide** held 49 acres 6 perches of land assessed for a tithe of £3/6/0 in <u>Ardagh Townland</u>, Taughboyne Parish [Provincial Archives of New Brunswick. MC2081 Tithe Composition Applotment Books, Co. Donegal. Tab 7/32, p. 3, #18. microfilm #F14462].
  - Discussion: The Rent Account Books for the Earl of Abercorn Tyrone and Donegal Estates (1811-1831) gives an account for lands in <u>Ardagh</u> townland starting on 19 February 1811 with And[re]w McClintock as the tenant. His holding was taken over by Ja[me]s Kilpatrick from November 1817. Then **Rob[er]t Kinkead** takes over the holding on 25 November 1823 and pays £14/11/0 twice a year. Another account for lands in Ardagh townland starts on 4 January 1811 with John McClintock as the tenant. A note in the left column indicates that **Robert Kinkead** took this over in 9 February 1819 paying £25/0/6 twice a year. This changes to £15/15/0 twice a year starting in November 1822 and changes again to £30/6/0 starting in November 1829 [Public Record Office of Northern Ireland. D623/C/4/9].
    - I went on Thursday and dispossessed William Hazlett of Whitehill, John Allen of Craigadoois, Robert and Thomas Vance of Momien and Andrew McClintock of Ardagh, for non-payment of rent... McClintock's creditors are to be in to bid for his land [Public Record Office of Northern Ireland. D623/A/130/12. Letter from Sir John James Burgoyne of Strabane to the Marquess of Abercorn, at London, dated 24 February 1817].
- Sir Richard Griffith's Valuation of Ireland for Taughboyne Parish, County Donegal in 1857 records **Catherine Kincaid** as a tenant of John Dougllas for a house with garden 15 perches valued as £0/15/0 at map reference 8 c in <u>Ardagh</u> townland.
  - Discussion: John Douglas (8a) held 88/0/20 acres of the Marquis of Abercorn with cottars George Murray (8b), Catherine Kincaid (8c), James Moore (8d), and Daniel Barnett (8e). Also in the townland were Samuel Stevenson (1a) holding 170/2/15 acres of the Marquis of Abercorn with William Culbert (1b), and unoccupied house (1c), William Abraham (1d), James Coyle (1e), and John Magee (1f) as cottars; John Wright (2a) holding 61/0/25 acres of the Marquis of Abercorn with Thomas Park (2b) as a cottar; John Coyle (3) holding 77/1/20 acres of the Marquis of Abercorn; Andrew Rolleston (4a) holding 123/1/30 acres of the Marquis of Abercorn with Samuel Peebles (4b), Hugh Toland (4c), John M'Clintock (4d), Catherine Brodie (4e) as cottars and an unoccupied house (4f); Martha Campbell (5a) holding 53/1/0 acres of the Marquis of Abercorn with Anne Brogan (5b) as cottar and a school house (5c); Daniel M'Clintock (6) holding 11/0/35 acres of Andrew Rolleston; Daniel Gallagher (7) holding 56/2/25 acres of the Marquis of Abercorn with Patrick Nelis (9b) as cottar; John M'Adoo (10) holding 35/1/10 acres of the Marquis of Abercorn; Margaret Gamble (11A, 11Ba, 12c) holding 8/2/15, 10/0/5, and 0/0/30 of the Marquis of Abercorn

James Kincaid of Ballycushion (formerly of Cross and Ardagh townlands, Taughboyne Parish, County Donegal (c1851 - 1919).

- On 6 January 1881, **James Kincaid**, a full age bachelor labourer of <u>Cross</u>, son of **James Kincaid**, labourer, was married to <u>Mary Jane Nesbitt</u>, a full age spinster of Ardagh, daughter of James Nesbitt, labourer at the parish church, Taughboyne Parish, County Donegal according to Rites and Ceremonies of the Church of Ireland by license by John Malloy. The witnesses were Richard Devenny and Isabella Nesbitt. He signed James Kinkaid and Mary Jane gave her mark [Ireland. Civil Registrations of Marriages. Londonderry District, 1881, no. 39, vol. \_\_\_, p. 219].
  - Discussion: Cross is on the east side of Ballycushion townland and north side of Kilgort townland which is on the north side of Clashygowan townland. Clashygowan townland is two townlands east of Ardagh townland.

### Legnatraw, Ballylennon & Lettergull, Taughboyne parish

\_\_\_\_\_\_\_





Legnatraw townland is in the middle of the parish and a tad south of its center. Legnatraw is only about 5km (3.15 miles) west/northwest of Magherareagh townland, Donagheady parish, County Tyrone and about 9 miles southwest of the City of Londonderry. There is no evidence of Kincaids in Legnathraw before 1854. To the west of Legnatraw is the townland of Treansallagh (which itself is on the south side of Treantagh), Taughboyne parish where there was a Kincaid in 1850. On its north is Mongavlin and Castletown, then Kinnacally and then Clashygowan where there were Kincaids from Ardagh in the 1780s. Southwest of Legnathraw is Lettergull; on its east Burnthaw and Drumenan, and on its south Binnion and Ballylennan.


Perhaps the main connecting feature of Legnathraw is that, as noted above, the Kincaids of Ballyholey were married into the Hamiltons of Gortaquiqley and close relations/friends with the Porters of Legnathraw as well as the Cunninghams of Castleton, the Alexanders of Drumenan, and the Rankins of Altaskin – all closeby. Robert Kincaid of Legnathraw was actually a tenant of Alexander Porter of Legnathraw. Alexander Porter, son of Joseph Porter, was successor to Hugh Stephenson [http://census.nationalarchives.ie/reels/vob/IRE\_CENSUS\_1821-

51\_007246881\_00069.pdf] whose youngest daughter he married on 18 February 1853 [Swindley, Len. Porter Family Notes, Co. Donegal 1829-70. https://cotyroneireland.com/surnames/porter.html]. Joseph Porter was of Ballymoney, Burt parish which just north of Drumboy, Taughboyne parish — being only separated by the townland of Blanket Nook. There were perhaps Porter connections in Leckpatrick parish as well, with two James Porter and a William Porter each holding land there in the 1826 Tithe Applotment Books.

Matthew Haslett married Sarah McCrea daughter of Walter McCrea who operated the mill at Drumgauty. Her uncles were Robert McCrea of Leckpatrick townland who married Ann Jack of Lisnarrow, John McCrea of Magheraragh who married Mary Clarke of Grange; and James McCrea of Farmhill who married firstly Jane McCrea of Binnelly. Another son of William Hazlet, James, became a minister and lived at Creaghan Glebe while he was curate of St. Michaels Church of Ireland in Bunowen. Moving southwards along the Foyle there are two townlands separating Mongavlin and Porthall, Clonleigh parish of which the latter was home to William Gamble, son of Joseph Gamble of Eden, Donaghedy parish. Eden was the townland on the east side of Magheraragh. Porthall is opposite Drumenny Big townland, Donaghedy parish while Mongavlin is opposite Grangefoyle townland, Donaghedy parish.

Hazlett Long shares 46 cM of shared dna with the longest block being 10 cM. The suggested relationship is 4th cousin + (see below for further details).

According to Hazlett Long's daughter, Glenda Bruce, Ann Kincaid married William Long on 3 November 1887. Hazlett also has in common with Joseph Wiliam Kincaid and John Robert Kincade, descended from William Kincade of Adelaide township, Middlesex County, Ontario, Canada - who is a proven close Y-dna relative of the Kincaids of the Province of New Brunswick in Canada. His first wife died in 1940 and he is survived by his second wife Sara and two sons, Mr. John Kincaid who lives in Australia and Major William James Kincaid, Northampton, England. He is also survived by two sisters, Sarah and Margaret, both of whom lived in England.

When Sara was aged 23, she met a young soldier, Arthur, who was serving in the British Army at Eglington Barracks in Londonderry. They fell in love and married in the Waterside Presbyterian church on the 8th June, 1922. Sara never knew her correct age as she could never find a birth certificate, she thought she was in 1901, two years younger than she was. Their first child was born on the 16th. Sept. 1922, a girl, Emily. Some time after this they moved to Parkstone, England where Arthur came from and they left Emily behind with her grandmother. The reason for this is unclear, maybe they thought that they could not support her until they had settled in. What ever reason Emily stayed there until the 1939/45 war. After about a year the Battle of Britain was in full swing and Parkstone was getting bombed, so Sara decided to move the family back to Ireland. They moved in with her mother in Alfred St, Londonderry and that was the first time that the children met Emily. Also living there was Maude, Sara's step sister. They were there for a little while and then they moved to Portstewart which is a seaside resort. It appears that her brother was a district councilor there and he found a job with accomodation for her. The job was cook for a YWCA boarding house and there was plenty of room for all the children and herself. This carried on right through the war with the children going to school in Portstewart and a couple became old enough to start work. In 1946 Arthur came back from the war and they all, except the oldest boy, who had joined the army, moved back to England. They moved in with Arthur's sister in Old Wareham Rd. for a while, then the local council gave them a council house in Rossmore Road, Parkstone. Sara stayed in this house until the children had all left and her husband died in 1963. She moved to a smaller house and outlived her husband by nearly twenty two years and filled her life with

her church and her grandchildren. She was laid to rest beside her husband in March 1985 and was survived by her seven children, eighteen grandchildren and two great granddaughters. She is buried at Branksome Cemetery at Number 137 Section Z.

- Discussion: It is not certain if he is the following Alexander Kincaid of Troy, New York, but the latter certainly fits.

William Kincaid of St. Johnston town, Taughboyne Parish, County Donegal (c1858 - ).

- A case of Assault and Robbery is reported from the town of St. Johnston. Two men, John Kelly, of Altasker, and Joseph Blee, of St. Johnston, have been arrested, as also Charles Sharkey and William Kincaid. The following information was taken before Mr. R. M'Clintock, J.P., viz.:--The information of Thomas Canaghan, of Drumstoland, were to the following effect:--On the night of the 28th September, between the hours of eleven and twelve o'clock I was in the town of St. Johnston. Five men came up to me and caught hold of me. One of them said he was the sergeant, and would take me to the barracks. This man was Kelly (one of the prisoners). They then threw me on the broad of my back. There were present-Joseph Blee, Charles Sharkey, and William Kincaid, with Kelly. They beat me with stones. I had £11 and seven shillings on me. Kelly held me, and the others took the money out of my pocket. No money was got on the prisoners, who were then remanded till next Raphoe Petty Sessions. His Worship took bail for their appearance. The arrests were made by Constable James Moore, Sub-Constables Smith and Lyons [Derry Journal, Friday, 1 October 1880, page 8, column 5].
- On 8 June 1886, **William Kinkaid**, a full age bachelor carman of <u>St. Johnston</u>, son of **William Kinkaid**, farmer, was married to <u>Martha Roulston</u>, a 19 year old spinster of St. Johnston, daughter of Andrew Roulston, farmer, at the Parish Church, Taughboyne Parish, County Donegal according to the Rites and Ceremonies of the Church of Ireland by licence by Robert B. Rankin. The witnesses were James Roulston and Annie Bell [Ireland. Civil Registrations of Marriages. Londonderry District, 1886, vol. \_\_\_, p. 143, no. 50].
