INDEPENDENT ENTITY

An entity having a public purpose relating to the state or its citizens that is individually created by the state or is given by the state the right to exist and conduct its affairs as an independent state agency or independent corporation. (Utah Code §63E-1-102)

INDEPENDENT STATE AGENCY

An entity created by the state, but which is independent of the governor's direct supervisory control.

- School and Institutional Trust Fund Office
- School and Institutional Trust Lands
 Administration
- Utah State Railroad Museum Authority

- Utah Beef Council
- Utah Communications Authority
- Utah Dairy Commission

PUBLIC CORPORATION

An artificial person, public in ownership, individually created by the state as a body politic and corporate for the administration of a public purpose relating to the state or its citizens.

- Utah State Fair Corporation

QUASI-PUBLIC CORPORATION

An artificial person, private in ownership, individually created as a corporation by the state, which has accepted from the state the grant of a franchise or contract involving the performance of a public purpose relating to the state or its citizens.

CREATION OF INDEPENDENT ENTITIES

- 1. A government requestor proposes that the Legislature create a new independent entity (Utah Code §63E-1-302(1)).
- 2. The committee schedules a meeting to review the proposal (Utah Code §63E-1-302(2)(a)).
- 3. The committee may request relevant information from executive and legislative branch entities (Utah Code §63E-1-302(2)(b)).
- 4. After review of the proposal, the committee makes a report to the Legislature stating whether the committee recommends creation of the new entity (Utah Code §63E-1-303).

PRIVATIZATION OF INDEPENDENT ENTITIES

- 1. An independent entity seeking to privatize submits a request to the Legislature (Utah Code §63E-1-403(1)(a)).
- 2. The independent entity is audited by the state auditor within one year prior to the proposed effective repeal date (Utah Code §63E-1-403(1)(b)).
- 3. The relationship between the state and an independent entity may not be terminated except by repeal of the authorizing statute of the independent entity (Utah Code §63E-1-403(2)).

PURPOSE:

Operate and maintain a scenic and historic railroad in and around Heber Valley (Utah Code §63H-4-106).

STATE INVOLVEMENT:

The authorizing statute provides that the agency does not have the authority to incur liability on behalf of the state (Utah Code §63H-4-107).

STATE SERVICES USED:

- May participate in the state's Risk Management Fund
- Utah Retirement Systems(Non-Contributory Plan)

HISTORY & ORIGIN:

The Heber Valley Historic Railroad's history began in 1899, when trains served the pioneers who first settled the valley. In the early 1970s, the railroad became the "Heber Creeper," a tourist passenger train operating on a seasonal basis. It now operates as a nonprofit organization focused on tourism, education, and the restoration of historical railroad equipment.

The authority was initially created as an independent state agency by statute in 1992. The creating statute was repealed in 2009, but reenacted in 2010 (Utah Code Annotated §63H-4-102).

REPORTING REQUIREMENTS:

The authority is subject to audit by the state auditor pursuant to Title 67, Chapter 3, Auditor, and by the legislative auditor general pursuant to Section 36-12-15 (Utah Code §63H-4-108(3)).

The authority is subject to requirements related to the Utah Public Finance Website. (See Utah Code §63H-4-108(2) and §67-3-12.)

EXEMPTIONS:

Exempt from the following statutes (Utah Code §63H-4-108 and §63H-4-111):

- Funds Consolidation Act (Title 51, Ch. 5)
- Utah Government Operations Code (Title 63A), but is subject to provisions related to the Utah Public Finance Website
- Budgetary Procedures Act (Title 63J, Ch. 1)
- Utah State Personnel Management Act (Title 63A, Ch. 17)
- Sales and Use Tax Act (Title 59, Ch. 12)

The board has eight total members (Utah Code §63H-4-102):

- one member for the county legislative body of Wasatch County;
- the mayor of Heber City;
- the mayor of Midway;
- executive director of the Department of Transportation, or the director's designee;
- executive director of the Division of State Parks, or the director's designee; and
- three public members appointed by the governor:
 - o one representative each from the tourism industries of Wasatch and Utah counties; and
 - o one representative from the public at large.

The three public board members serve four-year staggered terms where one-half of the members' terms expire every two years. These members may not serve more than two full consecutive terms (Utah Code §63H-4-102).

PURPOSE:

Manage the trust fund consisting of money from the sale or use of land granted to the state under the Utah Enabling Act and other proceeds, revenue, and assets (Utah Code §53C-3-102 and §53D-1-201(3)).

Provide board members and the director of the school children's trust section access to all office records and personnel as necessary for board members and the director of the school children's trust section to fulfill their responsibilities to ensure that the office is in full compliance with applicable law and policies (Utah Code § 53D-1-202).

EXEMPTIONS:

(Utah Code §53D-1-103)

Exempt from the following provisions of Title 63G, Chapter 3, Utah Administrative Rulemaking Act: Utah Code §63G-3-301(6) and (7); and §63G-3-601.

Exempt from some provisions of Title 63A, Chapter 17, Utah State Personnel Management Act (see Utah Code §53D-1-103(7)).

SITFO is subject to Title 52, Chapter 4, Open and Public Meetings Act; and §67-3-12, the Utah Public Finance Website.

HISTORY & ORIGIN:

SITFO was created by statute during the 2014 General Legislative Session as an independent state agency within the executive branch (UtahCode §53D-1-201(2)).

REPORTING REQUIREMENTS:

"No later than September 1 of each year, the office shall provide to the Division of Finance financial information for the prior fiscal year that the Division of Finance requests for financial reporting purposes" (Utah Code §53D-1-201(4)).

"The board shall annually report the director's compensation to the Legislature" (Utah Code §53D-1-303(3)(g)).

"At least annually, the director shall report in person to the Legislative Management Committee, the governor, and the advocacy office, concerning the office's investments, performance, estimated distributions, and other activities" (Utah Code §53D-1-403).

PURPOSE:

Manage lands that Congress granted to the state for the support of common schools and other beneficiary institutions (Utah Code §53C-1-201).

STATE INVOLVEMENT:

The authorizing statute provides that the attorney general shall represent the board, director, or administration in any legal action relating to trust lands (Utah Code §53C-1-305).

EXEMPTIONS:

(See Utah Code §53C-1-201)
Board-approved exemptions possible for:

- Utah Procurement Code (Title 63G, Ch.6a)
- Utah State Personnel Management Act (Title 63A, Ch. 17)

Certain business proposals may be classified as protected under GRAMA (Utah Code §63G-2-305).

HISTORY & ORIGIN:

In 1785, prior to passage of the U.S. Constitution, the Continental Congress reserved one square mile out of every thirty-six square mile township "for the maintenance of public schools." Beginning in 1850, two square miles were granted to schools. Then, in 1894, for Utah, Arizona, and New Mexico, four square miles per township were granted. Utah accepted the responsibilities of trustee, requiring the state to act with undivided loyalty in the best interest of the schools and other institutions that also received lands. Proceeds from the lands were to be placed in permanent funds to support the schools (trustlands.utah.gov).

SITLA was initially created by statute in 1993 and it was established as an independent state agency by statute in 1994 (Utah Code Annotated §53C-1-201).

REPORTING REQUIREMENTS:

The board shall "annually report the director's compensation to the Legislature" (Utah Code §53C-1-301(4)).

The director shall "submit to the board for public inspection an annual management budget and financial plan for operations of the administration and, after approval by the board, submit the budget to the governor" (Utah Code $\S53C-1-303(1)(e)$) and "maintain appropriate records of trust activities to enable auditors appointed by appropriate state agencies or the board to conduct periodic audits of trust activities" (Utah Code $\S53C-1-303(1)(k)$).

The director is also required to "keep the board, beneficiaries, governor, Legislature, and the public informed about the work of the director and administration by reporting to the board in a public meeting at least once during each calendar quarter" (Utah Code §53C-1-303(1)(m)).

PURPOSE:

Promote the beef industry of the state and encourage local, national, and international use of Utah beef (Utah Code §4-21-105(1)).

STATE INVOLVEMENT:

The state is not liable for the acts or omissions of the council, council officers, agents, or employees (Utah Code §4-21-301).

The attorney general is not the legal advisor for the council and has no obligation to defend the council or the council's members in an action or proceeding brought against the council, but the attorney general may choose to represent the council or its members if requested to do so (Utah Code §4-21-303).

EXEMPTIONS:

(Utah Code §4-21-106(1))

The council is exempt from:

- Funds Consolidation Act (Title 51, Ch. 5);
- Utah Government Operations Code (Title 63A), but is subject to provisions related to the Utah Public Finance Website;
- Utah Procurement Code (Title 63G, Ch. 6a), but shall ensure purchases provide for fair competition and are at competitive prices;
- Budgetary Procedures Act (Title 63J, Ch. 1); and
- Utah State Personnel Management Act (Title 63A, Ch. 17).

HISTORY & ORIGIN:

The Utah Beef Council originally existed as a non-profit organization. In the 2018 General Session, the Utah Beef Council became an independent state agency charged with the promotion and marketing of beef and beef products in Utah. The organization is directed by a 10-member board that represents the state's cattle producers (www.utahbeef.org; Utah Code §4-21-103(1)).

REPORTING REQUIREMENTS:

The council shall submit the council's proposed budget and an end-of-year audited financial statement to the department and the Office of the State Auditor within 180 days of the end of each fiscal year; provide the department, on an annual basis, with a detailed outline of the council's plans for future publications and messaging; and report, by October 1 of each year, to the Retirement and Independent Entities Interim Committee on the operations and activities of the council (Utah Code §4-21-105(2)).

STATE SERVICES USED:

The council is not eligible to receive coverage under the state's Risk Management Fund (Utah Code §4-21-302).

- the vice president of the UCA;
- a member of the UCA's board of directors, chosen by the UCA;
- the U.S. Secretary of Agriculture appointed Utah appointee on the national beef checkoff Cattlemen's Beef Promotion and Research Board:
- the president of the Utah Cattlewomen's Association;
- a member of the Utah Dairy Commission, chosen by the Utah Dairy Commission; and
- three at large producers from the state of Utah, appointed as described in §4-21-103(4).

Establish and maintain a statewide public safety communications network and provide administrative and financial support for statewide 911 emergency services (Utah Code §63H-7a-102).

STATE INVOLVEMENT:

"The state treasurer shall invest all money held on deposit by or on behalf of the authority." (Utah Code §63H-7a-701).

HISTORY & ORIGIN:

The Utah Communications Agency Network (UCAN) was originally established by executive order of the governor on June 6, 1996 (Laws of Utah 1997).

During the 2014 General Session, legislation changed UCAN to the Utah Communications Authority, expanding the overall purpose and incorporating the state 911 program. During the 2017 General Session, legislation redefined the board structure and eliminated radio user fees, funding UCA through service fees on phone lines.

REPORTING REQUIREMENTS:

"The authority shall, following the close of each fiscal year, submit an annual report of its activities for the preceding year to the governor and the Legislature" (Utah Code §63H-7a-804).

"The state auditor shall at least once in each year audit the books and accounts of the authority or shall contract with an independent certified public accountant for this audit" (Utah Code §63H-7a-804).

The authority is subject to requirements related to the Utah Public Finance Website (Utah Code §63H- 7a-803(3)(b) and §67-3-12).

In March 2018, the Commission entered into a Dairy Research and Promotion Agreement with Dairy West, which now represents Utah and Idaho dairy producers. Under the agreement, Dairy West implements and administers dairy promotion in Utah and other western states and provides other services to the commission. The Commission has the option to renew the agreement annually.

The commission was initially created as an independent state agency by statute in 1979.

BOARD MEMBERSHIP, REQUIREMENTS, & TERMS CONT'D

The Utah Capital Investment Board is created within the Governor's Office of Economic Development and consists of five members:

- the state treasurer:
- the executive director of the Governor's Office of Economic Development; and
- three members appointed by the governor with expertise in:
 - o the supervision of investment managers;
 - o fiduciary management of investment funds; or
 - o the management and administration of tax credit allocations programs.

The Board of Directors of the Utah Capital Investment Corporation consists of at least five members with expertise in:

- the selection and supervision of investment managers;
- fiduciary management of investment funds; or
- other areas of expertise considered appropriate.
