

NOTICE TO BLCS MEMBERS

15th July 2020

This is an update to the Society's statement issued 10th October 2019

Through communication with members and on its website throughout 2019, the Society advised that a number of animals bred in the Ballinloan herd had been subject to investigation by the authorities and their passports had been removed.

At the same time, the Society also advised that some animals were still under investigation. Recent communication about those animals with the authorities has meant that the Society's Council of Management has had to look at the information and consider the status of each of these animals within the herd book.

In consultation with the authorities, it has been established that information supporting the records for pedigree registration purposes of some of these animals is not available. The Council has considered this and, to mitigate the impact on wider members and those they may sell cattle to, the decision has been made that these animals should be de-registered from the herd book. They are as follows:

In turn, this also means the descendants of these animals have also been deregistered, since they no longer meet the requirements of the 'three generation rule' within the EU legislation by which the Society is bound. All affected owners have been informed.

In addition to the above, a number of other Ballinloan and Ballinloan-related animals remain under investigation. Their pedigree status within the BLCS herd book and that of their descendants is suspended pending outcomes of the investigation. The animals are as follows:
