



## ADDENDUM No. 1

### PROJECT: AWTP-CHLORINE SCRUBBER SYSTEM – FY2023

MACON, GEORGIA

DATE: January 4, 2023

The Bid Documents shall be amended as follows:

- The existing Section of the Contract Documents listed below shall be replaced with the following clarifications:
  - Section 0020-2 INVITATION TO BID – The Contractor **does not** have to have a Georgia Utility Contractor License Number.

Eligibility requirement for Bid submittance:

- The existing Section of the Contract Documents indicates the following requirements for submitting a bid:
  - Section 0020-2 INVITATION TO BID - Copies of Contract Documents may be obtained at the Engineering Department, Macon Water Authority, 537 Hemlock Street, Macon, Georgia 31201, by contacting Gene Inman, Project Manager, Telephone 478-738-6518, upon a non-refundable payment of **\$150.00** for each set. A street address must be provided to ensure prompt delivery. No partial sets of bidding documents shall be issued. **Bidders must purchase the Contract Documents in order to be eligible to submit a bid.**

### Questions & Responses from Pre-Bid Meeting

1. **Question:** *Is there any flexibility due to the current economic environment concerning the 130 consecutive calendar days for full completion of the Work under the contract?*
  - a. **Response:** The Contract Documents are being amended to 200 consecutive calendar days. The Owner will be flexible should additional time beyond the 200 consecutive calendar days be needed, provided acceptable justification in writing is provided to the Owner in sufficient time prior to expiration of the 200 consecutive calendar days.
2. **Question:** *Is overtime allowed during the project?*
  - a. **Response:** The normal business hours of the Amerson Water Treatment Plan (AWTP) are Monday-Friday, 8:00am-5:00pm EST. The contractor should plan to perform work during these hours. Extension of work time is addressed

in the following *Article* should it become necessary. Contract time is addressed in the Contract documents under 00700 GENERAL CONDITIONS SECTION, ARTICLE 28 - (a) Rate of Progress.—The Contractor shall proceed with the Work at a rate of progress which will insure substantial completion of the Project within the Contract Time. It is expressly understood and agreed by and between the Contractor and the Owner that the Contract Time for the Work is a reasonable time, taking into consideration the average climatic and economic conditions, and other factors prevailing in the locality of the Work. It is understood that the Contractor’s proposed construction schedule is based on a normal 40-hour work week, less recognized holidays. If the Contractor desires to work in excess of a normal 40-hour work week, the Contractor shall submit a written request to the Owner and Engineer a minimum of two (2) days prior to the desired work date. The Contractor shall be responsible for any additional expenses incurred by the Owner as a result of any extended work hours, including resident inspection overtime. The cost associated with resident inspector overtime will be deducted from the Contractor’s monthly progress payment request.

3. **Question:** *Is onsite Safety addressed?*

a. **Response:** Yes. Safety requirements can be found in the contract documents under 00700 GENERAL CONDITIONS SECTION, ARTICLES 21, 22 and 23.
