AIRWORTHINESS LIMITATIONS - GENERAL COLOMBIA UNIDAD ADMINISTRATIVA ESPECIAL DE AERONAUTICA CERTIFICATION STANDARD

1. Planning Information

A. Effectivity

All PC-12, PC-12/45, PC-12/47 and PC-12/47E aircraft which are required to comply with the Colombian Civil Aviation Administration (UAEAC) certification standard.

If an aircraft is delivered direct from PILATUS to Colombia, it will comply with the Colombian (UAEAC) defined requirements. This Service Bulletin is issued to make sure that aircraft not delivered directly from PILATUS, will comply with Colombian (UAEAC) requirements.

B. Concurrent Requirements

None.

C. Reason

(1) Problem

Aircraft not in compliance with the requirements of the Colombia (UAEAC).

(2) Cause

The Colombia (UAEAC) require that aircraft imported into Colombia comply with Reglamentos Aeronauicos De Colombia, including bi-lingual placard requirements (Spanish/English) per RAC 9.

(3) Solution

Install placards/markings in accordance with the bi-lingual language requirements of the Colombia (UAEAC).

D. Description

This Service Bulletin gives the instructions and data necessary to install the bi-lingual language placards/markings.

E. Compliance

Mandatory for all aircraft which are required to be in compliance with the Colombia (UAEAC) certification standard.

F. Approval
