RE: UK policy review for *Macchiademus diploterus* (Grain chinch bug)

I am writing to invite your view on a proposed change in position recommended by the UK Plant Health Risk Group (PHRG) for *Macchiademus diploterus*. This would replace the position agreed following a review in 2012, taking account of developments since then.

In 2012 a Pest Risk Analysis (PRA) was conducted for *Macchiademus diploterus*. At the time, it was recommended by the PHRG that statutory action be taken on any findings of the organism due to the perceived risk to southern member states. A further review of *Macchiademus diploterus* in 2018 has now taken place. Further to this, it also appears that the UK is the only country in Europe routinely taking such action, with associated impacts on UK importers. This pest has also been discussed by the European and Mediterranean Plant Protection Organisation (EPPO), including representatives from southern European countries, who have not identified it as a priority for regulation. In light of this the PHRG has revised its recommendations.

Recommendations

The following recommendation was presented at the PHRG:

• No statutory action will be taken against findings, on the basis that it is unlikely to establish in the UK.

Background

Macchiademus diplopterus (Distant) is native to South Africa where it is a serious pest of wheat, oats and barley. It has been detected in England in association with fresh apple,



citrus, nectarine, pomegranate, peach and plum fruit imported from South Africa on at least 42 occasions since 2005, including 24 interceptions since 2015.
