A RESOLUTION to recognize Ronnie L. White on the occasion of his Retirement.

WHEREAS, it is fitting that the members of this General Assembly should pause to specially recognize those outstanding citizens who have devoted their careers to providing the highest quality education for Tennessee's students; and

WHEREAS, Ronnie L. White, Millwright Skills Instructor at the Tennessee Technology Center (TTC) in Elizabethton, is one such estimable educator who evinces the greatest probity and excellence in all his endeavors; and

WHEREAS, after more than eighteen years as an educator, Mr. White is taking a much deserved retirement on February 29, 2012, after having been a positive influence on so many lives; and

WHEREAS, in his tenure at TTC, Ronnie White initiated the Millright Skills Program, the only program of its type in the United States. For twenty years, the program has produced intelligent and capable professionals for the construction and maintenance of machinery; and

WHEREAS, prior to his work at TTC, he served for thirteen years at Fluor Daniel in Greenville, North Carolina, where he was responsible for the launch of the A.E. Staley Plant, a \$450 million project, and for the training of their maintenance force. He also developed and administered the first training program to receive more than one million dollars in Job Training Partnership Act contracts for a single year and the first program to graduate more than 700 participants in the fiscal year; and

WHEREAS, a graduate of East Tennessee State University (ETSU), where he studied business administration, Mr. White has continuously sought new learning opportunities, including management performance training at Aubrey Daniels & Associates in Atlanta and the critical path method of planning and scheduling program at the University of Virginia; and

WHEREAS, he also completed coursework in laser and optical alignment at Luccduca in Miami and in the insulation and maintenance of high voltage at ETSU, and advanced training in blueprint reading, welding, and industrial electricity; and

WHEREAS, as a result of his extensive education, Ronnie White has earned his welding license from the United States Navy, state and city electrical and state electrical contracting licenses, a municipal plumbing license, a municipal air conditioning and refrigeration license, and Fluor Daniel craft certifications in rebar, millwright, electrician, pipefitter, instrumentation fitter, carpenter, and supervisor; and

WHEREAS, his vast expertise and decades of experience greatly served him as he trained countless individuals for gainful employment; and

WHEREAS, Mr. White exemplifies the spirit and allegiance to community that are characteristic of a true Tennessean; and
