

# Well Badger Resource Center Inclusion/Exclusion Criteria

#### **BACKGROUND**

The Well Badger Resource Center provides specialized health-related Information and Referral (I&R) services to individuals and families throughout Wisconsin. Target groups include pregnant people, children and youth with special health care needs, and low-income individuals and families. The Well Badger Resource Center maintains a searchable online directory of health, human service, and community-based services, sites, and agencies in Wisconsin. The directory is accessible to the public and professionals. It is also accessed by Well Badger I&R specialists in providing phone, email, chat, text, and web form I&R services.

#### **INCLUSION**

#### **Inclusion Overview**

For inclusion in the Well Badger Resource Center directory, an agency/service must:

- Provide direct health, human, and/or community services; and/or have a related role (such as
  planning, coordinating, or funding of these services) that fall under one of the service categories found
  on pages 4 and 5.
- Be located within and/or serve residents of the state of Wisconsin
- Have provided continuous services for at least six months
- Provide timely and accurate information about agency and service updates to the Well Badger Resource Center
- Not deny services to individuals based on agency membership, nationality, race, religion, age, sexual orientation, or any other category protected by civil rights laws
- Follow regulatory or licensing standards, if applicable

#### **Included Entities**

In addition to meeting the above criteria, agencies included in the Well Badger Resource Center directory must also fall under at least one of these entity types:

- Non-profit health, human, and/or community-service agencies
- Government agencies that provide oversight, funding, or coordination of health, human, and/or community-services
- For-profit health, human, and/or community-services agencies that meet at least one of the following criteria:
  - Provide services at no-cost, low-cost, or on a sliding scale-fee
  - Provide "critical for-profit health and human services" 1
  - o Provide services for children, youth, and adults with special health care needs
- Faith-based agencies that provide ancillary health, human, and/or community services. Health, human, and/or community services must be offered to all individuals regardless of religion or membership.
   Religious services or related activities will not be included.
- Informal/unincorporated agencies that provide ancillary health, human, and/or community services, such as support groups

## Well Badger Resource Center Inclusion/Exclusion Criteria

#### **EXCLUSION**

#### **Exclusion Overview**

Any agency that does not meet the above inclusion criteria will not be included in the Well Badger Resource Center directory. In addition, any agency that meets any of the following exclusion criteria will not be listed in the Well Badger directory:

- Does not provide health, human, or community services or have a related role
- Delivers services that violate local, state, or federal law
- Misrepresents or omits information about services, sites, or agency information
- Denies services to individuals based on agency membership, nationality, race, religion, age, sexual orientation, or any other category protected by civil rights law
- Does not have necessary licensure, or license has been suspended (if applicable)
- Does not provide direct services
- Individual or private practitioners<sup>2</sup>

#### REMOVAL FROM WELL BADGER RESOURCE CENTER DATABASE

At the discretion of the Well Badger Resource Center, agencies may be suspended from the Well Badger Resource Center directory under the following circumstances:

- Has not responded to three requests for updated service, site, and agency information
- Is under legal investigation for criminal activity, fraud, misconduct, discrimination, or other suspected wrongdoing
- Has not responded to communication from the Well Badger Resource Center about a suspension
- Has misrepresented or given false information about services, site, or the agency

#### REQUEST FOR INCLUSION

Agencies not currently listed in the directory should review the inclusion/exclusion policy. If they feel they meet the requirements, the agency should complete an intake form. (Instructions listed <a href="https://exclusion.org/learning/learning-new-the

#### **REQUEST FOR UPDATES**

Agency listings will be updated at least once per calendar year. Agencies will receive a verification email from <a href="mailto:agencyinfo@wellbadger.org">agencyinfo@wellbadger.org</a>. The Well Badger Resource Center relies on agencies to provide up-to-date information and updates for the directory. Well Badger will also continuously update entries when we learn of new services or updates.

# Well Badger Resource Center Inclusion/Exclusion Criteria

#### **DENIAL**

If an agency or service is found ineligible for the directory, the Well Badger Resource Center will inform the agency of the decision within 30 days of the receipt of the intake form.

#### **GRIEVANCES**

All agencies will be considered for inclusion in the Well Badger Resource Center directory on a case by case basis. Well Badger Resource Center reserves the final decision about inclusion and exclusion decision. If an agency does not agree with the decision, the following process will be followed:

- 1. Complainant agency may file a written complaint via email to <a href="mailto:agencyinfo@wellbadger.org">agencyinfo@wellbadger.org</a> or by mail to Wisconsin Women's Health Foundation, 2503 Todd Drive, Madison, WI 53713.
- 2. Well Badger Resource Center will acknowledge the receipt of the complaint within two business days.
- 3. Well Badger Resource Center Review Team (comprised of Resource Specialist, Program Manager, and Operations Director) will examine the complaint and make a determination within five business days.
- 4. Once the determination is made, Well Badger Resource Center will respond to the complainant via email with the decision.
- 5. If the complainant wishes to appeal a second time, the final decision as to the exclusion will be decided by the Wisconsin Department of Health Services.

- 1. The information listed in the Well Badger Resource Center directory has been provided by the agency. The Well Badger Resource Center is not responsible for missing or inaccurate information.
- 2. The Well Badger Resource Center aims to provide accurate and appropriate referrals based on the individual and family needs. It does not recommend or endorse any agencies.
- 3. The Well Badger Resource Center is not responsible for misunderstanding or misuse of services.
- 4. The Well Badger Resource Center is not responsible for the quality of services delivered by any agency listed within the directory.
