1. CALL TO ORDER AND ROLL CALL

Mr. Christos Valiotis, Academic Senate President, called the March 1, 2012 Academic Senate meeting to order at 3:02 p.m.

2. OPENING COMMENTS FROM THE SENATE PRESIDENT

- Mr. Valiotis announced Ms. Dorothy Williams will be honored at the upcoming Board of Governor's
 meeting as a recipient of the Hayward Award. Ms. Williams will be the sixth award recipient from
 Antelope Valley College. This is the most prestigious award for California Community College Faculty.
- Dr. Fisher, AVC Superintendent/President will return to work on Monday, March 5, 2012. He is recovering well and is ready to return to work.
- An invitation was extended to Ms. Diana Keelen, Director of Business Services, to speak to the budget
 concerns raised at the last Academic Senate meeting. She is unable to attend the meeting to speak to the
 budget or concerns expressed at the last Academic Senate meeting but will attend the March, 15, 2012
 Senate meeting.

3. OPEN COMMENTS FROM THE PUBLIC

• Dr. Thomas Shey stated he was recently made aware of percentage increases incurred on books sold at the Marauder Bookstore. He presented the following statement:

"Following a number of complaints by students who recently bought the required text and reader for SOC 101 at our campus bookstore, I contacted the publisher and members of the previously mentioned bookstore and belated discovered that our shop had increased their profit margin by 50 percent – namely, from 22 to 33 percent, In short, the Henslin text which Pearson Publishers billed for \$66.00 was sold to our students for \$88.00 plus sales tax.

At a recent Social Science Division meeting conducted last Friday on February 2, 2012 a motion was made and universally passed by all faculty in attendance directing me to bring this situation to the Academic Senate for review and hopefully subsequent action.

We logically assume that if our bookstore is marking up our Sociology text they are also doing it to other disciplines on campus. Given the understandable fiscal constraints that our students are currently operating under, a 33 percent markup is unconscionable!"

Dr. Shey announced he spoke with Mr. David Moyer, Bookstore Supervisor, regarding this matter and he claimed the Bookstore is struggling financially and has to maintain a level of fiscal solvency.

- Mr. Van Rider stated the Library is in the process of evaluating which databases would be best suited to offer on campus. An email will be distributed to specific faculty requesting they review Library database services and evaluate them accordingly. Please inform constituent faculty of the evaluation process and encourage them to participate in the evaluation process as faculty input is vital to determining which databases are needed for campus use.
- Mr. Ron Chapman stated he thought the Ebscohost is paid by the State and is not paid by the District. Mr.
 Van Rider reported there are several California Community Colleges that cannot afford to pay for database
 subscriptions therefore the consortium for Library services pays for all California Community Colleges to
 have access to specific databases.
- Dr. Berkeley Price stated it is incredibly difficult to schedule discipline or division meetings and would like the Senate to review the following issues:

- Adjunct email it is increasingly difficult to communicate and contact Adjunct Faculty. Adjunct faculty express frustration with the email service and the amount of spam they receive therefore they don't regularly check their campus email. Often times therefore their campus email accounts are over quota. Mr. Valiotis recommended having adjunct faculty forwarding all avc.edu email to their personal email accounts to limit spam and eliminate the opportunity for adjunct faculty to miss pertinent information pertaining to discipline faculty.
- o Most universities or colleges facilitate standardized meeting times for faculty work to be collectively completed. It has become incredibly difficult for division faculty to schedule collaborative meetings where all faculty can participate. It would be helpful for the District to institute a specific block of time for discipline faculty to participate in committee, division, or discipline meetings. Often times when faculty need to establish a meeting to work on campus issues (i.e. SLOs, Program Review, Curriculum issues, etc.) there is generally one or more faculty who cannot attend due to a conflict in schedule. Mr. Valiotis suggested recommending to the Dean this need so it can be facilitated at the Division level. The Health Science faculty indicated their Dean has established a definitive day for Division meetings and all courses are scheduled around this day and time to facilitate the participation of all full-time faculty in the Division.

4. APPROVAL OF MINUTES

5. PRESENTATION (10 minutes max.)

a. Foundation and Advancement - Ms. Bridget Razo

Ms. Bridget Razo expressed her gratitude for being able to provide a presentation to the faculty. She presented the purpose of the Foundation and Advancement Office.

"The Antelope Valley College Foundation's mission is to raise funds and create partnerships and friends in support of the mission of Antelope Valley College."

The role of Advancement and Foundation is to develop the financial, political and public support for Antelope Valley College through:

She indicated in comparison to other Foundation Organizations in the local community the college Foundation has been able to raise a significant amount of money. The only Foundation organization that generally raises more funds locally is the AV Hospital Foundation (\$805,445.00). Ms. Razo presented several handouts displaying the funds processed and disbursed by the Foundation. Each month the Foundation presents an itemized report to the Board of Trustees to display all budgetary expenses and disbursements. It is important for the Foundation to ensure transparency and fiscal accountability. In addition, Ms. Razo provided itemized lists of the January 2012 Fund Activity Report, January 2012 Gifts Report (Unrestricted, Restricted: Scholarships, Temporary Restricted: Other, Restricted: Endowments, and In Kind Donations), and Foundation Grants awarded during the 2005 – 2011 academic years. A total of \$76,693.00 have been awarded to Administration (6 grants), Faculty (74 grants), and Staff (7 grants). See attachments for complete detail. One of the major differences between the Advancement and the Foundation Offices is the Foundation operates under the guidance of a Governing Board who assists in determining fundraising opportunities and events. Ultimately, the Foundation works to facilitate all facets of fundraising opportunities to augment funding needs for the District. She presented an additional handout on the Advancement and Foundation Scholarship Summary.

"Since 2008, the Advancement and Foundation Office has managed the AVC Scholarship Program. In that time, there has been continued growth in the scholarship program.

The endowments are contractual, and must be awarded annually. The 20 scholarship endowments managed by the AVC Foundation represent a pooled assets of \$995,958.37. From this \$55,534.00 is distributed annually as scholarships from the endowed funds.

The annual non-endowed scholarships are given by 63 donors or donor groups, and represent \$92,836.00 to be distributed in 2012 - 2013.

Out of all scholarship donors, 75% donate to other funds. It is a point of entry of gifts. Many scholarship volunteers (committee screeners) are now becoming donors as well."

The Foundation and Advancement has hired an Investment Management group, in addition to incorporating a Foundation Financial and Investment Committee who makes investment recommendations. The hired Investment Group has invested in conservative funds which we've been able to net 12% in income with the conservative investments. This is a great return on conservative fund investments. Ms. Razo stated it is important for faculty to see the Foundation and Advancement Office as a resource for funding needed for course instructional needs, instructional materials, professional development opportunities, etc. Furthermore, she operates the office with an open door policy and is always willing to work with faculty to create Foundation funding opportunities.

Mr. Ken Shafer reported at a recent Distance Education and Technology Committee meeting the Director of Information Technology Services, Mr. Calvin Madlock, reported most campus computers are four to five years beyond their expected life. Is it plausible to consider using Foundation funds to assist in the funding requirements needed to replace technological equipment on campus? Ms. Razo indicated this is absolutely an area where the Foundation can assist. They would need specific information, such as the number of computers needed, the longevity of the project, how many students will be impacted by replacing the technology, etc. If there is a campus need the Foundation can work to create fundraising opportunities available or solicit community support. At the present time, in a bleak budgetary time there are more funding requests and needs. The Foundation and Advancement Office is struggling with a staffing shortage to raise the funds the District actually needs. The more staff the office incorporates the more resources each staff member can use to contact potential community resource opportunities. Ms. Razo stated the Foundation and Advancement Office should be seen as the campus resource and advocate.

Mr. Valiotis reported he has been associated with the Foundation and Advancement Office for the past ten years and is incredibly impressed with the dedication and work of the staff and board members. He applauded Ms. Razo for the work she has performed on behalf of the District and students.

6. ACTION ITEMS

a. Tenure Review Coordinator – Liette Bohler (complete current term 2 years remaining beginning fall 2012)

A motion was made and seconded to approve Ms. Liette Bohler as the Tenure Review Coordinator and complete the remaining two years of the current three year term. Motion carried.

7. DISCUSSION ITEM

a. 2012 – 2013 Budget Update

Mr. Valiotis reported it appears that at every Senate meeting there is another budget update which depicts a more fiscal uncertainty than previously reported. Mr. Valiotis distributed the handout, *The budget freefall: Three rounds of 2011 – 2012 budget cuts*. See handout for complete details. Mr. Valiotis reported the District anticipated the January midyear cut but then were surprised by the announcement of the possible February cut. If this additional cut occurs it is expected to be another 1.5 million dollar cut for AVC. It is obvious the State needs to begin rethinking how to address education funding. The continued cuts put tremendous stress on colleges that are called to achieve higher results with less funding. Future updates will be provided when available. Mr. Ken Shafer stated the evening before the start of the spring 2012 semester, Pasadena City College cut 100 course sections to address the expected budget shortfall.

b. Budget Reduction

Mr. Valiotis presented a summary handout of the General Unrestricted Fund Actuals Expenditure Reductions and summarized the information being presented. He pointed out that since 2007 the District has actualized 6.2 million dollar cuts to the campus budget. The budget reduction has been due to faculty retirements, reduction in Administration (Deans), Librarians, Summer Session reduction, Adjunct faculty reduction, extra duty pay reduction, office hour reduction, and material expense reduction. At the last Academic Senate meeting an question was raised regarding the money saved from faculty retirements and campus closure during the summer 2011. Mr. Valiotis reported the District has experienced an overall state budget reduction of 6.2 million dollars. If the District is able to materialize savings from retirements, campus shut down, etc. then the money saved from not filling positions and or campus shut downs is being used to decrease the budget deficit gap which is increasing annually. The reality is the budget situation is increasingly getting worse and the District is forced to look at all means to reduce expenditures to meet the shortfall. The Senate will be provided a budget overview at the next Senate meeting and faculty will most probably be asked to brainstorm other means to reduce campus expenditures. At the present time there hasn't been any discussion or information provided on specific program cuts although it is very likely programs will be impacted by the current budget reductions. So far there have been no cuts to our base salary. The District will need to act quickly on how to address the budget reduction as the March 15th layoff notice deadline to notify Administrators, Faculty, Confidential Management/Supervisory Staff, and Classified staff is quickly approaching. The notices are mere notifications and do not necessarily mean layoffs. It is very likely that the summer schedule will be drastically reduced to offer only sections that are absolutely necessary to sustain programs. Faculty need to begin discussing the impact of a campus closure as well as come up with ideas for further reductions. In addition, faculty must be cognizant that 87% of the District's budget is for salaries and benefits, which doesn't leave many options when considering reduction possibilities. It is a good time for faculty to begin considering grant funding opportunities so that programs and services can be augmented with grant funding. The District is looking into instituting a Flee/Farmers Market to generate additional revenue.

Mr. Luis Echeverria stated in Counseling due to the budget reductions the area has reduced staff and have a great deal of work not being addressed (i.e. filing) and it may be time to look into instituting a volunteer program to assist with the additional work in the area that is not being performed due to the lack of work force.

Ms. Susan Knapp inquired since the District is thinking about cutting classes during the summer are they also thinking of closing services as well? Mr. Valiotis reported other colleges have moved to a four day a week work schedule to actualize budget savings. The District hasn't made any mention of closing services or altering service hours but a study of cost savings would have to be performed in addition of reviewing how the block schedule would have to be altered. At this point, Mr. Valiotis indicated there will not be a set date on when feedback is expected to be reported to the Senate but will leave the issue open at this time. It is imperative faculty begin discussing all possibilities at this time.

c. Assembly Bill Implementation: Student Success Task Force

Mr. Valiotis reviewed the Proposed Education Code Language to Implement Student Success Task Force (SSTF) February 9, 2012 – Second Draft. He stated there are some proposed revisions that cause concern and should also concern Counseling Faculty. In Ed. Code 78215 and 78216 the term Counseling is being removed and being substituted with Education Planning Services inferring these types of services can be performed by an Educational Advisor in lieu of Counseling Faculty. The Counseling faculty need to actively discuss this proposed revision and respond accordingly. Mr. Valiotis also requested for Senators to review the Student Success Act for 2012 Summary of Key Elements in Proposed Bill Lanugage – Feburary 1, 2012. The summary speaks specifically to changes made to Counseling and Matriculation services. In addition, one major element that stands out is everyone was awaiting the revisions made to the Student Success Task Force language although legislative bills were already created. This indicated that legislatures were working on establishing bill language prior to the Task Force completing their recommendations. Dr. Glenn Haller reported he has a summary report of the Implementation of Student Success Task Force Recommendations and what impact they may have on Statutes, Regulations, Budget, State Administrative Policies, Local Best Practice, and legislative action. He will forward the summary for inclusion in the Senate packet but cautioned faculty to be vigilant as there are events occurring at the State level that will ultimately impact the way colleges provide services and are allocated funds. Please review attachments for additional information. Mr. Valiotis stated the intent of the Task Force was good but there are questions about how the recommendations will be implemented.





AVC Scholarship Program Executive Summary

Since 2008, the Advancement and Foundation Office has managed the AVC Scholarship Program. In that time, there has been continued growth in the scholarship program.

The endowments are contractual, and must be awarded annually. The 20 scholarship endowments managed by the AVC Foundation represent a pooled asset of \$995,958.37. From this, \$55,534 is distributed annually as scholarships from the endowed funds.

The annual non-endowed scholarships are given by 63 donors or donor groups, and represent \$92,836 to be distributed 2012-13.

Out of all scholarship donors, 75% donate to other funds. It is a point of entry for gifts. Many scholarship volunteers (committee screeners) are now becoming donors as well.

The budget freefall: Three rounds of 2011-12 budget cuts

Antelope Valley CCD

- The Budget Act
- In the 2011-12 state budget, the state General Fund appropriation for community colleges was cut by \$400 million, which was expected to be partially offset by \$110 million in new fee revenue from a statemandated increase in fees from \$26 to \$36 per unit.
- In an effort to maintain the per-student funding received by the state, the Budget Act provided the Chancellor's Office with authority to reduce student workload commensurate with the funding cut taken by the community colleges. Districts reduced enrollment, as instructed, in all areas except enrollments in basic skills, workforce training and transfer-level coursework. Underlying the provision permitting colleges to reduce enrollments was an acknowledgment that colleges have NOT received a cost of living adjustment in four years while at the same time their fixed costs have increased (negotiated agreements, health & welfare benefits, utilities etc) significantly. While a workload reduction permits institutions to somewhat "preserve" instructional quality, the lack of investment in higher education results in "shutting the door" on students.
- For Antelope Valley CCD, this reduced funding by approximately \$3,222,000, resulting in a workload reduction of 706 FTES, or approximately 235 course sections.
- The January Trigger Cuts
- In an effort to conclude the 2011-12 budget deliberations in June 2011, an additional \$4 billion of revenues was added to Governor

Brown's May Revision projections to "preserve" overall programmatic funding statewide. Companion legislation to the budget act outlined additional programmatic reductions throughout the budget in the event revenues came in under projections. On December 13th the Department of Finance announced an additional \$981 million of "trigger" reductions of which \$102 million were specifically targeted at the community colleges. This \$102 million reduction to the colleges arrived 6 months into the fiscal year and came at the conclusion of the fall 2011 semester, and after spring 2012 schedules had been set. Given the dynamics unfolding related to the upcoming November election, it is likely the colleges will again find themselves on a "trigger" list which once again will compromise their ability to serve their communities.

 For Antelope Valley CCD, this reduced funding by an additional amount of approximately \$741,000, resulting in an additional workload reduction of 171 FTES, or approximately 57 course sections. Additionally, the district was cut \$306,000 on a one-time basis.

The February Surprise

- On February 16, California's community college districts were informed that they would have an additional \$149 million mid-year cut, on top of the \$313 million cut included in the 2011-12 enacted budget and the \$102 million made in January as part of the "budget triggers." This brings the total 2011-12 cuts to an astounding \$564 million.
- The cut is due to lower-than-projected property tax and student enrollment fee revenues, which are ordinarily combined with state general fund revenues to provide each district's "apportionment"-the basic per-student funding that supports instruction and student services.
- Of the \$564 million in total cuts, \$385 million is taken as a permanent "workload reduction," meaning fewer classes will be offered and fewer students will be served. The remaining \$149 million is a one-time reduction to funding per student, reducing funding from \$5,659 in 2008-09 to nearly \$5,000 in 2011-12.
- For Antelope Valley CCD, this reduced funding by an additional amount of approximately \$1,522,000.

Proposed Education Code Language to Implement Student Success Task Force (SSTF) February 9, 2012 Second Draft

Proposed SSTF Education Code changes to Matriculation:

- **78210.** This article shall be known and may be cited as the Seymour-Campbell-Matriculation Act of 1986 Student Success Act of 2012.
- **78211.** It is the intent of the Legislature to do all of the following:
 - (a) Ensure equal education opportunity for all Californians.
- (b) Provide students with the resources and support to establish informed educational goals.
- (bc) Ensure that students receive the educational services necessary to optimize their opportunities for success in completing their educational goals and programs of study.
- (d) Recognize that student success is the responsibility of the institution and student, supported by well coordinated and evidence-based student and instructional services to foster academic success.
- (e) Target state resources on the provision of critical student services, such as counseling and student advising, and identify a broad array of service delivery mechanisms that can effectively reach a greater number of students.
- —(c) Provide students with the information to establish realistic educational goals, and ensure that the matriculation process does not exclude students from receiving appropriate educational services at community colleges.
- **78211.5.** (a) The purpose of the Student Success Act is to increase California community college student access and success by providing effective core matriculation services of orientation, assessment and placement, counseling and education planning, and academic interventions. The focus of the Student Success Act is on the entering students' transition into college to provide a foundation for student achievement and successful completion of students' educational goals, with a priority towards serving students who enroll to earn degrees, career technical certificates, or transfer. The Student Success Act of 2012 targets state resources on core matriculation services that research has shown to be critical to increasing the ability of students to reach their educational goals. By focusing funding in these core areas and leveraging the use of technology to more efficiently and effectively serve a greater number of students, the goal of the Student Success Act is to provide students with a solid foundation and opportunity for success in the California Community Colleges.

(b) The Board of Governors of the California Community Colleges shall initially provide for full implementation of the Student Success Act's matriculation services specified in Section 78212 in as many community colleges as the funds appropriated for this purpose allow.

(b) Because of the need to develop and evaluate data on a standard statewide basis concerning the implementation and effectiveness of the matriculation services described in this article, Any college or district

receiving funding under this article shall agree to carry out its provisions as specified, but shall be bound to that agreement only for the period during which funding is received pursuant to this article. The obligations of the college or district under the agreement shall include, but not be limited to, the expenditure of funds received pursuant to this article for only those matriculation services approved by the board of governors and the contribution toward the purposes of this article of matching funds as the board of governors may require pursuant to Section 78216.

- **78212.** (a) For purposes of this article, "matriculation" means a process that brings a college and a student who enrolls for credit into an agreement for the purpose of realizing achieving the student's educational objectives goals and completing the student's program of study. The agreement involves the responsibilities of both parties to attain those objectives through the college's established programs, policies, and requirements identified by the board of governors pursuant to Section 78215.
- (1) The student's responsibilities under the agreement include, but are not limited to, the expression identification of an at least a broad educational intent educational goal upon enrollment, the declaration of a specific educational objective program of study within a reasonable period after enrollment as defined by the board of governors, diligence in class attendance and completion of assigned coursework, and the completion of courses and maintenance of academic progress toward an educational goal and program of study identified in the student's education plan according to standards established by the college, the district, and the state.
- (2) The institution's responsibility under the agreement includes the provision of services for students to provide a strong foundation to support their academic success and ability to achieve their educational goals. The services funded through the Student Success Act, also known as the Student Success and Support Program,

 Matriculation services to be made available by the colleges shall include, but are not limited to, all of the following:
- (1) Processing of the application for admission.
- (2A) Orientation and preorientation services designed to provide to students, on a timely basis, information concerning campus procedures, academic expectations, financial assistance, and any other matters the college or district finds appropriate.
- (3B) Assessment and counseling education planning services upon enrollment, which shall include, but not be limited to, all of the following: (1i) Athe administration of assessments instruments to determine student competency in computational and language skills and readiness for college.
- (C) Counseling and education planning services, which shall include, but not be limited to, all of the following:
- (2i) Counseling and advising,
- (ii) Assistance to students in the identification of aptitudes, interests and educational objectives, including, but not limited to, associate of arts degrees, transfer for baccalaureate degrees, and career technical vocational certificates and licenses,

- (iii) The provision of information, guided by sound counseling principles and practices, using a broad array of delivery mechanisms, including technology-based strategies, to serve a continuum of student needs and abilities, to enable students to make informed choices, and
- (4iv) Development of an education plan leading to a program of study and guidance on course selection.
- (DD) Referral to specialized support services as needed, including, but not limited to, federal, state, and local financial assistance; health services; campus employment placement career services; veteran support services, foster youth services, extended opportunity programs and services provided pursuant to Article 8 (commencing with Section 69640) of Chapter 2 of Part 42; campus child care services provided pursuant to Article 4 (commencing with Section 8225) of Chapter 2 of Part 6; programs that teach English as a second language; and disabled student services provided pursuant to Chapter 14 (commencing with Section 67300) of Part 40.
- (E) Advisement concerning course selection.
- (D) Post-Evaluation of each student's progress and referral to appropriate interventions, and required advisement or counseling for students who are enrolled in *basic skills* remedial courses, who have not declared an educational objective *goal* as required, or who are on academic probation, as defined by standards adopted by the Board of Governors of the California Community Colleges and community college districts.
- (b) Student Success and Support Program funding shall be targeted to fully implement orientation, assessment and education planning services needed to assist a student in making an informed decision about his or her educational goal and program of study and in the development of an education plan.
- **78212.5.** Each community college district may develop and maintain all of the following within each community college in the district:
- (a) Career resource and placement centers having the purposes of maintaining information on vocational, technological and educational opportunities, and facilitating career employment.
- -(b) Programs to instruct appropriate staff and faculty members in the performance of matriculation services.
- (c) Orientation programs designed to explain to new students academic requirements and other regulations of the community college, and the available student support services.
- (d) A publicity program designed to inform the community served by the community college that the purposes of the mandatory matriculation process are intended to facilitate, rather than restrict, student access to community college instruction, and to enhance each student's awareness of his or her abilities, skills, and potential.
- (e) A publicity program designed to inform high schools in the community served by the community college, through orientation programs and other means, of student skill levels, and of available student support services.
- **78213.** (a) No district or college may use any assessment instrument for the purposes of this article without the authorization of the board of governors. The board of governors may adopt a list of authorized assessment

instruments pursuant to the policies and procedures developed pursuant to this section and the intent of this article. The board of governors may waive this requirement as to any assessment instrument pending evaluation.

- (b) The board of governors shall review all assessment instruments to ensure that they meet all of the following requirements:
 - (1) Assessment instruments shall be sensitive to cultural and language differences between students.
- (2) Assessment instruments shall be used as an advisory tool to assist students in the selection of an educational program.
 - (3) Assessment instruments shall not be used to exclude students from admission to community colleges.
- (c) The board of governors shall establish an advisory committee to review and make recommendations concerning all assessment instruments used by districts and colleges pursuant to this article.
- (d) At such time when the board of governors adopts a system of common assessment, districts and colleges may use supplemental assessments or other measures for placement pursuant to 78213(a).
- **78214.** (a) All participating districts shall, with the assistance of the chancellor, establish and maintain institutional research to evaluate the effectiveness of the *Student Success and Support Program* services described by this article and of programs and services designed to remedy-facilitate students' skills deficiencies completion of their educational goals and programs of study.
 - (b) The data base accountability metrics for this research shall include, but not be limited to:
 - (1) Prior educational experience, including transcripts when appropriate, as determined by the chancellor.
 - (2) Educational objectives goals and programs of study.
 - (3) Criteria for exemption from *orientation*, assessment or required counseling or advisement, if applicable.
 - (4) Need for financial assistance.
 - (5) Disaggregated data by Eethnicity, gender sex, and age.
- (6) Academic performance, such as the completion of specified unit thresholds, success in basic skills courses, grade point average, course completion outcomes, transfer readiness, and degree and certificate completion.
 - (7) Any additional information that the chancellor finds appropriate.
- (c) The evaluation provided for by this section shall include an assessment of the effectiveness of the programs and services in attaining at least the following objectives:
 - (1) Helping students to define their educational goals and declare a program of study.
 - (2) Assisting institutions in the assessment of students' educational needs and valid course placement.

- (3) Helping support students' successful course completion and attainment of a degree, certificate or transfer, through the provision of effective orientation services and academic interventions.
 - (3) Matching institutional resources with students' educational needs.
- -(4) Providing students with specialized support services as referred to in subdivision (b) of Section 78212.
- **78215.** The Board of Governors of the California Community Colleges shall establish *policies* criteria and processes for:
- (a) requiring all non-exempt students to complete orientation, assessment, and develop education plans; (b) exempting students from participation in orientation, assessment testing, or required counseling or advisement education planning services under this article; and (c) requiring community college districts to adopt a student appeal process.
- **78216.** (a) The Legislature recognizes that community college districts are currently funding various components of student matriculation through existing *orientation*, *counseling education planning*, assessment, and other student services, but that adequate student matriculation and implementation of *Student Success and Support Program strategies* cannot be realized without supplemental funding support.
- (b) The board of governors shall develop a formula for allocating *Student Success and Support Program* funding *to implement the services identified in 78212* student matriculation services at community colleges. The formula shall include the requirement that the districts or colleges contribute matching funds in an amount to be established by the board of governors in each case, and shall reflect, but not be limited to, *other* all of the following considerations:
 - (1) The number of students to receive services at each college.
- (2) The levels of support for matriculation services provided at each college prior to July 1, 1985, and the need for funding assistance in the implementation of the program set forth in this article. —(3) The relative needs for matriculation services, based on special student populations such as low income students, students with language differences, students with physical and learning disabilities, and students in need of remedial instruction.
- (3) The relative needs for matriculation services, based on special student populations such as low income students, students with language differences, students with physical and learning disabilities, and students in need of remedial instruction.
- (42) The requirement that funds for *Student Success and Support Program matriculation*-services be expended only for services approved by the board of governors.
- (53) The requirement that any district or college receiving funding pursuant to this section agree to implement this article and implement the board of governors system of common assessment and accountability scorecard, pursuant to Section 84754.5 of the Education Code, when established during the period in which it receives that funding.
- (6) The need for computer hardware and software to provide approved matriculation services, and for institutional research personnel for ongoing evaluation.

- (4) Insofar as a district is able to fully implement in-person or technology strategies for orientation, assessment, and education planning services, the board of governors may identify other non-instructional support services that can be funded through the provisions of this Act.
- (c) The board of governors shall require participating colleges to develop a *Student Success and Support Program* plan for student matriculation that reflects all of the following:
- (1) A method for providing description of the Student Success and Support Program services specified identified in Section 78212 to be provided.
- (2) The college budget for the *state-funded Student Success and Support Program services* pursuant to Sections 78212 and 78214.
- (3) The development and training of staff and faculty to implement the Student Success and Support Program matriculation-services.
- (4) In multicampus districts, the coordination of the college *Student Success and Support Program* matriculation plan with other college plans within the district.
- (5) Computerized information Technology services and institutional research and evaluation necessary for implementation of this article.
- (6) Coordination with college student equity plans to ensure the college has identified strategies to monitor and address equity issues and mitigate any disproportionate impacts on student access and achievement.
- (d) The board of governors may allocate up to 5 percent of the total funds appropriated for student matriculation the Student Success and Support Program for state administrative operations to carry out the intent of this article, subject to the review of the annual budget process.
- **78218.** In the *2013-2014* fiscal year and each fiscal year thereafter, this article shall be operative only if funds are specifically appropriated for the purposes of this article.

Proposed SSTF Education Code changes to BOG Fee Waiver:

- 76300. (a) The governing board of each community college district shall charge each student a fee pursuant to this section.
- (b) (1) The fee prescribed by this section shall be thirty forty-six dollars (\$346) per unit per semester, effective with the fall-summer term of the 2011-12 academic 2012 calendar year.
- (2) The board of governors shall proportionately adjust the amount of the fee for term lengths based upon a quarter system, and also shall proportionately adjust the amount of the fee for summer sessions, intersessions, and other short-term courses. In making these adjustments, the board of governors may round the per unit fee and the per term or per session fee to the nearest dollar.

- (c) For the purposes of computing apportionments to community college districts pursuant to Section 84750.5, the board of governors shall subtract, from the total revenue owed to each district, 98 percent of the revenues received by districts from charging a fee pursuant to this section.
- (d) The board of governors shall reduce apportionments by up to 10 percent to any district that does not collect the fees prescribed by this section.
 - (e) The fee requirement does not apply to any of the following:
 - (1) Students enrolled in the noncredit courses designated by Section 84757.
- (2) California State University or University of California students enrolled in remedial classes provided by a community college district on a campus of the University of California or a campus of the California State University, for whom the district claims an attendance apportionment pursuant to an agreement between the district and the California State University or the University of California.
- (3) Students enrolled in credit contract education courses pursuant to Section 78021, if the entire cost of the course, including administrative costs, is paid by the public or private agency, corporation, or association with which the district is contracting and if these students are not included in the calculation of the full-time equivalent students (FTES) of that district.
- (f) The governing board of a community college district may exempt special part-time students admitted pursuant to Section 76001 from the fee requirement.
 - (g) The fee requirements of this section shall be waived for any student who:
 - (1) identifies a degree, certificate, transfer, or career advancement goal,
- (2) meets academic and progress standards, including a maximum unit cap, as defined by the Board of Governors; and
 - (3) meets one of the following criteria:
- (A) At the time of enrollment, is a recipient of benefits under the Temporary Assistance to Needy Families program, the Supplemental Security Income/State Supplementary Program, or a general assistance program;
- (B) Demonstrates eligibility according to income standards established by regulations of the board of governors, or;
- (C) Demonstrates financial need in accordance with the methodology set forth in federal law or regulation for determining the expected family contribution of students seeking financial aid.
- (4) Conditions specified in subsections (1) and (2) shall be phased in over a reasonable period of time as determined by the board of governors

The fee requirements of this section shall be waived for any student who, at the time of enrollment, is a recipient of benefits under the Temporary Assistance to Needy Families program, the Supplemental Security Income/State Supplementary Program, or a general assistance program or has demonstrated financial need in accordance with the methodology set forth in federal law or regulation for determining the expected family contribution of students seeking financial aid

- (2) The governing board of a community college district also shall waive the fee requirements of this section for any student who demonstrates eligibility according to income standards established by regulations of the board of governors.
- (h) The fee requirements of this section shall be waived for any student who, at the time of enrollment, is a dependent, or surviving spouse who has not remarried, of any member of the California National Guard who, in the line of duty and while in the active service of the state, was killed, died of a disability resulting from an event that occurred while in the active service of the state, or is permanently disabled as a result of an event that occurred while in the active service of the state. "Active service of the state," for the purposes of this subdivision, refers to a member of the California National Guard activated pursuant to Section 146 of the Military and Veterans Code.
- (i) The fee requirements of this section shall be waived for any student who is the surviving spouse or the child, natural or adopted, of a deceased person who met all of the requirements of Section 68120.
- (j) The fee requirements of this section shall be waived for any student in an undergraduate program, including a student who has previously graduated from another undergraduate or graduate program, who is the dependent of any individual killed in the September 11, 2001, terrorist attacks on the World Trade Center and the Pentagon or the crash of United Airlines Flight 93 in southwestern Pennsylvania, if that dependent meets the financial need requirements set forth in Section 69432.7 for the Cal Grant A Program and either of the following applies:
 - (1) The dependent was a resident of California on September 11, 2001.
 - (2) The individual killed in the attacks was a resident of California on September 11, 2001.
- (k) A determination of whether a person is a resident of California on September 11, 2001, for purposes of subdivision (j) shall be based on the criteria set forth in Chapter 1 (commencing with Section 68000) of Part 41 of Division 5 for determining nonresident and resident tuition.
- (I) (1) "Dependent," for purposes of subdivision (j), is a person who, because of his or her relationship to an individual killed as a result of injuries sustained during the terrorist attacks of September 11, 2001, qualifies for compensation under the federal September 11th Victim Compensation Fund of 2001 (Title IV (commencing with Section 401) of Public Law 107-42).
- (2) A dependent who is the surviving spouse of an individual killed in the terrorist attacks of September 11, 2001, is entitled to the waivers provided in this section until January 1, 2013.
- (3) A dependent who is the surviving child, natural or adopted, of an individual killed in the terrorist attacks of September 11, 2001, is entitled to the waivers under subdivision (j) until that person attains the age of 30 years.

- (4) A dependent of an individual killed in the terrorist attacks of September 11, 2001, who is determined to be eligible by the California Victim Compensation and Government Claims Board, is also entitled to the waivers provided in this section until January 1, 2013.
- (m) (1) It is the intent of the Legislature that sufficient funds be provided to support the provision of a fee waiver for every student who demonstrates eligibility pursuant to subdivisions (g) to (j), inclusive.
- (2) From funds provided in the annual Budget Act, the board of governors shall allocate to community college districts, pursuant to this subdivision, an amount equal to 2 percent of the fees waived pursuant to subdivisions (g) to (j), inclusive. From funds provided in the annual Budget Act, the board of governors shall allocate to community college districts, pursuant to this subdivision, an amount equal to ninety-one cents (\$0.91) per credit unit waived pursuant to subdivisions (g) to (j), inclusive. It is the intent of the Legislature that funds provided pursuant to this subdivision be used to support the determination of financial need and delivery of student financial aid services, on the basis of the number of students for whom fees are waived. It also is the intent of the Legislature that the funds provided pursuant to this subdivision directly offset mandated costs claimed by community college districts pursuant to Commission on State Mandates consolidated Test Claims 99-TC-13 (Enrollment Fee Collection) and 00-TC-15 (Enrollment Fee Waivers). Funds allocated to a community college district for determination of financial need and delivery of student financial aid services shall supplement, and shall not supplant, the level of funds allocated for the administration of student financial aid programs during the 1992-93 fiscal year.
 - (n) The board of governors shall adopt regulations implementing this section.
- (o) This section shall be inoperative and is repealed on May 1, 2012, only if subdivision (b) of Section 3.94 of the Budget Act of 2011 is operative.
