## **Types of Vouchers**

**Institutional Vouchers:** Arizona State Schools for the Deaf and the Blind (ASDB) A.R.S. § 15-1201, "Institution" means the Arizona State Schools for the Deaf and the Blind, the Arizona training program facilities as provided in section 36-551, and the Arizona State Hospital.

**Residential Vouchers:** Residential Treatment Centers (RTC) Students placed by state agencies and IEP teams into ADE approved RTCs.

ESS Vouchers are different from the Empowerment Scholarship Account (ESA).

## **Changes with ASDB**

Due to the passage of <u>HB 2863</u> during the Spring 2021 legislative session, the Arizona State Schools for the Deaf and the Blind (ASDB) is now considered a local education agency (LEA) for the provision of free and appropriate public education (FAPE).

HB 2565 (2022) provided additional clarification, specifically to A.R.S. 15-1306 and 15-1342.

## **Approving an Institutional Voucher**

- By approving and validating the voucher, you are aware that the student is receiving services from ASDB through an Institutional Voucher. Approval passes responsibility to ASDB for their campus-based students and shared locations.
- For students attending in your district or charter (Regions 1, 2, and 3), the district or charter is responsible for reporting. At <u>ASDB Student Reporting</u>, you will find additional information.
- A current IEP and evaluation are required for a voucher application to be approved.

Once approved by ADE, the application is valid until the end of the fiscal year (6/30/2024).

State Placing Agency (SPA) Residential Treatment Center (RTC) Home School District (HSD) Arizona Department of Education (ADE) ESS Vouchers

## **The Process**

- A SPA places a student into an RTC for care, safety, or treatment purposes.
- The RTC sends an Initial Application to the HSD within 5 days of entry to the RTC.
- The HSD approves the Initial Application (verifying they are the correct HSD). The HSD then has 60 days from the student's date of entry to the RTC to complete a Home School District Education Voucher Application with the required statutory documents (Child Find).
- The ESS Vouchers team reviews the application/documents. If approved, the student's funding is authorized for the remainder of the fiscal year (6/30/2024).

## **Process Change in FY25**

- State Placing Agencies (SPA) will submit the Initial applications beginning on 7/1/2024 (FY25).
- This change is aligned with state statutes.
- SPAs will have more detailed information on students, including legal guardianship information.

- · Home School Districts only need the role of ESS Vouchers: HSD User
- · State Placing Agencies only need the role of ESS Vouchers: SPA User
- Institutional/ASDB only need the role of ESS Vouchers: Institutional User

## **Required Documents for HSDs**



#### Required Documents for Home School Districts

#### Last Updated 4/24/23

Your Multidisciplinary Evaluation Team (MET) should determine if the student is currently receiving special education services, if not the MET must complete a Review of Existing Data. Signing the Initial Application is the responsibility of the Home School District. You must then complete a Home School District (HSD) application and upload the required documents (within the HSD application) in ADE Connect/ESS Portal/ESS Vouchers within 60 days of the student's entry to the Residential Treatment Center (RTC).

- Convene MET meeting
- Review existing data, gather additional data (if needed), determine eligibility (Child Find)

#### Minimum required documents for students not eligible for special education services:

- MET Report/Review of Existing Data (RED)
- PWN for the Referral/Evaluation
- Non-Eligibility Determination
- PWN for Non-Eligibility
- MET participant names

If the student is referred for further evaluation, then determined eligible for special education services, write an IEP with appropriate services in the least restrictive environment with the participation of the RTC and upload the required documents in an ESS Vouchers HSD application in ADE Connect.

Minimum required documents for students receiving special education services:

- MET Report
- MET participant names
- PWN for the MET evaluation
- Eligibility Determination
- PWN for Eligibility
- IEP with participant names
- PWN for IEP must indicate change of placement to the RTC and that it will be implemented there

## **Residential Voucher Numbers**

- Approximately 1500 students are placed in ADE approved RTCs each year.
- 55% of students are determined NSE (Non-Special Education).
- 45% of students are SPED/CSE (Care Special Education).
- Less than 1% are RSE (Residential Special Education), which is an IEPdriven placement.

## **Funding Categories**

**NSE:** (Non-Special Education) Student is not eligible for special education, placed in a residential facility for care, safety, or treatment reasons.

**CSE:** (Care Special Education) Student is eligible for special education, placed in a residential facility for care, safety, or treatment reasons.

**RSE:** (Residential Special Education) Student is eligible for special education and requires a residential facility for education reasons.

## **Residential Special Education (RSE) Placement**

RSE placement is an IEP driven placement.

#### **RSE process differences:**

- HSD needs to contact ADE if the IEP team determines that an RTC is the Least Restrictive Environment (LRE).
- The IEP team must include the ACC-RBHA. The ACC-RBHA will conduct a behavioral health assessment and submit the recommendation to AHCCCS.
- Placement must be in an ADE approved RTC. The documentation must be approved by ADE prior to placement at the RTC.
- The IEP must include exit criteria and a reintegration plan.

#### Home School District Is Defined Under A.R.S. 15-761(9)

"Home school district" means the "age-appropriate" school district or charter school that the child last attended or, if the child has not previously attended a public school in this state, the school district in which the person resides who has legal custody of the child, as provided in section 15-824, subsection B. If the child is a ward of this state and a specific person does not have legal custody of the child, or is a ward of this state and the child is enrolled in an accommodation school pursuant to section 15-913, the home school district is the district that the child last attended or, if the child has not previously attended a public school in this state, the school district within which the child currently resides.

## **Children Who Are Wards of the State**


If a specific person does not have legal custody of the child and parental rights have been severed, the child is a ward of the state. To meet the best interest of the child within Every Student Succeeds Act (ESSA), if a parent still retains educational rights, the child is not considered a ward of the state in terms of the flowchart.


## **Flowchart for Determining the HSD**

## **Answer 2**

## Home School District

A.R.S. §15-1183. "Responsibility for monitoring the educational services during the time a child is placed in the residential facility and for planning for the transition from the private residential facility to a public school remains with the home school district."

Monitoring the educational services includes keeping the IEP and evaluation current while the student is at the RTC. The PEA is also responsible for reporting all students in their Student Information System (SIS).

# **60 days** from date of entry to the RTC (unless an extension is approved for ADE-approved reasons)

## **Answer 4**



The RTC representative is part of the team and needs to provide input into the evaluation as per A.R.S. §15-765. Although an RTC representative must provide information for the evaluation, a writing section is not required from the RTC.
