ERASMUS+: ANOTHER RECORD YEAR IN 2017



In 2017, the EU invested a record €2.6 billion in the programme, which represents an increase of 13% compared to 2016. This made it possible to provide more opportunities for young people than ever before. The figures show that Erasmus+ remains well on track to meetits target of supporting 3.7% of young people in the EU between 2014 and 2020. The report also highlights that the programme is becoming more open for people from disadvantaged backgrounds as well as smaller organisations.

Support for the programme has never been stronger. During a successful campaign in 2017 to celebrate 30 years of Erasmus, more than 750,000 people took part in 1,900 events in 44 countries, highlighting the role of Erasmus+ and its predecessors in enabling young people to develop their competences and experience what it feels like to be European.

Erasmus+ and its predecessors are among the most successful EU programmes. Since 1987, they have been offering young people in particular opportunities to gain new experiences by going abroad. The current Erasmus+ programme, running from 2014 to 2020, has a budget of €14.7 billion and will provide opportunities for 3.7% of young people in the EU to study, train, gain work experience and volunteer abroad. The geographical scope of the programme has expanded from 11 countries in 1987 to 33 currently (all 28 EU Member States as well as Turkey, the former Yugoslav Republic of Macedonia, Norway, Iceland and Liechtenstein).

MONTENEGRO: A LAW ON ACADEMIC INTEGRITY SOON TO BE ADOPTED



Montenegro stands out as the first country in the Balkan region to regulate academic integrity by a specific law, which has been recently drafted by the Ministry of Education. This drafted Law aims at preventing plagiarism and raising awareness on all forms of violation of academic integrity, as well as at promoting academic and democratic values in higher education. In order to directly deal with these issues, an Ethics Committee will be created.

After being approved by the Government, the draft Law has been referred to the Parliament where the adoption procedures are currently undergoing.

The Council of Europe assists relevant authorities in Montenegro to improve the quality of education through applying preventive mechanisms based on Council of Europe standards and practices. Two actions on education are being implemented in partnership with the Ministry of Education while involving a wider group of relevant stakeholders, including University of Montenegro, Bureau for Education Services, Agency for Anti-Corruption, education policy and research institutes, academics, NGOs, pilot schools and teacher training organisations.

EU NEGOTIATORS REACH A BREAKTHROUGH TO MODERNISE COPYRIGHT RULES



The political agreement reached today will adapt copyright rules to today's world, where music streaming services, video-on-demand platforms, news aggregators and user-uploaded-content platforms have become the main gateways to access creative works and press articles. The agreement needs now to be confirmed by the European Parliament and the Council of the EU in the coming weeks.

Users will benefit from the new licencing rules which will allow them to upload copyright protected content on platforms like YouTube or Instagram legally. They will also benefit from safeguards linked to the freedom of expression when they upload videos that contain rightholders' content, i.e. in memes or parodies. The interests of the users are preserved through effective mechanisms to swiftly contest any unjustified removal of their content by the platforms.

The agreement is a part of a broader initiative to adapt EU copyright rules to the digital age. In December 2018, EU colegislators agreed on new rules to make it easier for European broadcasters to make certain programmes available on their live TV or catch-up services online. And since 1 April 2018, Europeans who buy or subscribe to films, sports broadcasts, music, e-books and games in their home Member State are able to access this content when they travel or stay temporarily in another EU country.

Moreover, due to various application domains, teamwork, creativity and entrepreneurial skills are required for the design, programming and innovative exploitation of robots and robotic services.

Children are fascinated by such autonomous machines. This fascination and the variety of fields and topics covered make robotics a powerful idea to engage with. Young girls as well as boys can easily connect robots to their personal interests and share their ideas through these tangible artefacts.

EUROPEAN CITIZENS' INITIATIVE: COMMISSION REGISTERS 'EUROPE CARES - INCLUSIVE QUALITY EDUCATION FOR CHILDREN WITH DISABILITIES' INITIATIVE







The objective of the initiative is to ensure: "the right to inclusive education of children and adults with disabilities within the European Union". The initiative states that while "over 70 million EU citizens have a disability and 15 million children have special educational needs" many "are facing excessive barriers in [...] their right to quality inclusive education". The organisers therefore call on the Commission to "draft a bill on a common EU framework of inclusive education, which will ensure that no child is left behind when it comes to early intervention services, education and transition towards the labour market". Under the Treaties, the EU can take legal action aimed at combatting discrimination based on disability as well as support Member States' efforts when it comes to education systems and vocational trainings. The Commission therefore considered the initiative legally admissible and decided to register it. At this stage in the process, the Commission does not analyse the substance. The registration of this Initiative will take place on 4 March 2019, starting a one-year process of collection of signatures of support by its organisers. Should the initiative receive one million statements of support within one year, from at least seven different Member States, the Commission will analyse it and react within three months. The Commission can decide either to follow the request or not, and in both instances would be required to explain its reasoning.

EUROPANA TELLS US WHO INVENTED THE BREAD



What is the real palaeo diet, and who invented bread? Archaeological findings on eating and drinking in the past.

Archaeology can give great insight into what processes

have made us the humans we are today. Seemingly small things have hugely influenced our contemporary lives, and maybe the most important one is the invention of cooking. Richard Wrangham, professor of biological anthropology, in his book, Catching Fire: How Cooking Made Us Human, describes how cooking reduced the caloric cost of digestion and increased the efficiency of food consumption. According to Wrangham, homo erectus (who lived between about 1.89 million and 143,000 years ago), evolved to develop a smaller, more efficient digestive tract that freed up the energy to enable brain growth.1 This was thanks to Homo Erectus being able to cook their food, setting the stage for modern

Finally, the golden bear was awarded to the Romanian film 'Touch me not' by Adina Pintilie.

NATURE, CULTURE AND GOVERNANCE: THE RELATIONSHIP BETWEEN CHINA AND EUROPE



By studying the exchanges of landscape art, one EU supported researcher not only examined the 'object' of the exchange processes, but how that exchange was conducted between societies and cultures.

Debate about the relations between Chinese and European landscape art is not new. Since the 18th century, whether the English or European landscape gardens were 'influenced' by the Chinese gardens has frequently been the subject of argument. Earlier debates were often limited to aesthetics alone, without engaging the larger social and political context. The Nature Entangled project is looking at this broader picture thanks to support from a Marie Curie fellowship.

he lesson from this study, as explained by Dr Zhuang, is that everyone's moral and cultural cultivation is just as important as technological development. In particular, 'nature' should not be treated in the modern, Western sense as an alienated 'natural world' that can be conquered and 'improved' by technology. "Rather, it is more apt to think of a Confucian concept of nature – a process of life and regeneration in which humanity considers its own responsibility to assist and nourish."

While the Nature Entangled project is mainly a historical study, the methodology applied to the study of contemporary discourses, such as the idea of 'eco-cities', involved field work along with visual analysis, cultural studies, and interviews in situ.

ALETTA JACOBS: THE DRIVING FORCE OF THE MOVEMENT FOR THE RIGHT TO VOTE OF WOMEN



Europeana and Mariya Gabriel, European Commissioner for the Digital Economy and Society, are proud to present the Pioneras online exhibition, which is part of the strategy of Commissioner Mariya Gabriel to empower women and increase their participation in the digital economy. It seeks to raise awareness about the historical contributions of women to society and provide a platform for the representation of emblematic professional women in Europe.

100 years ago, women in the Netherlands won full suffrage: the right to stand for election combined with the right to vote. Aletta Jacobs was one of the women involved in that process who had a profound impact on Dutch society. She was a driving force behind the women's rights movement in the Netherlands and the world. She was the first Dutch woman to receive a university diploma, the first to become a doctor, and the first to receive her doctorate. She was also a figurehead for the 'first feminist wave', fighting for women's right to vote. She was an example for women everywhere.

Jacobs passed away on 10 August 1929. Her funeral was well attended and filmed for the newsreels. Apparently, shortly before her death, Jacobs had lamented that, 'There is still so much to do in the world.'
