## Function

### Power Button

Press and hold the button for 3 seconds to turn the device on / off.

### Status LED Indicator

Red: Power On, Red (Flashing): Recording, Blue: Charging

### File Protect / Wireless Link Button

#### File Protect

Simply press the button to protect the current video file from overwriting.

#### Wireless Link

Press and hold for 3 seconds to turn on the Wireless Link function, this is not available while recording or during playback.

### Menu Button

Press this button to open the menu of the current mode. Press this button twice to enter the general setting menu.

### Record / OK Button

#### Record

In Video mode, press to start or stop recording. / In Photo mode, press to take a photo.

#### OK

The confirm button used to select options in menus.

### Mode / Screen Shot Button

#### Mode

This button allows you to navigate between video, photo and playback modes.

#### Screen Shot

While you are recording in video mode, press the button and you will be able to take a screenshot of the current frame.

### Reset Button

On the rare occasions the device has a problem, use the reset button to shut down the device. Simply press the reset until the device turns off and press power button to turn on.

# In-Vehicle Installation

---

## 1. Insert microSD Card Into The Dash Cam

The dash cam supports class 10 or above microSD card with 8GB to 256GB capacity. Follow the symbol as directed to insert the SD card. Do not remove or insert the memory card while the device is turned on. The microSD card is inserted as factory shipment condition.

## 2. Install Circular Polarizer Filter

Align the threaded side of the polarizer filter with device and turn it clockwise to make sure the rotation is smooth along the threaded metal area. Rotate the polarizer filter outer metal ring clockwise and align arrow mark on the polarizer lens with the arrow mark on the device.

## 3. Connect The Dash Cam To The Magnetic Mount

Make sure you align the camera within the connector port for proper installation.

## 4. Attach The Mount To The Windshield

Select a location on the windshield within wiping range where won't distract you. Then, put the suction mount in place and lock the mount.

## 5. Connect To Car Power Outlet

Connect the cigar lighter adapter cable that is in the package to your vehicle's 12 V outlet. The vehicles ignition will let the camera turn on and record while connected to your vehicles 12 V outlet. When the vehicle is turned off, the camera will automatically shut down.

## 6. The First-Time Setup

When connecting the power, the dash cam will turn on and display the first-time setup. Please set your language, country, time zone, time and date etc.

## 7. First Time Use SD Card Format

When the SD card is inserted into the device for the first time, the device will ask you to format the card.

## 8. Start Recording Automatically

After formatting the card, the dash cam will start recording and you are all set.

# Feature & Support

---

## Parking Mode

Access the VIDEO MENU by pressing the MENU button while in VIDEO MODE, and then turn the Parking Mode Sensor setting to On.

In parking mode, the device will stay in a standby mode in conjunction with our hardwire kit CA-DR1030 (optional accessory). It can detect an impact above the normal level, recording events that could damage your vehicle. Also, the hardwire kit has an automatic power cutoff function. When the device detects that the car battery is below a certain level, it will cut off power to prevent draining the battery.

## KENWOOD DASH CAM MANAGER Smartphone App

"KENWOOD DASH CAM MANAGER" is a smartphone app for displaying video recorded with the device. It can be used to review data and videos of the latest KENWOOD dash cameras. Download and install the app from App Store(iOS) / Google Play(Android) on your mobile device.

### How to Connect:

1. Long press the Wireless Link button on the device and enter the connecting mode.(Make sure the dash cam is not recording)
2. Open the KENWOOD DASH CAM MANAGER of the smartphone app.
3. Press the Connect button and select from the network list to pair the dashboard camera device.
4. Enter the Wireless Link password into the input field.
5. Connect completed, press the Continue button into the main screen of app.

- Recording resolution might be changed automatically to continue the recording avoiding the possible overheat in the high temperature.

## Precautions for installation

- Install the device in a position where it will not block the front view of the driver (position where hidden by the rear-view mirror).
- Install the device so that it is within the wiping range of the wiper.
- Install the device in a position where it will not interfere with the movement of the rear-view mirror.
- Take care not to install the device over the vehicle inspection sticker or other sticker.
- Take care not to install the device where it will interfere with driving or airbag operation.
- When installing the device in a vehicle equipped with a driving support system, check the instruction manual of the vehicle and then select an installation position that will not interfere with the driving support system.
- If the device is installed incorrectly, event recording or parked recording may not work correctly.
- Refer to "Installation and Connection" for the loosening of fixing knob, installation orientation, installation angle, and other information and then install the device correctly.
- Do not install the device near a digital terrestrial television antenna or an electrical component.
- Doing so may reduce television receiver sensitivity or cause flickering and noise.
- When selecting a position for the suction mount, make sure it's on a glass surface that is smooth and free of paint.
- Before mounting, clean the area with a dry/clean cloth and add a small amount of moisture to the windshield. This allows a stronger bond to form between the glass and the suction mount.
- When fixing the device with the adhesive mount, use a commercially available cleaning cloth or the like to wipe off all dirt and grease on the mounting surface. If the device is re-affixed or mounted using, for example, general-purpose double-sided tape, the adhesion strength may weaken and cause the device to fall.
- After mounting the device, leave it for 24 hours before use to enable the mounting strength of the adhesive mount to improve. Failing to do so may result in the adhesion of the adhesive mount becoming weak and the device falling.

While most cameras traditionally use the entire capacity of the SD card until it is removed, the device automatically deletes the oldest file to create space for the new video.

Dashboard camera offers three modes:

1. Video Mode: Video mode will set to default when the device is active.
2. Photo Mode: The device setting takes still photographs.
3. Playback Mode: Users can view all previously recorded videos and photos taken.

## Troubleshooting

Blurred Image (Video)	The device comes with a protective lens cover for the camera lens, be sure to remove it. Wipe the lens with a soft cloth until any debris/stains are removed. Clean your vehicles windshield where the camera is placed.
Unable to insert SD card	Make sure the metal portion of the memory card faces the screen side. Once inserted, push the card until a CLICK sound is heard.
SD card does not release from the devices	The device releases the SD Card by pressing the SD card forward. By applying the pressure on the SD card, a small click sound will be made. If you are unable to remove the SD card, use the edge of a small coin to push forward until the click sound is made.
Video files can not be played	The device video files are recorded in .MOV format. These files may not be played on your computer if you do not have a suitable video player installed.
Video files jump when they are being played	The memory card that the device recommends for best quality is the UHS type 3 SD Card. If your computer does not recognize the video files, try another computer to view the recorded video. 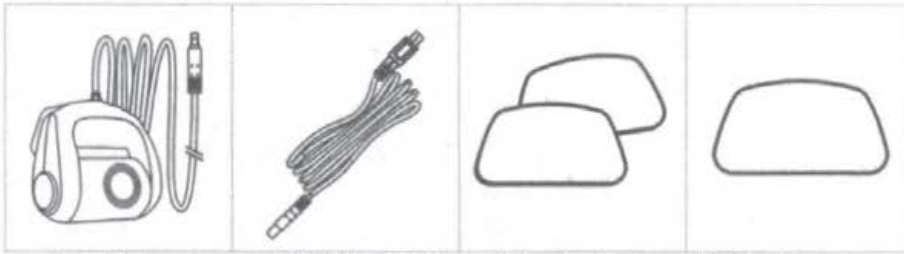

Wiping the device with a hard cloth or using a volatile substance such as thinner or alcohol may cause scratches, deformation, deterioration or other damage.

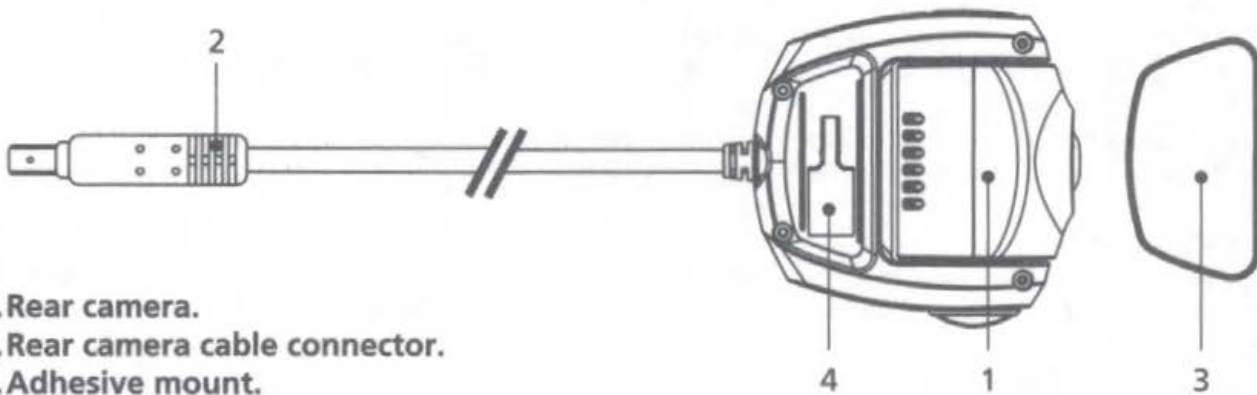

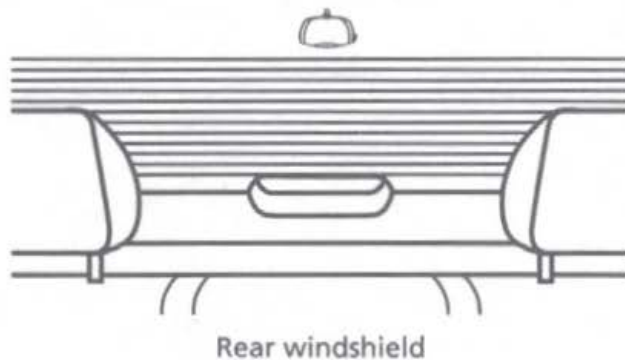
### Recommended installation position

- Install the device in a position where it will not block the view of the driver.
- Install the device within the wiping range if equipped the wiper.

### ⚠ Caution

When passing the power cord through the front pillar or another part, observe the points below when performing the wiring work.

- Wire the power cord farther forward or farther rearward than the airbag so that it does not interfere with the airbag.

Start the engine to power up the rear cam, then turn on Wireless Link mode to connect with mobile device. Using the App to view the image and adjust the installation position.

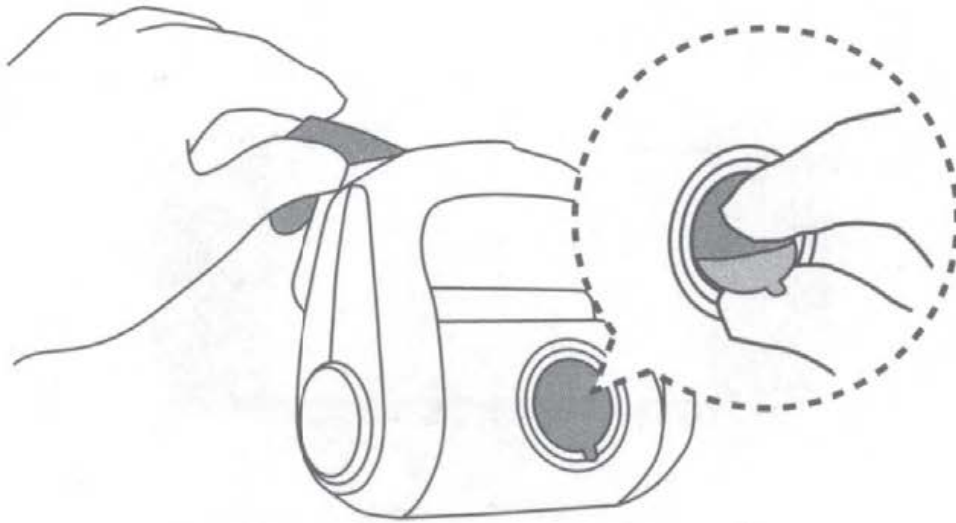

### 1.5 Putting on an adhesive mount

After selecting the best installation position and angle, remove (3) Adhesive protective film and protective lens film, stick it on the rear windshield, keep press and add pressure for 30 seconds.



#### TIP

- Make sure that Cable can be connected at the installation location.
- Windshield should be thoroughly cleaned and mounting area is wiped dry and at room temperature before applying the adhesive (Avoid under direct sunlight).
- Allow 24 hours to get the best adhesion effect.

### 1.6 Evaluate Cable Routing Location

Installation of the rear camera cable needs careful planning for the cable run and the final position of the camera within the vehicle. See the device manual for optimum front dash camera position. Study the vehicle for the most appropriate cable run towards the front windshield.

### 1.7 Cable Installation

Tucking the cable into the headliner of the vehicle and hide exposed cable to pillar trim and rubber strips, use a panel removal tool to loosen any trim and hide the cable if necessary.

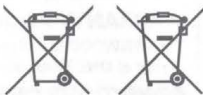
