You will recall that one of the recommendations of the most recent Master Plan Reexamination Report was to consider the adoption of a Green Buildings and Sustainability Plan Element of the Fanwood Borough Master Plan. This plan element, which was recently added to the NJ Municipal Land Use Law, is an optional element and identifies the following:

...which shall provide for, encourage, and promote the efficient use of natural resources and the installation and usage of renewable energy systems; consider the impact of buildings on the local, regional and global environment; allow ecosystems to function naturally; conserve and reuse water; treat storm water on site; and optimize climatic conditions through site orientation and design.

Please review the enclosed proposal and advise if the proposed scope of services addresses the Board's satisfaction. If appropriate, the proposal can be transmitted to the Borough Council for further review and consideration.

#### INTRODUCTION

T&M Associates is pleased to submit this proposal for a Green Buildings and Environmental Sustainability Plan Element of the Borough of Fanwood Master Plan. The purpose of a Green Buildings and Environmental Sustainability Plan Element is to provide a framework for Ordinance amendments to increase green buildings, through new construction or renovations, and encourage environmental sustainable actions in the Borough by the municipality and through changes in land use and transportation and reduction of waste and energy use. Municipal facilities and operations will be addressed.

- D. Review Potential Regulations and Sustainable Measures
  - Listing of measures to encourage green buildings in the private sector.
  - Actions to address sustainability of municipal facilities.
  - Overview of sustainable measures addressing land use, transportation, energy and waste.
  - Listing of activities in other municipalities.
- E. Establish Targets and Benchmarks

Quantitative targets are important to be able to measure progress toward the Borough's goals.

F. Action Plan.

Prepare an action plan of short term and long term measures, ranked by priority, listing the responsible party and cost category.



#### Meetings and Hearings

T&M Associates will attend two Planning Board meetings in connection with this project. The first meeting will be a workshop session with representatives of the Borough and the Planning Board to review the draft report and discuss necessary revisions. The second meeting will be the public hearing.
