- Plan is to have at the CND 2014 launch of the system; pilot operation scheduled for Q4/2013


















Welcome to International Import/Export System

INCB proposes a new system which should serve as a platform to speed up and facilitate data exchange between importing and exporting countries and the INCB, on the approval and endorsement of individual transactions, and eventually to replace the paper system which is currently being used by many countries.

The initial phase should allow at least data exchange and the generation of electronic import/export certificates, with the basic security features in place, although not yet abolishing the paper certificate systems currently in use (and required under international conventions and some national laws).




