Gift, for the service of the donee and 8/-, of 9 profitable strips of land in the field of Northway [in Ashchurch], lying together in the ploughland called 'The Hill' towards the east, and in length from 'middelforlung' towards the waters of 'Karent' (Carrant Brook), paying annually 121b of cumin in 'Theoky' (Tewkesbury) at Michaelmas, for all services. (Imperfect).
