




Light toning, horizontal and vertical fold lines, a few small holes and tears just starting along fold lines, text not affected, residue from wax seal and tear to final leaf not affecting address or docket. * Compiled over the course of the term, this volume is comprised of a list of 73 cases on the docket for the Glasgow Circuit Court of Justiciary in September 1829 followed by records for 72 of those cases. The records consist of a short summary of the indictment along with a list of witnesses and jury members, if applicable. Each record is individually paginated and docketed in print on the verso of the final leaf, suggesting that they were issued individually as the term progressed and bound later for the reference of judges and advocates.

In private practice, one of Alison's cases involved the aftermath of the bankruptcy of James Auchie and Company, a merchant firm incorporated in Jamaica as Dollar, Auchie and Company. The company declared bankruptcy in Glasgow in 1812, triggering many suits by creditors and counter-suits by the company's accountants. One of these accountants was William Carrick, whom Alison represented at least once in 1822 and likely afterwards. In this letter, a Jamaican attorney declines to involve himself in the case, saying "I never in my life saw any business so mismanaged" and that "it would only be throwing away good money after bad to take it into a Court of Law." The letter, laid-in to the compilation volume, was likely given to Alison as part of his work for Carrick and the Dollar estate.



* First edition. According to Walker, Arnot's work contains the only accounts of many trials otherwise unknown. Contents include chapters on treason, murder, piracy, forgery, incest, adultery, blasphemy, witchcraft and crimes against religion and the state among others. With a twelve-page list of over 800 subscribers that includes the Prince of Wales, Adam Smith, Thomas Erskine, Lord Chancellor Thurlow and many other luminaries.



"Meditatio Fugae is an old principle of Scots law that if a creditor could make an oath that his debtor was in meditatione fugae to avoid payment of his debt, he may apply to a magistrate who may grant warrant for apprehending the debtor for examination, and subsequently, grant warrant to imprison the debtor until he finds caution judicio sisti" (Walker). OCLC locates no copies in North America; copies located at the Library of Congress and Harvard Law School.



* Second edition. A lawyer and man of letters, Bayne studied law in Edinburgh and Leiden. He lived in London for several years and was friendly with Richard Steele and other literary figures. He also had a strong interest in music. His *Institutions* was a companion volume for a course of lectures at the University of Edinburgh. The first edition was published in 1730. Both editions are scarce. OCLC locates 7 copies of the second edition, 2 in North American law libraries (UC-Berkeley, Harvard).





* Only edition. With side-notes. This treatise is notable because it reflects contemporary debates about the extension of suffrage. An important figure in the history of Scots law, Bell was an advocate and professor of conveyancing to the Society of Writers to the Signet. He is known today as the author of *The Dictionary of the Law of Scotland* (1807) and several other treatises on Scots law, especially leases and conveyancing. OCLC locates 4 copies, 3 in North America (at Thomas Fisher Rare Book Library, Ontario, Cornell University and Georgetown University Law Library).



This book has a great deal of information about gild courts and the regulation of international commerce.







* Compiled over the course of the term, this volume is comprised of a list of 77 cases on the docket for the Glasgow Circuit Court of Justiciary in May 1827 followed by records for 72 of those cases. The records, typically 5-8 pp. in length, consist of a short summary of the indictment along with a list of witnesses and jury members, if applicable. Each record is individually paginated and docketed in print on the verso of the final leaf, suggesting that they were issued individually as the term progressed.

The list of cases and many of the records are annotated by Lord Alloway, a Scottish lord of session appointed to the Justiciary Court in 1826. The charges range in severity from murder to petty theft. Almost certainly rebound by Alloway for his future reference, this handsome volume is a fascinating glimpse of the work of a nineteenth-century court in Scotland from a judge's perspective. Compilation volumes like these were created for the personal use of judges and advocates and are quite scarce. OCLC locates 6 copies of compilations from the Glasgow Justiciary Court, 5 at the University of Glasgow and 1 at Harvard, none of which match ours.



* First edition. This was the first Scottish book of precedents, or, to use the Scots term, Styles. According to Walker, *System of Stiles* was "long indispensable in Scottish legal offices." A second edition in two volumes was published in 1774. Stuart, 2nd Earl of Bute [1696-1723] was the father of John Stuart, 3rd Earl of Bute, the advisor to King George III who was Prime Minister from 1762 to 1763.



* Only edition, one of four issues from 1718. In this pamphlet Dalrymple, then the Queen's advocate in Scotland, refutes the argument advanced in a pamphlet by the Scottish advocate Patrick Haldane. Haldane's pamphlet questions the ability of the Scottish legal system to resolve the financial consequences that followed the forfeiture of estates after the Jacobite Rebellion of 1715 and calls for emergency legislation to facilitate the claims of creditors.





Davidson, a lawyer and well-regarded antiquarian, provides a richly detailed critical survey of early editions of the laws of Scotland from the manuscript compilations of the 11th century (likely spurious) to the printed editions of 1566 and 1597. 



* Second edition. Esteemed for its erudition, clarity and accuracy, Erskine's *Institute* was one of the definitive authorities on Scots law. Rich in sociological detail, it includes laws on such topics as witchcraft, sodomy and bestiality, adultery, dueling and gypsies A durable work, it was first published in 1773 and went through four more authorial editions and four later editions by other authors, the last (eighth) in 1871.



* Second, final and best edition. First published in 1703, the *Methodical Treatise Concerning Bills of Exchange* was the first work on the subject published in Scotland. The second edition is preferred because it is a corrected and expanded work that reflects changes brought about by the Act of Union (1707), the act that united England and Scotland under the name of Great Britain. Forbes was the first Professor of Civil Law at Glasgow University.







* First edition. This was Kames's last major legal work. "As my intention is only to give examples of reasoning, free from the shackles of authority, I pretend not to say what our law actually is, but what it ought to be" (xiii). The leading Scottish jurist of his day and an important figure of the Scottish Enlightenment, he was an influence on David Hume, James Boswell and Adam Smith. The second and final edition of *Elucidations* was published in 1800.



MacKenzie "became notable for his resistance to the pretensions of the Crown, but in 1677, he was made Lord Advocate and in the next few years prosecuted and persecuted Covenanters with such zeal as to earn the title "The Bloody Mackenzie.' In many cases he strained the law so as to obtain a conviction" (Walker). He is also well-known for having founded the Advocates Library, now the national law library for Scotland. 

* Robert Alfred Cathcart was, like several other members of his family, an Edinburgh lawyer and member of the Society of Writers to her Majesty's Signet. The catalogue is an interesting glimpse into the lives of lawyers practicing in this time, showing what a wealthy lawyer's library might contain - in this case some 150 legal and 200 other works. The works are organized into "Law Books," "Medical Works," and "Miscellaneous Works." Among the legal texts are a manuscript copy of Baron Hume's Commentaries on the Law of Scotland Respecting Trial for Crimes (1819) and quite a few works on Roman law. Medical works cover the fundamentals of anatomy and pathology. Cathcart may have relaxed at the end of a long day with The Arabian Nights' Entertainment (1843) or The Mysteries of Paris (n.d.). The catalogue captures a unique snapshot of what a young nineteenth-century Scottish lawyer at the beginning of his career deemed the essentials of daily reference and practice.





* This manuscript is a carefully organized precedent book, known in Scots law as a style book, detailing cases heard between 1763 and 1764 at the Scottish Court of Session. It is written in two hands. The first hand provides a brief summary of the details of the case along with an extensive list of relevant precedents. The second hand lists the outcomes of the cases, usually briefly but sometimes at length. The latest date in the second hand is June 1764. Both hands provide marginal citations, perhaps corresponding to another volume of precedents. The cases, heard before Lords Auchinleck, Kames and Nisbet, among others, cover a broad range of topics in civil law, including property and inheritance, libel, bonds, rights of way and possession and breach of promise. Perhaps composed by a law student or young practitioner, the book provides an interesting and detailed look at the Scottish legal system in the eighteenth century.









The volume, however, never obtained a great share of public favor, and is now rarely consulted" (Marvin). Millar was the son of the jurist John Millar [1735-1801]. When her parents found a more suitable match, she attempted to break the relationship, but he threatened to use their love letters to expose her if she did not marry him. He died from arsenic poisoning a month after making his threat. Smith, who had been seen purchasing arsenic, was arrested and charged with his murder after the pair's love letters were discovered. Although the circumstantial evidence against her was strong, there was some suspicion that L'Angelier had committed suicide. The jury ultimately returned with a verdict of "not proven."
