In accordance with 10 CFR 50.4(b)(4), "Security plan and related submissions," and 10 CFR 50.54(p)(2), "Conditions of licenses," Florida Power and Light Company (FPL), the licensee for St. Lucie Nuclear Plant, Units 1 and 2, and Turkey Point Nuclear Plant, Units 3 and 4, and FPL Energy Seabrook, LLC (FPL Energy Seabrook), the licensee for Seabrook Station, hereby submit Revision 1 to the Florida Power and Light Company & FPL Energy Seabrook Physical Security Plan, Training and Qualification Plan and Safeguards Contingency Plan. The effective date of Revision 1 is June 30, 2005.

Florida Power & Light Company and FPL Energy Seabrook have concluded that these changes do not decrease the safeguards effectiveness of the Physical Security Plan, Training and Qualification Plan, and Safeguards Contingency Plan.
