VOTES AND PROCEEDINGS

OF THE

LEGISLATIVE COUNCIL.

FRIDAY, 28 SEPTEMBER, 1855.

1. Council met pursuant to adjournment; the Speaker took the Chair. Claims against Government Bill:—Mr. Nichols moved, pursuant to notice, for leave to bring in a Bill to give relief to persons having claims against the Government of New South Wales.

Question put and passed; - Ordered, That the Mover and Seconder prepare and

bring in the Bill.

2. Government Debentures: -Mr. Cowper moved, pursuant to notice, That an Address be presented to the Governor General, praying that His Excellency will be pleased to cause to be laid upon the Table of this House, a Return shewing the amount of Debentures issued up to the 14th September, 1855, (the day upon which the Royal Assent was given to the Public Works Loan Bill,) specifying the time when such Debentures will fall due, and the services for which they were issued, and distinguishing the amount raised upon the security of the General and Territorial Revenues respectively.

Debate ensued.

Question put and passed. 3. Crown Land Sales:—Mr. Cowper moved, pursuant to amended notice, That an Address be presented to the Governor General, praying that His Excellency will be pleased to cause to be laid upon the Table of this House,—

(1.) A Return shewing the amount paid from the date of the last Return, to 30th June, 1855, to each of the Commissioners of Crown Lands appointed for the purpose of conducting Crown Land Sales, under the Regulations of 8th March, 1853, as

Commission for conducting such sales of land.

(2.) A Return of the quantity of Crown Land sold, and the amount realized in each particular District, between the 1st April, 1854, and 30th June, 1855, under the Regulations of 8th March, 1853.

Debate ensued.

Question put and passed.

4. Mrs. Johanna Toele:—Mr. Murray presented a Petition from Mrs. Johanna Toele, representing that by the Defalcations of Mr. Gray, late Clerk of Petty Sessions at Major's Creek, she had lost various sums of money left by her in his custody, and praying relief.

Petition received

5. Mr. C. G. Gray's Defalcations:—Mr. Murray moved, pursuant to notice, That an Address be presented to the Governor General, praying that His Excellency will be pleased to place on the Estimates of Expenditure for the year 1856, the sum of £1,000, for the purpose of indemnifying such parties as have been losers through the defalcations of Mr. C. G. Gray, late Clerk of Petty Sessions and Gold Receiver at Major's Creek.

Debate ensued

Mr. Parker moved the Previous Question.

Debate continued.

Previous Question by leave withdrawn ;-

Whereupon Original Question, as then by leave amended, That it be referred to a Select Committee, to inquire into and report upon the Claims of such parties as have been losers through the defalcations of Mr. Gray, late Clerk of Petty Sessions at Major's Creek; and that such Committee consist of Mr. Nichols, Mr. Bligh, Mr. Samuel, Captain King, The Colonial Secretary, Mr. Park, and Mr. Cowper—put and passed.

Postponement:—Mr. Parkes postponed the motion standing in his name fifth on the Notice Paper for to-day, until Tuesday next.
 Claims against Government Bill:—Mr. Nichols having presented this Bill, Bill, intituled, "A lill to give relief to persons having Claims against the Government of New "South Wdes," read a first time; ordered to be printed.

Postponement:—The second reading of the City Commissioners' Powers extenso nBill postponed, on motion of Mr. Nichols, until Tuesday next.
 Sydney Paving Bill, on motion of Mr. Nichols, read a third time, and passed.
 Mr. Nichols then moved, That the Title of this Bill be, "An Act to provide for "Paving certain Streets in the City of Sydney."

Question put and passed.

10. Adulteration of Spirits Prevention Bill, on motion of Mr. Murray, read a third time, and passed. Mr. Muaray then moved, That the Title of this Bill be, " An Act to prevent the

Adulteration of Spirituous and Fermented Liquors.' Question put and passed.

Council adjourned at five minutes after Five o'clock, until Tuesday next, at Three o'clock.
