I. CALL TO ORDER

The meeting was called to order at 11:34 a.m.

III. PUBLIC COMMENT PERIOD

There was no public comment.

IV. APPROVAL OF MINUTES FROM THE NOVEMBER 7, 2016 MEETING

The Minutes were unavailable; therefore approval was deferred until the next meeting.

V. AGRICULTURAL COMMISSIONER – BRIEF UPDATES

Milton O'Haire, Stanislaus County Agricultural Commissioner/Sealer, gave a quick overview regarding two main agricultural issues: Cannabis Cultivation and the proposed regulations regarding Pesticide Use near Schools. He began by discussing Proposition 64 which legalizes marijuana under state law for use by adults 21 years or older. He referenced two agencies that will work closely with the Agricultural Commissioner's Office: the California Department of Food and Agriculture (CDFA); and the California Department of Pesticide Regulation (DPR). CDFA's responsibilities will include licensing and regulating growers; tracking production up through the sale;

and weights and measures. DPR's responsibilities will include regulating pesticide use for growing marijuana; (10) license types; and when established, pesticide tolerances. He noted that the State will set the standards which are still under development. He also included in his presentation the duties of the County Agricultural Commissioner and the changes that could be forthcoming due to the passing of Proposition 64, but also noted that nonmedical marijuana is not yet legal in Stanislaus County. During the second part of his presentation he provided information about the use of pesticides near schools and the requirements which include notification by growers and prohibited applications during certain time frames. At the end of his presentation, he took questions from the attendees and provided answers regarding the topics he had discussed.

He reminded those in attendance about the public hearing with the State Water Resources Control Board (Worth Your Fight) at the Modesto Centre Plaza the following day. He referenced a letter he had received from the Westside RCD regarding an upcoming tour.
