Legal framework



- right of free movement
- Free access to Member States labour market



- Entry and stay without a residence permit
- No purpose of residence required
- Family members from third countries
 accompanying the Union citizen do not require
 a residence permit for entry, but for
 permanent residence in Germany.

! British nationals!

Entry as from 01.01.2021 like privileged nationals => residence permit required



Basic information about refugees from Ukraine



- Residence permit according to § 24
 AufenthG possible for initially 2
 years.
- No restrictions on study or employment


- Refugees from third countries can stay in Germany without a visa until May 23, 2022.
- Residence permit possible according to the general regulations of the foreigner law (§ 16b, ...).
- § 24 AufenthG possible if it is not possible to leave the country for your home country ...).






Study

• § 16b Abs. 1 Residence Act

- residence registration
 - => the Residence Registration Office in Munich is called "Bürgerbüro" and is located at the Department of Public Order (Kreisverwaltungsreferat)
- proof of secure livelihood
 => e.g. blocked account, formal obligation
- health insurance
 - No travel insurance
 - Benefits comparable to statutory health insurance
- enrolment at a state university or a recognised university
- valid residence permit or visa
- valid passport or passport replacement







Proof of secure livelihood

- ⇒ available money per month (2022: **947,-- Euro** scholarship BaföG)
- ⇒ Please note: this amount increases annually
- notarized declaration from parents, securing the livelihood
- formal obligation "Verpflichtungserklärung) § 68 Residence
 Act
- savings account or blocked account at a german bank with
 11,364 (2022) euros
- confirmation of scholarship
- bank guarantee from a German bank
- ⇒ For extension of the residence permit: you can work and earn money in addition to proof your financiation





Validity

- issue and extension for at least 1 year and should not exceed 2 years
 ⇒ in MUC validity at most 2 years
- renewal if the purpose of the stay has not yet been achieved and can still be achieved within a reasonable time
- study must be finished in an appropriate time
 - ⇒ normal period of university education + three semesters (maximum 10 years)
- further postgraduate or doctoral studies are possible (maximum 12 or 15 years)





Validity

• FAQ

I would like to stay abroad for more than six months?

The residence permit expires automatically if you stay abroad for more than 6 months.

Exceptions:

- Semester abroad in the EU (up to 2 semesters)
- longer period of time by the foreigners authority before leaving the country
- **no** special regulations due to Covid 19

I have been exmatriculated - what do I have to do?

Exmatriculation may have no direct effect on the validity of the residence permit. But you must report this to the foreigners authority. They will decide whether you can keep your residence permit or whether the residence permit will be withdrawn.



Working

- employing up to 120 days or 240 halve days per year without separate permission (not self-employed or freelancer)
- employment as a research or scientific assistant at the university or at another academic institution without time restrictions and without separate permission but you have to inform the foreign authority
- internships being a compulsory part of university studies without separate permission
 - for all other internships you need a separate permission applications at foreign authority



Working

FAQ

- I would like to work more than 120 days a year?
 - You cannot work more than 120 days per year. Exception: your funding has been cut off and you would have to discontinue your studies or apply for social assistance. [Special regulation for Ukrainian, Russian and Belarusian nationals in individual cases possible]
- Can I spend the 120 days working for different companies?
 Yes, you can but in total not more then 120 days or 240 half days.
- I have found a full-time job that matches my foreign university degree (eg Bachelor)?

You have to change the purpose of your stay, from study to employment. However, you can continue your studies with the new residence permit.



Changing your branch of studies / university

1st to 3rd semester

- a one-time change is usually possible
- any change must be approved by the foreign authority
- indication without delay, but at the latest within 14 days after the new enrolment
- certificate of enrolment
- proof of academic achievement (performance records)

from 4th semester

- a change is only possible in special cases
- any change must be approved by the foreign authority
- indication without delay, but at the latest within 14 days after the new enrolment
- detailed statement about the reasons for the change and the further planned study courses
- e.g. recognition of courses of study



Give up studies

- after giving up your studies a residence permit for another purpose is not possible, except:
 - Legal entitlement (such as family reunification, EU Blue Card)
 - Qualified vocational training (understaffed profession)

In Munich:

- → in the individual case the change of purpose is admitted in a qualified vocational training also in non-understaffed professions
- → in the individual case the change of purpose is admitted in a skilled employment if there is a demand in the local labour market.



Mobility

• § 16c Residence Act

- Residence permit with the REST-Guidline permission contains the addition "Student"
- Semester abroad in an other EU Member State semester abroad for up to 360 days without separate residence permit in the other EU Member State

Registration process

- Form for registration (Anmeldung)
- Valid identification document (**passport**) of the persons obliged to register.
- Confirmation of the landlord / owner about the occupation of the apartment (Wohnungsgeberbestätigung).
- If you do not have or do not yet have the housing provider confirmation, you can submit a declaration regarding the missing housing provider confirmation.
- If Munich is the main place of residence (Hauptwohnsitz): bring passport and eAT (if available) to update the address/place of residence.











Application process


- apply for your residence permit online or postal
- Required documents:
 - Application form [download at our website]
 - Passport, copy of visa and copy of the entry stamp
 - Enrolment
 - Current proof of health insurannce or a copy of the insurance card (for at least twelfe months)
 - Sufficient proof of financing
 - Certificate of matriculation
- Duration: 10 weeks
- Following steps:
 - Appointment for ordering the electronic residence permit
 - Temporary residence permit (Fiktionsbescheinigung)
 - Residence permit by mail (expenses 5.50 € for registered letter)





In Case of Emergeny

What is an emergency?

- Threat of loss of employment
- Imminent loss of benefits (for example, unemployment compensation or student loans)
- Urgent travel for personal or professional reasons within the next seven days (for example, business trip, illness, death)

What is not an emergency but an urgent concern?

- Residence title ordered more than 2 1/2 months ago and not received and the fictitious certificate expires next week
- Residence permit applied for more than 2 1/2 months ago and did not get an appointment from the Foreigners Authority

Following steps:

- Google: Notfälle Ausländerbehörde München
- Use: link "Hilfe bei fehlendem Aufenthaltstitel (Notfälle)"
- Book an appointment at the bottom of the website
