What is Public Policy?



Public policy can be generally defined as a system of laws, regulatory measures, courses of action, and funding priorities concerning a given topic promulgated by a governmental entity or its representatives.

Advocacy & Lobbying

- Advocacy is arguing or speaking in favor of a cause, idea or funding priority. There is no limit on advocacy an individual or organization (such as a nonprofit) can do.
- Lobbying can generally be defined as any attempt to influence a politician or public official on an issue (Direct or Grassroots)
 - Government/State employees can advocate outside of state responsibilities on personal time

Advocacy & Lobbying

Advocacy

- Telling a legislator how a policy affects constituents
- Using social media to inform the public
- Meeting w/ government official to explain how a problem/issue affects a particular group

Lobbying

- Asking legislator to vote, amend, sponsor legislation
- Generating a petition asking members or public to contact legislators in support/opposition of particular legislation

Basic Steps for BWEIP Advocacy

- 1) What is our goal?
- 2) Who is our audience/decision-makers?
- 3) What is our plan of action?

1. What is our Goal?

Build a relationship with our legislators

- Increase awareness of Baby Watch Early Intervention Program
- Maintain funding
- Increase funding to support growth and quality services
 - Need a clear & simple statement to describe program, context and background and the current need (past fact sheets)
 - Need a unified voice

2. Audience/Decision-Makers

Know who represents you

2. Audience/Decision Makers (cont)

- Know who is running for office
 - All of House and half of Senate up for reelection in 2018
 - After election, know who to contact, committee assignments early December

2. Audience/Decision-Makers (cont)

Legislative Committees

Rules

Decides if and where a bill is heard

Standing

Hears testimony, votes on bills

Appropriations Subcommittees

Hears testimony, prioritizes funding requests

Executive Appropriations

Leadership, determines state budget

Interim

Meets between sessions to study issues

3. Take Action

- Contact your legislators
 - "I am a voter in your district"
- Contact members of appropriation committees
 - before and during the session: emails, calls, schedule appointments, interns
- Find legislators on social media platforms, connect in real time
- Speak from your own personal experience, share data, be prepared to answer questions or find answers

3. Take Action (cont)

- Testify at Legislative Appropriations hearings during public comment
 - address committee chairs
 - be brief
 - respect allocated time
 - rehearse
 - thank them for their time
 - leave a hard copy of testimony for members of committee
