General notes

1. An asterisk (*) for a zero duty in the column "Post-KR duty" indicates that part of the zero duty has already been bound and that the remainder will be bound as a result of the Kennedy Round.

2. For items in Chapters 28-39 inclusive, where two alternative rates are given in the concession rate column, the following rules will apply:

The first rate is conditional on that major participants bring into effect the rate for the corresponding item on the basis of a maximum result as indicated in their schedule. If this condition is not fulfilled the rate within brackets will apply.

3. For the following items Sweden is prepared to put into effect the concession rate without staging:
